#### 1. MINUTES OF THE PREVIOUS MEETING

#### 6. **BUDGET AND FINANCIAL FORWARD PLAN**

The Committee received a report outlining the latest development of the financial forward plan 2011/12 - 2013/14, which outlined budget saving options considered by the Cabinet on 20<sup>th</sup> October 2010, together with the key corporate risk list.

Officers presented to the picture the financial outlook in the aftermath of the Comprehensive Spending Review 2010. It was noted that the level of funding available through the grant system was to be severely reduced and that unprecedented cuts in the public sector were expected. The Committee would receive further more detailed budget information through the budget setting programme in advance of Council agreeing its final budget in March 2011.

The Committee were briefed on the Council's online budget consultation, this year including a new 'ideas' website where residents were able to suggest to the authority ways of saving money. Responses were filtered by a team of officers including the Assistant Chief Executive and were reviewed at a service level. Members requested that they be informed of responses to made by Members of the public to this website, together with other information requested in the table below. The Committee noted that a public meeting on the budget was due to be held on 11<sup>th</sup> November 2010, and that the website also allowed the public to comment on specific aspects of the current budget.

The Committee scrutinised the strategic budget options in Adult Social Services and requested that efforts be made to ensure that standards of service were maintained when re-negotiating contracts with outside providers. The important importance of the role of the voluntary sector was discussed, with Members keen that potential service changes were not looked at in isolation, so as not to lead to increased costs in other areas of the authority. The importance of balancing the need to make savings, with the positive affects of prevention work was affirmed.

In the Children's Service, the Committee noted that services for Child Protection, Children in Care and Safeguarding were statutory, and that savings were thus required to be made from other areas. Some of the work currently carried out by the Youth Service could potentially be consolidated in other areas following the completion of a review. In terms of prevention, the Committee were supportive of investment in early intervention services, as this had proven cost and social benefits in the long-term.
