Councillor Alison Moore undertook to provide the Director of Adult Social Care and Health with details of residents groups that had been lobbying councillors to enable Adult Social Care and Health to respond to these concerns.

The Assistant Director for Adult Transformation and Resources agreed to provide Members of the Committee with details of: a) the progress made in completing financial assessments process, particularly how many financial assessments were outstanding and what actions were being taken by officers to ensure that all financial assessments were completed before the new charging policy came into force; and b) clarification as to whether income received from charities should be included in the income sources section of the Fairer Contribution Policy.

The Director of Adult Social Care and Health undertook to review the Fairer Contributions Policy after a period of 12 months and, if required, report the findings to the relevant Overview and Scrutiny Committee.

The Committee decided not to refer the above matter back to the Cabinet Member of Adults for reconsideration.

The Committee noted that a report would be presented to the General Functions Committee on the staffing implications of transferring some functions of Adult Social Services to a local authority trading company.

The Cabinet Member for Adults noted the concerns of the Committee in relation to the potential for elected Member scrutiny to become diminished when services were provided by a local authority trading company instead of by the council. He agreed that elected Member scrutiny should be addressed in any contracts between the trading company and the council.

The Committee decided not to refer the above matter back to the Cabinet Member of Adults for reconsideration.
