**143. REPORT OF CABINET, 26 FEBRUARY, 2007 – COUNCIL BUDGET AND COUNCIL TAX 2007/08 (Agenda items 8, 11.2.4(i) and 11.2. 5(i)):**

The report of the Cabinet meeting held on 26 February 2007, with the following recommendations, was received:

**RESOLVED TO RECOMMEND**

**Balances**

1. That, having taken account of all matters set out in the Chief Finance Officer's report on reserves and balances as set out at Appendix A to the Leader's report (attached) the level of General Fund balances should not be allowed to fall below £10m. and that in recognition of the significant financial risks facing the council in the coming years there should be no adjustment in finalising the 2007/08 budget to the current forecast balances of £12.7m.

**Revenue Budget and Council Tax**

2. That the forecast revenue outturn for the year 2006/07 and the estimates of income and expenditure for 2007/08 be approved.
3. That it be noted that the Chief Finance Officer under his delegated powers has calculated the amount of 135,345 (band D equivalents) as the Council Tax base for the year 2007/08 in accordance with Regulation 3 of the Local Authorities (Calculation of Council Tax Base) Regulations 1992 made under Section 33(5) of the Local Government Finance Act 1992.
4. That the following amounts be now calculated by the Council for the year 2007/08 in accordance with Sections 32 to 36 of the Local Government Finance Act 1992:-
  - (a) £785,581,820 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act;
  - (b) £563,063,120 being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c) of the Act;
  - (c) £222,518,700 being the amount by which the aggregate at 4(a) above exceeds the aggregate at 4(b) above, calculated by the Council, in accordance with Section 32(4) of the Act, as its budget requirement for the year;
  - (d) £80,915,723 being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates, revenue support grant or additional grant increased or reduced (as appropriate) by the amount of the sums which the Council estimates will be transferred in the year from:-
    - (i) its collection fund to its general fund and;

- (ii) its general fund to its collection fund in accordance with Sections 97(3) and (4) and 98 (4) and (5) respectively of the Local Government Finance Act 1988;
- (e) £1,046.24 being the amount at 4(c ) above less the amount at 4(d) above, all divided by the amount at 3 above, calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its Council Tax for the year 2007/2008;

7. That in accordance with Section 38(2) of the Act the Chief Executive be instructed to place a notice in the local press of the amounts set under recommendation 1.6 above pursuant to Section 30 of the Local Government Finance Act 1992 within a period of 21 days following the Council's decision.

**Housing Revenue Account and Rents**

8. That the Housing Revenue Account estimates for 2007/08 be approved.

9. That, with effect from Monday 2 April 2007:-
- (a) The rent of all Council dwellings, with the exception of those included under Recommendation (1.10), be changed in line with the Government's proposals on rent restructuring outlined in this report, producing an average increase of 5.0%
  - (b) That the rents of all properties relet for whatever reason be moved upwards to the formula rent. Where formula rent is below actual rent no reduction will be made.
  - (c) That service charges for all tenants of all flats and maisonettes based on the services they receive be increased to the following charges (per week, 48 week basis):-

  - (d) That there is an increase of 30% on the charge for space and water heating
10. That, with effect from Monday 2 April 2007: -
- (a) The basic rents of dwellings in the Council's equity sharing scheme at Moorlands Avenue, NW7 be increased as follows:-
    - Current basic rents of £2,202 to £2,313 per annum
    - Current basic rents of £2,028 to £2,130 per annum.
  - (b) The net rents of dwellings in the equity share scheme at Friern Hospital be increased by 5.0%.
11. That, with effect from Monday 2 April 2007, the rents of Council garages be increased by 5.0%.
12. That the Chief Executive be instructed to take the necessary action including the service of the appropriate Notices.
13. **Key Priority Plans**  
That the Key Priority Plans be approved.
14. That the Chief Officers be authorised to implement the detailed proposals set out in the Key Priority Plans within the resource constraints identified, in consultation with lead Members as appropriate.
15. That the Director of Children's Service in consultation with the Cabinet Member for Children's Services be authorised to make any necessary amendments to the Children & Young People Plan / A Bright Future for Children & Young People KPP prior to its approval by Council in the light of forthcoming government guidance (Paragraph 9.3).

### Capital Prudential Code and Borrowing Limits

16. The Prudential Indicators set out in Appendix F be recommended for approval to Council and that the Chief Finance Officer be authorised to raise loans, as required, up to such borrowing limits as the Council may from time to time determine and to finance capital expenditure from financing and operating leases subject to:
- (i) the appropriate provision having been made in the estimates for 2007/08;
  - (ii) authorisation (where necessary) of the expenditure by the appropriate Government Department;
  - (iii) a decision of the committee concerned or under delegated/urgency powers to incur the capital expenditure and that the Cabinet Resources Committee be instructed to approve new projects up to the value of surplus resources outlined in this report, having regard to the priorities identified.

### Capital

17. That the capital programmes be approved, and that the Chief Officers be authorised to take all necessary action to implement them.

### Fees, Charges and Allowances

18. That the fees, charges and allowances as set out in section 9.48 and Appendices are approved.

### Contracts

19. That authorisation be given to allow tenders to be sought for contracts listed in Appendix J.

### Medium Term Financial Strategy (MTFS)

20. To note that a report on the draft MTFS will be presented to Cabinet Resources Committee in March 2007 with public consultation to follow (paragraph 9.41)
21. To note that the current annual level of prudential borrowing cannot be sustained long term, and that Cabinet must also seriously consider using significant capital receipts generated in future years to repay borrowing rather than fund further expansion of the capital programme (paragraph 9.75).

Members' attention was drawn to an amendment submitted by officers at Item 5(i) of the Supplemental Report of the Democratic Services Manager, with the following recommendation:

**That recommendation (2) be amended as indicated in italics:**

- (2) **That the forecast revenue outturn for the year 2006/07 and the estimates of income and expenditure for 2007/08 be approved subject to any later decisions taken by Council on the proposed Members' Allowances scheme for 2007/08 at Agenda item 11.2.2**

Amendments in the names of Councillors Alison Moore and Monroe Palmer were moved and duly seconded. Debate ensued. The amendment in the name of Councillor Alison Moore was put to the vote and declared lost.

Upon being put to the vote, the amendment in the name of Councillor Monroe Palmer was declared lost.

The Mayor indicated that she would take a separate vote on those elements of the budget that related to grants.

Upon the substantive motion being put to the vote it was:

**Road User Charging**

Council is extremely concerned at Labour Government plans to introduce Road User Charging Across the country, and believes that any plan to introduce such a charge will impact disproportionately on people with low or fixed incomes and those who depend on their car for mobility.

It is noted that the Labour Government has received over 1 million signatures in objection to its road charging plans, demonstrating the strength of opinion nationwide against such a levy.

It should be further noted that the first road charging policy in existence in Britain, the Central London Congestion Charge, has failed to cut congestion in the long run, with delays inside the zone nearly back up to pre-charge levels. The said levy is also attributed to delays and congestion in Barnet, where the attendant increase in commuter parking has resulted in the necessary implementation of additional Controlled Parking Zones (CPZs).

However, in addition to extending the Congestion Charge westwards, Transport for London (TfL) has also mooted plans to charge on "busy roads". Last year TfL admitted, under these plans, it would cost a road user £13 to travel from Barnet across London.

This Council is committed to ensuring its residents are free to go about their everyday lives without being unduly charged. We believe there are more effective means of cutting carbon emissions than by Road User Charging, which, the London Congestion Charge has demonstrated, can be ineffectual at reducing congestion in the long run.

Council requests that Cabinet considers more effective means by which congestion and emissions could be reduced other than road user charging, and that these suggestions are communicated to the Secretary of State for Transport.

**Opposition Policy Item to be moved by Councillor Moore**

**Promoting public engagement and participation in Barnet Area Forums.**

Council welcomes the aims in the local government white paper “Strong & Prosperous Communities”, with regard to better public engagement in the democratic process.

Council also welcomes the fledgling project on Democratic Champions and it’s intention to respond to those aims.

Council believes, however, that increased public participation requires public confidence in consultation.

Council notes that about half of those residents responding to the 2006/7 Residents Attitude Survey felt the Council does not listen, does not involve residents and is not responsive.

Council also notes that one of the stated aims of the Council’s consultation strategy is “to ensure Barnet’s residents and civil society has the fullest possible opportunity to become involved.”

Council further notes that despite this stated aim the Special Committee (Constitution Review) has proposed amendments to the Constitution that will further curtail the public’s ability to participate by cutting the number of Area Forums by 50%.

Council believes that the erosion of opportunities for public engagement damages the reputation of the Council as a “listening” Council, and flies in the face of the Council’s stated motto that they are “putting the community first”.

Area Forums should function as the “front door” to the Councils’ democratic process, enabling and enhancing the relationship between the council and the community.

With the impending reduction of the existing forums, it is imperative that the Council ensures that the local community’s voice is still heard.

Council therefore requests Cabinet consider asking the Resources Performance and Partnerships Overview & Scrutiny Committee to undertake a review of the attendance, working and outcomes of Area Forums with a view to increasing participation from the wider Barnet community.
