The Council are proud to recall the long association that he and his family have had with the borough. John Apthorp is not only a philanthropist, but has also served the community of the London Borough of Barnet by being a Councillor for the Edgware Ward from 1968 to 1974. He continues that service through being a governor of the London Academy.

In conferring the Honorary Freedom on John Dorrington Apthorp, the Council are recording formally the high esteem in which he is held by the Council and the community of the London Borough of Barnet.
