117. MEMBERS' MOTION (Agenda Item 3)

The Motion at Agenda Item 3 was moved by Councillor Mike Freer.

Debate ensued. Upon being put to the vote, the motion was carried. **RESOLVED** –

1. That, in pursuance of Section 249 of the Local Government Act 1972, the Council of the London Borough of Barnet do confer upon John Dorrington Apthorp, Officer of the Order of the British Empire, the Honorary Freedom of the London Borough of Barnet (being the most honourable award it is the Council's privilege to bestow) in recognition of the most generous support rendered by John Apthorp, particularly through the Milly Apthorp Trust to individual Barnet residents, the voluntary sector and to Council projects.

The Council are proud to recall the long association that he and his family have had with the borough. John Apthorp is not only a philanthropist, but has also served the community of the London Borough of Barnet by being a Councillor for the Edgware Ward from 1968 to 1974. He continues that service through being a governor of the London Academy.

In conferring the Honorary Freedom on John Dorrington Apthorp, the Council are recording formally the high esteem in which he is held by the Council and the community of the London Borough of Barnet.
