Future Shape of the Council

Council notes the Future Shape of the Council project and the potential impact it could have on local people, council services and staff - particularly in the light of the current uncertainty of the £27.4 million in Icelandic banks and falling interest rates.

Council is concerned that the rationale for the project seems to be more about shrinking the organisation rather than designing quality services for the future, and that final proposals may be to outsource many local services, which may present additional risks to both the council and local people given the current economic situation.

Council is also concerned that any strategic partnership with a private sector organisation may result in the loss of democratic control of local service delivery despite the council retaining legal, political and public accountability.

Council believes that the process so far of the Future Shape of the Council project appears to be top down, has not been open or transparent, and is concerned that initial proposals will be presented for decision in December as a fait a compli.

Council asks Cabinet to suspend any further decisions on the Future Shape of the Council until the All Party Working Group has concluded its review of the current process.

Council further asks that, subject to the outcome of the All Party Working Group review, Cabinet commences a proper and transparent service review process that involves staff and trade unions as equal partners in designing quality public services for the future, treats in-house service delivery on a level-playing field with other models, and fully co-operates with any pre-decision scrutiny working group that is setup as part of that service review process
