REPORT OF THE AD HOC OVERVIEW & SCRUTINY COMMITTEE

EXTERNAL REVIEW INTO THE ADOPTION/APPLICATION OF THE COUNCIL'S TREASURY MANAGEMENT STRATEGY WITH PARTICULAR REGARD TO DEPOSITS PLACED IN ICELANDIC BANKS

9. BACKGROUND INFORMATION

- 9.1 At its meeting of May 19th 2009, Council established an Ad Hoc Overview & Scrutiny committee to appoint an independent external review body (comprising members with appropriate experience and expertise) to enquire into the adoption/application of the Council's Treasury Management Strategy with particular regard to deposits placed with Icelandic banks.
- 9.2 The Ad Hoc Overview & Scrutiny Committee met on June 9th 2009 and agreed to appoint Deloitte to carry out an external review of the Council's Treasury

- 9.3 The Committee met again on June 22nd 2009 and received an update from Deloitte on the progress of their review.
- 9.4 The Committee met for a final time on July 8th 2009 to receive the final report from Deloitte. The Committee agreed that the findings be reported to Council, together with the above recommendations for the implementation and scrutiny of changes relating to Treasury Management as identified by the external reviewers.
