5. OFFICIAL ANNOUNCEMENTS (Agenda Item 5):

The Worshipful Mayor regretted to announce the death of Sir John Gorst on 31 July 2010. Sir John served as MP for Hendon North from 27 years from 1970 until 1997. A minutes silence was held in remembrance of a departed friend and colleague. The Worshipful Mayor on behalf of the Council passed on his condolences to Councillor Charlie O-Macauley and his family on the passing of his father.

6. BUSINESS REMAINING FROM LAST MEETING (Item 1.6)

7. QUESTION TIME FOR MEMBERS (Agenda Item 2.1)

Questions were put to the Leader and Members of the Cabinet. These questions, together with the answers provided and the text of any supplementary questions and answers are set out in Appendix 1 to these minutes.

8. VARIATION OF ORDER OF BUSINESS

Councillor Joan Scannell, duly seconded, moved under Council Procedure Rule, Section 1, paragraph 10.2.2, that the order of business relating to Agenda Item 3 be varied so that Motions 3.5, 3.3 and 3.9 be heard first.

Upon being put to the vote, the motion was declared carried.

RESOLVED – That the order of business be varied to allow Motions 3.3, 3.4 and 3.2 to be debated and voted upon in advance of votes being taken on the other Motions on the Agenda.

Councillor Barry Rawlings, duly seconded by Councillor Alison Moore, moved under Council Procedure Rule, Section 1, paragraph 14.1.2 that Standing Order be suspended to allow a member of the public to speak on a motion. Upon being put to the vote, the motion was declares lost.

RESOLVED – That the Standing Orders not be suspended to allow a member of the public to speak on a motion.

9. MOTION IN THE NAME OF COUNCILLOR DANIEL SEAL (Agenda Item 3.5)

Motion 3.5 in the name of Councillor Daniel Seal was moved. An amendment in the name of Councillor Kath McGuirk was moved. Upon being put to the vote, the amendment in the name of Councillor McGuirk was declared lost. Upon being put to the vote, the motion was declared carried.

RESOLVED - Council is pleased that Transport for London agreed in 2009 to make improvements to improve the safety and traffic flow at Henly's Corner, although Council remains adamant this should not preclude additional future improvement work.

However, Council notes that owing to the deficit left by the previous Labour Government, the current Government is looking to make savings through the Comprehensive Spending Review (CSR). This will include examining the funding towards transport bodies, such as Transport for London (TfL).

TfL has, Council notes, consequently put its major projects under review, including the planned work on the A406 at Henly's Corner.

Council believes that the work at Henly's Corner is of the utmost importance, not only for local safety, but also as part of the strategic road network across North London, as delays at the junction produce many knock-on effects on traffic flow on the North Circular and the A1.

Therefore, Council resolves to make strong representations for the improvement work at Henly's Corner to be safeguarded in TfL's review, and calls for the Chief Executive to write to the TfL Commissioner and Mayor of London pressing for the scheme to be protected and the reasons why.

10. MOTION IN THE NAME OF COUNCILLOR LYNNE HILLAN (Agenda Item 3.3)

Motion 3.3 in the name of Councillor Hillan was moved. An amendment in the name of Councillor Geof Cooke was moved. Debate ensued. Upon being put to the vote, the amendment in the name of Councillor Cooke was declared lost. Upon being put to the vote, the motion was declared carried.

RESOLVED - Council notes the Audit Commission cost £200 million a year and employed 2,000 people.

Council further notes that the role of the organisation shifted over many years, ending up as an arm of Whitehall, issuing local authorities with costly diktats.

The abolished CAA Inspection regime (and the CPA before it) costing LBB over £100,000 in staff time each year formed a major part of the Audit Commission's remit, Council remembers.

Further, Council is dismayed that the Audit Commission spent taxpayers' money treating its staff to jollies such as trips to the races.

In addition, Council deplores the spending of £60,000 by that body on lobbyists in order to "combat the activities" of a senior Opposition MP in early 2010.

Council believes that local authorities should manage and audit their own spending, and that the bureaucracy of the Audit Commission has become both unwieldy and unnecessary.

Accordingly, Council welcomes the Coalition Government's abolition of the Audit Commission.

Council further requests Cabinet and the Audit Committee work to put in place a framework to ensure the requisite auditing of Barnet's finances in light of the abolition of the Audit Commission.

11. MOTION IN THE NAME OF COUNCILLOR GEOF COOKE AS AMENDED BY COUNCILLOR BRIAN COLEMAN (Agenda Item 3.9)

Motion 3.9 in the name of Councillor Geof Cooke was moved. Amendments in the name of Councillors Brian Coleman and Geoffrey Johnson were moved. Upon being to the vote the amendment in the name of Councillor Coleman was declared carried. Upon being put to the vote the amendment in the name of Councillor Geoffrey Johnson was declared lost. Upon being put to the vote the substantive Motion as amended was declared carried.

RESOLVED – Council is pleased that the Mayor of London, Boris Johnson, has rolled Oyster out onto the National Rail Network, further increasing the popularity of electronic transactions.

Council notes that as a result of Oyster's popularity just 5% of tube journeys start with a ticket office transaction and that the number of such transactions has plummeted 28% since 2006, with machine-based sales soaring 47% over the same period.

In addition, Council is delighted that the Mayor has boosted Police numbers on the Tube from 450 to 700, which will help improve passenger safety.

Council believes given the dwindling use of ticket offices, members of staff are better employed helping passengers on the platforms than enclosed behind a glass window, particularly considering limited public resources.

Council notes the plans involve no compulsory redundancies.

Council therefore supports the TfL proposals to this end.

12. MOTION 3.1 IN THE NAME OF COUNCILLOR JACK COHEN AS AMENDED BY COUNCILLOR BRIAN COLEMAN (Agenda Item 3.1)

Motion 3.1 in the name of Councillor Jack Cohen was moved. Amendments in the name of Councillors, Brian Coleman, Andrew McNeil and Susette Palmer were moved. Upon being put to the vote the amendment in the name of Councillor Brian Coleman was declared carried. Upon being put to the vote the amendment in the name of Councillor Andrew McNeil was declared lost. Upon being put to the vote the amendment in the name of Councillor Susette Palmer was declared lost. Upon being put to the vote the substantive Motion as amended was declared carried.

RESOLVED - Council welcomes the statement on 4 July by Secretary of State for Transport, Philip Hammond MP, that there will be no blanket reduction in speed limits to 20mph in residential areas.

Council believes that blanket 20mph zones are ineffectual, unenforceable and the limits largely ignored.

Council therefore calls on Cabinet to broadly maintain its existing levels of speed limits across the Borough, which, Council believes, have struck the correct balance between minimising congestion and maximising road safety.

13. MOTION 3.2 IN THE NAME OF COUNCILLOR RICHARD CORNELIUS (Agenda Item 3.2)

Motion 3.2 in the name of Councillor Richard Cornelius was moved. An amendment in the name of Councillor Jim Tierney was moved. Upon being put to the vote the amendment in the name of Councillor Tierney was declared lost. Upon being put to the vote the Motion was declared carried.

RESOLVED - Council regrets the practice of "Garden Grabbing" that occurred because front and rear gardens were classified as Brownfield under the planning rules, making it far easier to obtain planning permission to build on them.

Council notes that between 2006 and 2009, 34% of dwellings in Barnet were built on previously developed land (including gardens). This was the 10th highest rate in London, and a large jump from the 12% recorded in the three years to 1997.

Council also regrets that the old Labour Government made few changes to curtail this practice despite constant representations from this Council and local MP Theresa Villiers.

However, Council is extremely pleased that the new Coalition Government has listened and has reclassified front and rear gardens away from Brownfield land, which Council believes will serve to control building upon them.

Accordingly Council instructs the Chief Executive to write to the Communities Minister Greg Clark MP welcoming this move.

14. MOTION 3.4 IN THE NAME OF COUNCILLOR ANDREW HARPER AS AMENDED BY COUNCILLOR ANNE HUTTON (Agenda Item 3.4)

Motion 3.4 in the name of Councillor Andrew Harper was moved. An amendment in the name of Councillor Anne Hutton was moved. Councillor Harper accepted Councillor Hutton's amendment. Upon being put to the vote the substantive Motion as amended was declared carried.

RESOLVED - Council is proud of its first class schools and colleges that give the children of the Borough the best possible start in life.

Council believes that decent education and training is extremely important in building the future of Britain's and Barnet's economy.

Therefore Council is proud to note the excellent GCSE and A-Level results across the Borough, with 80% of Barnet's students receiving 5 or more A* to C grades at GCSE and 71% gaining A* to B in A-Levels.

Council also congratulates students of vocational courses for their exam results.

Council warmly congratulates all the students, staff, teachers, parents and Governors responsible for these excellent results, and calls on Cabinet to ensure Barnet continues to enjoy excellence in education for years to come.

15. MOTION 3.6 IN THE NAME OF COUNCILLOR JACK COHEN (Agenda Item 3.6)

19. ADMINISTRATION POLICY ITEM - COALITION PROPOSALS FOR HEALTH (Agenda Item 4.1)

Councillor Helena Hart proposed the item and moved that it be adopted. Amendments in the name of Councillors Barry Rawlings and Jack Cohen were moved. Debate ensued. Upon being put to the vote, the amendment in the name of Councillor Rawlings was declared lost. Upon being put to the vote, the amendment in the name of Councillor Jack Cohen was declared lost. Upon being put to the vote the Policy Item was declared carried.

RESOLVED - The Coalition Government's White Paper "Equity and Excellence: Liberating the NHS" proposes some of the most radical and far reaching changes to the way that Health Services are planned and delivered in the UK.

Based upon and protecting the core principles of the NHS of being free at the point of use and available to everyone based on need, not ability to pay, the White Paper proposes a real transfer of choice and control to Patients and Health Professionals, with General Practitioners taking the lead in commissioning patient care.

It is envisaged that the London Borough of Barnet will play a key role in supporting and liaising between the different groups and will also have the right to object to any proposed re-structuring of local Hospitals.

The White Paper also proposes far greater influence and powers for Local Authorities, such as the London Borough of Barnet, who will take a lead in Public Health. The responsibilities for local health improvement will also transfer from Primary Care Trusts to Local Authorities and there will be an additional White Paper later in the year devoted to Public Health.

All the proposals contained in the White Paper will, of course, be subject to extensive consultation before they are implemented.

As part of this, Council requests Cabinet to:-

- Respond carefully to the Consultation, ensuring the new relationship represents the best possible outcome for Barnet residents
- Liaise closely with the Secretary of State for Health, in ensuring the proposals are implemented as effectively as possible.
- Continue the Future Shape programme as it already involves much closer cooperation between LBB and NHS Barnet.

 Build upon LBB's track record of supporting and working with local healthcare providers and GPs to improve local healthcare for local people.

20. OPPOSITION POLICY ITEM AS AMENDED BY COUNCILLOR TOM DAVEY: CUTS TO PENSIONERS' BENEFITS(Agenda 4.2)

Councillor Barry Rawlings proposed the item and moved that it be adopted. Amendments in the name of Councillors Tom Davey and Alan Schneiderman were moved. Debate ensued. Upon being put to the vote, the amendment in the name of Councillor Davey was declared carried. Upon being put to the vote the amendment in the name of Councillor Alan Schneiderman was declared lost. Upon being put to the vote, the Policy Item as amended was declared carried.

RESOLVED - Council is dismayed that the last Labour Government made little difference to the Basic State Pension and also helped wreck Private Pensions thanks to its fiscal attack on the funds.

However, Council welcomes the Coalition Government's restoring of the link to earnings in the State Pension which will give Pensioners better support.

Council deplores the reckless spending undertaken by the last Labour Government that has bankrupted the public purse, and that this has meant changes may have to be made to a range of benefits.

Council calls on Cabinet to help ensure that any change that may need to be made thanks to Labour's past profligacy are as smooth and as painless for local people as possible.

Motion 3.1: Cllr. Lynne Hillan

General Powers of Competence

Council agrees with the Coalition Government that Local Authorities should have the powers to run their own affairs as Elected Representatives of local people see fit, and not according to dictats from Whitehall.

Council welcomes the abolition of the Standards regime, Local Area Agreements (LAAs), and many of the associated targets.

Further, Council welcomes the statement by Eric Pickles MP that Boroughs such as Barnet will soon be able to manage their own affairs through a general Power of Competence. This is, Council believes, the foundation of the new Localism Bill.

Council is pleased that LBB already seeks to shape services around local people, particularly through One Barnet.

Accordingly, Council calls on Cabinet to tailor even more of its work around local people following the moves to restore power to Local Authorities.

Motion 3.2: Cllr. Brian Salinger

Safeguarding Children

This Council recognises the importance to all residents of Barnet of the need to safeguard our children.

This Council welcomes and supports the decision of the government to roll out across the country the measures that have become known as 'Sarah's Law' which will enable residents to ascertain if convicted paedophiles and those convicted of other offences involving children, are living within their communities.

Council calls on the Cabinet to ensure that full and appropriate publicity is given to the measure when it is rolled out in London

Motion 3.3: Cllr. Richard Cornelius

Social Housing Tenancies

Council believes that Social Housing is there to help the needy back onto their feet.

Council further believes that under occupied properties need to be freed up to help others in greater need and to ensure the most equitable and fullest use of such homes.

Social Housing is intended to help those who need help, whilst they need help. The tax payer cannot be expected to continue to subsidise tenants who no longer need assistance.

Council strongly welcomes the Coalition Government's plans, contained in the Spending Review, with flexible Social Housing Tenancies that reflect the changing circumstances of individuals and families, so that people can access appropriate social housing in ways that better reflects their needs.

Council therefore calls on Cabinet to work with the Coalition Government in implementing the new forms of tenure for the future to ensure that Social Housing is allocated to those who will benefit the most whilst they need the help.

Motion 3.4: Cllr. Lynne Hillan

Community Place Based Budgets

Council affirms its support to the One Barnet Programme that is breaking down barriers across the local Public Sector to enable our residents to access better services at lower cost.

Council believes this work is vital given the tough economic times we are in, and also believes the One Barnet approach represents the future model of Local Government in the UK.

Therefore, Council is extremely proud to have been selected as one of a handful of authorities to pilot Community Place Based Budgets by the Government.

Council notes this will bring together several public service budgets to direct care for families with complex needs.

Council calls on Cabinet to work to ensure this pilot is a success, and the excellent One Barnet approach that led to this accolade continues.

Motion 3.5: Cllr. Kath McGuirk

Child Benefit Cuts

Council notes the decision of the Con-Dem coalition government to end universal child benefit.

Council also notes that the policy, as currently proposed, will mean a two-parent family with a joint income of £80,000 per annum will get child benefit, but a single Barnet parent earning only £45,000 per annum will have their child benefit taken away.

Council believes that this is not a fair policy and will mean many hard-working parents in Barnet whose income is at the lower end of that tax band will suffer as a result.

Council notes that during the General Election David Cameron gave a commitment not to cut child benefit, and that many lower middle income families will be financially squeezed as a result of his u-turn on this issue.

Council asks Cabinet to write to the Prime Minister setting out their opposition to this policy on child benefit for the reasons given above, and ask him to reconsider his proposal.

Motion 3.6: Cllr. Kath McGuirk

Police cuts in Barnet

Council notes the outcome of the Con-Dem coalition's Comprehensive Spending Review will mean cuts to the police of 4% each year for the next four years.

Council also notes that, as the Police budget is nearly 80% staffing costs, there are likely to be cuts to police numbers.

Council understands that our local Safer Neighbourhood Team officers are already being taken away from their wards on other duties as a result of Mayor Boris Johnson's cuts to police budgets, and believes that the Spending Review proposals will mean actual reductions in the number of officers in Barnet's Safer Neighbourhood Teams – particularly given that Mayor Boris Johnson has repeatedly refused to guarantee the current configuration of our Safer Neighbourhood Teams.

Council also notes that burglary rates are increasing in Barnet, and that this could get worse if frontline policing and our Safe Neighbourhood Teams are cut.

Council asks Cabinet to:

- Write to the Secretary of State outlining their opposition to any reductions in the number of police officers or Safer Neighbourhood Teams
- Lobby Mayor of London Boris Johnson calling on him to protect our Safer Neighbourhood Teams
- Work with our Borough Commander to ensure that cuts in Barnet do not affect frontline policing and that the public continue to be protected

Council believes that the Borough of Barnet and its residents deserve a library service that is fit for the 21st century.

Impact of Con-Dem Cuts on Women

Council notes that, according to the Fawcett Society, women face a 'triple jeopardy' from the Con-Dem coalition cuts of slashed benefits, job cuts, and a reduction in core public services.

Council also notes that:

- Women make up 65% of the public sector workforce where mass job losses are expected, and that 40% of women in work are employed in the public sector
- Cuts to family benefits, like child benefit, tax credits, and housing benefit will impact on women disproportionately
- Women access public services such as the NHS more frequently and intensively then men, because of pregnancy, longer life expectancy and lower earnings (women are still paid on average 16.4% less per hour than men) – and that cuts to public services, social care and child care provision will also impact on women disproportionately

Council agrees with the Fawcett Society that the impact of the emergency budget cuts threatens a huge step back in women's equality, as women will increasingly be pushed back into the home to fill the looming care gap. Council also believes with £6bn out of the £8bn cuts coming from women this will have a knock-on detrimental effect on children, young people and the family.

Council notes that the day of this Full Council meeting is Equal Pay Day, and asks Cabinet to assess the specific impact on women in Barnet of any proposed cuts in the council's budget, alongside any other equality impact assessments it will be undertaking, and where an assessment reveals a risk of discrimination, asks Cabinet to report the action it will be taking to address those risks.

- 4.2 To ensure that the Council has robust corporate governance arrangements, the Constitution should be kept under review and amended/ updated periodically such that it continues to be a living document.

9. BACKGROUND INFORMATION

- 9.1 At its meeting on 15 April 2008, the Council considered and agreed changes to the Constitution pursuant to recommendations of the Special Committee (Constitution Review). Many of these changes emerged from the annual review process but some were specific to the requirements of the Local Government and Public involvement in Health Act 2007 ('the Act').
- 9.2 This annual review of the terms of reference of the Standards Committee is an opportunity to consider if there are any consequential or further changes required to the Constitution.
- 9.3 Article 9 is the part of the Constitution which deals solely with the Standards Committee and contains the Committee's terms of reference. Attached in **Appendix A** is Article 9 of the Constitution and the recommended changes to the terms of reference under Articles 9.03 and 9.04.
- 9.4 Changes affecting the Standards Committee are likely to come forward in the prospective Decentralisation and Localism Bill. However, the extent of those proposed changes will not be known until the Bill is published. Thereafter, the Bill will be subject to the normal Parliamentary approval processes and it is anticipated that it will be well into 2011 before the legislation is enacted and the timetable for implementation is determined. In the interim, it is still considered necessary for the amendments below to be agreed by the Special committee (Constitution Review).

SECTIONS FOR AMENDMENT

9.5 **Article 9.03 (b)** One of the Independent Members will chair the Committee;

Recommended change - The Chairman and the Vice-Chairman shall be Independent Members.

9.6 **Article 9.04**

Recommended change - Add the following paragraphs:-

- (r) responding (through the Monitoring Officer) to consultations on

Proposed changes to Article 9 of the Constitution

Article 9 – The Standards Committee

References: Sections 53-55 and Section 81(5) Local Government Act 2000

Part 10, sections 183 to 203 of the Local Government and Public

Involvement in Health Act 2007

9.01 Standards Committee

The Council Meeting will establish a Standards Committee.

9.02 Composition

The Standards Committee will be composed of at least:-

- Six non-executive councillors, comprising two from each political group
- Seven persons who are not councillors, or officers, of the borough known as Independent Members.

9.03 Independent Members

- (a) Independent Members will be entitled to vote at meetings;
- (b) One of the Independent Members will chair the Committee;

Recommended change – to paragraph 9.03(b)

The Chairman and the Vice-Chairman shall be Independent Members;

- (c) Independent Members of the Standards Committee serve for a fixed term of office of four years;
- (d) Those Independent Members appointed subsequent to May 2008, are limited to two consecutive full fixed terms of office;
- (e) If an Independent Member of the Standards Committee should resign or otherwise leave office before the end of their term, any replacement independent member would serve the remainder of that four year term of office;
- (f) Independent Members are re-appointed by Council on an annual basis during the four year term so that Council is able to take appropriate action in any circumstances where an Independent Member is not properly performing his or her duties;

- (g) Independent Members are appointed following public advertisement seeking interest placed prior to the expiry of a fixed term of office, or earlier if a vacancy should arise;
- (h) The Chief Executive and Director of Corporate Governance and Monitoring Officer carry out a selection process from those responding to public advertisement and make recommendations for appointment to the Council;

[comment: 9.03 - (h) reflect the recommendations from the Special Committee (Constitution Review) from its meeting on 26 November 2007 agreed by the Council at its ordinary meeting on 29 January 2008]

- 9.04 The Standards Committee will have the following roles and functions.
 - (a) Promoting and maintaining high standards of conduct by councillors, faith and parent governor representatives and other co-opted members;
 - (b) Assisting councillors and co-opted members to observe the Local Code of Conduct for Members:
 - (c) Advising the Council on the adoption and revision of the Local Code of Conduct for Members;
 - (d) Monitoring the operation of the Local Code of Conduct for Members;
 - (e) Advising, training or arranging to train councillors and co-opted members on matters relating to the Local Code of Conduct for Members;
 - (f) Considering and making recommendations to the Council, as necessary, on ethical issues affecting the Council as a whole;
 - (g) Granting dispensations to councillors and co-opted members from requirements relating to interests set out in the Local Code of Conduct for Members.
 - (h) Granting and supervising exemptions from political restriction in respect of any post by the current holder of that post;
 - (i) Considering and giving direction to the Council on any requests that a post be politically restricted:
 - (j) To be consulted by and respond to the Local Government Ombudsman if s/he believes that a complaint s/he is considering relates partly to a matter which may be of concern to the Committee;
 - (k) To appoint a minimum of three Sub-Committees, each of no less than three persons and including at least two Independent Members, drawn from the Standards Committee to carry out any of the roles and functions set out in paragraphs [I] to [p] below.
 - (I) To make an initial assessment of any written complaint received alleging breach of the Local Code Of Conduct by any councillor or co-opted member and to either refer the matter to the Monitoring Officer for investigation, refer the allegation to the Standards Board for England if appropriate, or, to decide that no action should be taken in respect of the complaint;

Recommended change – to paragraph 9.04(I)

To make an initial assessment of any written complaint received alleging breach of the Local Code Of Conduct by any councillor or co-opted member and to either refer the matter to the Monitoring Officer for investigation or other action, refer the allegation to Standards for England, if appropriate, or, to decide that no action should be taken in respect of the complaint;

- (m) If a decision is made under (I) above that no action should be taken, to take reasonable steps to give notice in writing of the decision and the reasons for this to the person who made the allegation and to the councillor or co-opted member who is the subject of the allegation;
- (n) To have the discretion where the subject of the allegation is no longer a councillor or co-opted member of the London Borough of Barnet but is of another relevant authority (as defined by the Local Government and Public Involvement in Health Act 2007) to refer the allegation to the monitoring officer of that authority;
- (o) To carry out a review of a decision that no action be taken in respect of an allegation in circumstances where the person who made the allegation has subsequently made a written request for a review of that decision within thirty days of the date of the notice of the original decision;
- (p) Following an investigation and receipt of a report by the Monitoring Officer or Officer appointed by the Monitoring Officer to carry out such investigation and prepare such report into an alleged breach of the Code of Conduct, to make a decision as to whether or not, on a balance of probabilities, there has been a breach of the Code of Conduct and, if there has been, to consider whether it is appropriate to impose a sanction and, if so, to decide upon a suitable sanction, or, alternatively, whether it is appropriate to refer the case to the Adjudication Panel for England if the sanctions available to the Standards Committee are deemed insufficient;

- (q) monitoring the operation of the Register of Members' interests;

8.1. Part 3, Section 2 of the Constitution details the functions of the Special Committee (Constitution Review) which are "Proactively to review, and keep under review, all aspects of the Council's Constitution so as to ensure that it remains current and fit for purpose, and to make recommendations thereon to the Council".

8.2.

9. BACKGROUND INFORMATION

- 9.1. On 12 November 2009, the **2009 Act** received Royal Assent. The 2009 Act makes provision for public involvement in the decisions of Council and aims to promote local understanding about Council functions and democratic arrangements.
- 9.2. Chapter 2 of the 2009 Act, requires local authorities to publicise and comply with a scheme for handling petitions and also provide a facility for electronic petitions (e-petitions) on their websites.
- 9.3. The Local Democracy, Economic Development and Construction Act 2009 (Commencement No. 3) Order 2010, required all local authorities to have arrangements in place for petitions by 15 June 2010 and the requirement for providing a facility for electronic petitions (e- petitions) comes into force on 15 December 2010.
- 9.4. The Council already has in place a scheme for handling paper petitions from residents. In order to meet the requirements of the 2009 Act, the Petition Scheme should define the minimum number of signatures for a petition to be dealt with and how the petitions are to be dealt with. The 2009 Act sets a threshold of signatures and provides three categories of petition:-
 - Ordinary petitions
 - Petitions requiring debate
 - Petitions requiring an officer to account
- 9.5. The Department for Communities and Local Government ("DCLG") publication 'Listening to Communities Guidance on duty to respond to Petitions' sets out guidance on requirements for petition schemes and provides a model scheme.
- 9.6. On 24 September 2010, DCLG withdrew the statutory guidance on the duty to

- respond to the 2009 Act. The letter advising of this which was sent to local authority chief executives is attached at **Appendix A**.
- 9.7. The interpretation of this letter is for local authorities to be given discretion as to how they adopt the Petition Scheme but the expectation is that all authorities comply with the minimum statutory requirements.
- 9.8. A summary of those minimum statutory requirements are set out below:
 - anyone who lives works and studies in the Council's area, including those aged under 18, can sign or organise a petition and trigger a response;
 - a facility is provided by the Council which allows people to sign e-petitions electronically;
 - petitions must be acknowledged within a time period specified by the Council;
- 9.9. In responding to a petition, the following steps must be included in the scheme:
 - considering a petition at a meeting of the Council
 - holding an inquiry
 - holding a public meeting
 - commissioning research
 - a written response to the petition organiser setting out the Council's views on the request in the petition
 - referring the petition to the Overview & Scrutiny Committee;
 - petitions with a significant level of support trigger a debate at a Council Meeting.
 - Council's can determine this threshold locally but it must be no higher than 5% of the local population;
 - Petitions with a requisite level of support set by the Council, trigger a senior local government officer to give evidence at a meeting of the authority's overview and scrutiny committee.
 - Petition organisers can prompt a review of the Council's response if the response is felt to be inadequate.
 - a response which may include taking the action requested in the petition
- 9.10. In cases where petitions have a significant degree of support, the Local Authorities (Petitions) (England) Order 2009 states that the specified number for a petition requiring debate should be no greater than 5% of the total local authority population published by the Office of National Statistics (ONS).
- 9.11. The published ONS sub-national population projection for Barnet in 2010 is 345,800 (5% of this figure is 17,290).
- 9.12. The Department for Communities and Local Government (DCLG) guidance on petition schemes says that a petition which is vexatious, abusive, or inappropriate can be excluded. The test on which to consider the exclusion of

a petition is the same test that would be used for Freedom of Information (FOI) requests. The key question is whether the request is "likely to cause distress, disruption or irritation without any proper or justified cause"

9.13. **Petition Thresholds**

9.13.1 The Threshold to require a response:

The DCLG guidance on thresholds gives an example based on a population of 150,000. The guidance suggests petitions which contain 1500 signatures will be debated by full Council and petitions which contain 750 signatures can call for a relevant officer to give evidence.

9.13.3 The Threshold for ordinary petitions:

The DCLG's Model Scheme assumes that a Council will respond to every petition it receives, regardless of the number of signatures it attracts. The current arrangements in Barnet as set out in Section 4 (Public Participation) of the Council Procedure Rules of the Constitution direct the Democratic Services Manager to refer a petition or joint letter with 25 signatories to the next ordinary meeting of the relevant committee, sub-committee or forum. It is recommended that this remains the threshold for ordinary petitions.

9.13.4 The Threshold to require evidence to be given from a relevant officer:

Petitions with a requisite level of support, set by the local authority, will trigger a requirement for a senior local government officer to give evidence at a meeting of an overview and scrutiny committee of the authority. It is recommended that, for this purpose, the Council adopts a Petition signature threshold equal to 2% of the total local population figure published by the Office of National Statistics

9.13.5 The Threshold to require Council Debate:

Petitions with a requisite level of support will trigger a debate at a meeting of the full Council. Local authorities can determine this threshold themselves but it must not exceed 5 % of the total local population figure. It is recommended that, for this purpose, the Council adopts a Petition signature threshold equal to 5% of the total local population figure published by the Office of National Statistics

- 9.14. In order to introduce a new Petition Scheme, the Constitution requires amendment. The areas of the Constitution identified for amendment are set out below:-
 - Summary and Explanation
 - Article 3 Citizens and the Council
 - Article 4 The Full Council
 - Article 6 Overview and Scrutiny
 - Part 4 Council Procedure Rules
 - Section 4 Public Participation
- 9.15. It is recommended that the Council adopts a Petition Scheme based on

the draft model scheme issued by the DCLG (Appendix B). The Scheme will meet the minimum statutory requirements of the 2009 Act.

- 9.16. It is therefore proposed that Council be recommended to:
 - note the requirements of the 2009 Act
 - agree to the introduction of a Petition Scheme which meets the minimum requirements of the 2009 Act.
 - Adopt a Petition Scheme based on the draft model scheme issued by the DCLG to comply with the requirements of the 2009 Act.
 - Adopt a petition signature threshold equal to 5% (17,290) of the total local population figure published by the Office of National Statistics for petitions to be debated at a full meeting of the Council.
 - Adopt a petition signature threshold equal to 2% (6,916) of the total local population figure published by the Office of National Statistics for petitions which will require a relevant officer to be called to account before an Overview and Scrutiny Committee.
 - Retain the threshold of 25 signatures for ordinary petitions as set out in Section 4 (Public Participation) of the Council Procedure Rules of the Constitution
 - Adopt the amendments to the Constitution set out in Appendix C of this report in order to comply with the minimum requirements of the 2009 Act.
 - Request that the Director of Corporate Governance be instructed to facilitate a
 process for publishing petitions electronically via the Council's website and
 provide reasons for refusal of an e-petition if it is deemed inappropriate for
 publishing on the website.

Withdrawal of statutory guidance on petitions

I am writing to you about the statutory guidance on the duty to respond to petitions. This guidance was issued by the previous administration under Section 19 of the Local Democracy, Economic Development and Construction Act 2009, to principal local authorities in England on 30th March 2010.

The Department for Communities and Local Government is withdrawing `Listening to communities: Statutory guidance on the duty to respond to petitions' with effect from 24 September (although the document will continue to be available for reference on the department's website). This means you will now have more discretion to decide how you approach petitions locally.

The petitions requirements in Chapter 2, Part 1 of the Local Democracy, Economic Development and Construction Act 2009 necessarily remain in force unless or until they are repealed by fresh primary legislation. This includes the requirement to provide a facility for people to make e-petitions which will come into effect on 15th December this year. Local authorities will be paid for the new burden through the area based grants process this financial year, with the first payment on 15th October.

Local authorities are legally bound to comply with the minimum requirements of all statutory duties. However in considering how you approach the petitions requirements, including in making arrangements to set up an e-petition facility, you will wish to consider current circumstances, and having regard to both the Government's commitment to remove unnecessary prescription for local authorities and the priority of cutting out all wasteful spending.

Annex A

Draft model scheme

In order to demonstrate how the framework set out in the 2009 Act can translate in practice we have created a model scheme which local authorities can choose to adopt or adapt. The example below is based on an authority with a population of 150,000 and is the public facing information about their petition scheme published on their website. The model authority has chosen to respond to all the petitions it receives. Petitions which contain 1500 signatures will be debated by the full council and petitions which call for evidence from a senior officer, and have 750 signatures, will trigger that response. ['link' indicates where the council's webpage includes a link to related information]

Petitions

The council welcomes petitions and recognises that petitions are one way in which people can let us know their concerns. All petitions sent or presented to the council will receive an acknowledgement from the council within 14 days of receipt. This acknowledgement will set out what we plan to do with the petition.

APPENDIX C

To introduce an a Petition Scheme pursuant to the Local Democracy, Economic Development and Construction Act 2009, the following changes to the Constitution are recommended.

1. SUMMARY AND EXPLANATION

Citizens' Rights

Citizens have a number of rights in their dealings with the Council. These are set out in more detail in Article 3. Some of these are legal rights, whilst others depend on the Council's own processes.

Where members of the public use specific council services, for example as a parent of a school pupil or as a council tenant, they have additional rights. These are not covered in this Constitution.

Citizens have the right to:

- to be treated equally
- vote at local elections if they are registered
- contact their local councillor about any matters of concern to them
- obtain a copy of the Constitution
- attend meetings of the Council and its committees except where, for example, personal or confidential matters are being discussed
- petition to request a referendum on a mayoral form of executive
- speak at a residents forum on any aspect of Council services and to comment on Council plans and proposals before decisions are made
- contribute to investigations by the Overview and Scrutiny committees
- ask a question and speak at most meetings
- find out, from the Executive's forward plan, what major decisions are to be discussed by the Executive or decided by the Executive or officers, and when
- attend meetings of the Executive where key decisions are being discussed or decided
- see reports and background papers, and any record of decisions made by the Council and Executive
- complain to the Council if:
 - the Council has not done something it promised to do
 - the Council has treated anyone unfairly or impolitely
 - the Council has not provided a service within the time set
 - another organisation providing services on behalf of the Council has not done so properly
 - there is any other justifiable complaint

A leaflet with further information about complaints is available from Barnet libraries and Barnet On-line.

- complain to the Ombudsman if they think the Council has not followed its procedures properly. However, they should only do this after using the Council's own complaints process
- complain to the Council's Standards Committee if they have evidence which they think shows that a councillor has not followed the Local Code of Conduct for Members: and

2. ARTICLE 3 – CITIZENS AND THE COUNCIL

(a) **Voting and petitions.** Citizens on the electoral roll for the area have the right to vote and sign a petition to request a referendum for an elected mayor form of Constitution.

Recommended change: Replace 3.01(a) above with a new paragraph 3.01(a) (i) and (ii)

- 6.03 (f) A relevant officer for the purposes of Article 6.03 (a) (vi) is any one of the Chief Officers designated as such by Article 12.01 (b) of the Constitution.

Explanatory Note – petitions, public comments and questions

2. Petitions – If a group of residents are concerned about a Council service or a decision that is about to be made, they may send the Council a petition.

Recommended change: Delete paragraph 2 of the Explanatory Note above and replace with:

- 2. **Petitions** If persons who live, work or study in the authority's area are concerned about a Council service or a decision that is about to be made, they may send the Council a petition. All Petitions submitted to the Council shall be considered and responded to in accordance with the Petition Scheme set out in section 3 of the Council Procedure Rules and pursuant to the Local Democracy, Economic Development and Construction Act 2009.
- 3. Petitions and joint letters and procedure

- 3.1 Any petition or joint letter signed by 25 people or more who live or have businesses in the borough will be submitted to the next meeting of the committee or sub-committee or forum within whose terms of reference it falls, together with an officer's report.
- 3.2 Petitions or joint letters must be delivered to the Democratic Services Manager. If a member or officer of the Council receives a petition or joint letter, he or she must pass it immediately to the Democratic Services Manager. The Democratic Services Manager will arrange for the relevant Chief Officer to report the petition or joint letter to the next ordinary meeting of the relevant committee, sub-committee or forum.
- 3.3 The Democratic Services Manager shall notify the lead petitioner of the method by which the petition will be dealt with,

Petition Scheme

- 3.1 Petitions submitted to the Council shall be accepted and responded to in accordance with the Petition Scheme set out in the Council Procedure Rules. The Democratic Services Manager or a designated officer shall be responsible for the administration of the Petition Scheme.

- (a) requests for action to be taken or ceased
- (b) contains the signatures and addresses of 25 or more persons who live, work or study in the borough
- (c) relates to a function for which the Council is responsible
- (d) relates to an improvement in the economic, social or environmental wellbeing of the authority's area to which any of its partner authorities can contribute
- (e) is received in paper form or as an electronic petition submitted using the authority's e-petition facility
- 3.3 A petition shall not be accepted if it:

- (a) is vexatious or abusive
- (b) relates to a planning or licensing application, appeal or review
- (c) is a petition made under any other enactment or statutory provision
- (d) is an electronic petition and is not submitted using the authority's e-petition facility
- 3.4 Any petition or joint letter with signed signatures and addresses of 25 or more persons who live, work or study in the borough will be submitted to the next meeting of the committee or sub-committee or forum within whose terms of reference it falls, together with an officer's report.
- 3.5 A petition accepted shall be acknowledged in writing within 10 working days and the petition organiser informed of the action the Council will take to respond to it and the reasons for taking that action.

A Petition for Debate

- 3.6 A petition containing **17, 290 or more signatures** of persons who live, work or study in the borough duly received and accepted as valid by the Democratic Services Manager shall be debated at a full meeting of the Council:
- (a) the petition will be placed on the agenda for the next available Council meeting provided that (i) it has been received no later than 15 working days prior to the date of the meeting and if received after that date it will be placed on the agenda of the next available meeting and (ii) no other petition has already been accepted to be placed on the agenda for the meeting in which circumstances it will be placed on the agenda for the next available meeting.
- (b) the petition organiser, or a member of the Council on their behalf, shall be entitled to address the Council for up **to 5 minutes** on the petition.
- (c) the Council will debate the petition for up to 15 minutes.
- 3.7 in disposing of the petition the Council may decide one of the following courses of action:

to take the action requested by the petition not to take action on the petition to refer it to a Committee of the Council to conduct an investigation or take other action

to refer it to the Executive if it is a matter within their remit

to refer it to another public body to take any other action they consider to be appropriate

- 3.8 a written response shall be sent to the petition organiser within **10** working days of the meeting setting out what the Council has decided.
- 3.9 The response of Council will be published on the authority's website.

Petition to call an officer to account

- 3.10 A petition shall call an officer to account if:
- (a) the petition contains **6,916 or more signatures** of persons who live, work or study in the borough.
- (b) the petition requests for a relevant officer to give evidence at a public meeting of the authority.
- (c) the petition gives grounds for the request which relate to the discharge of functions for which the officer is responsible.
- 3.11 If the conditions in 3.10 (a)–(c) are met in disposing of the petition a relevant officer shall attend before an Overview and Scrutiny Committee to answer questions and give account to the Committee in respect of the matters raised by the petition.

Review of a Petition

- 3.13 If the conditions in are met in disposing of the petition a relevant officer shall attend before the Business Management Overview and Scrutiny Sub-Committee to review the adequacy of the steps taken or proposed to be taken in response to the petition.
- 3.14 If the organiser of a petition believes that the petition has not been dealt with appropriately or responded to satisfactorily, the petition organiser shall have the right to request that the petition be referred to the Business Management Overview and Scrutiny Sub-Committee.
- 3.15 The Business Management Overview and Sub-Scrutiny Committee shall deal with the request at the next available meeting.
- 3.16 The petition organiser shall be informed of the results of the review within

10 working days of the decision.

3.17 The Council will publish the results of the review on the authority's website unless it considers that in all the circumstances it would be inappropriate to do so.
