SUPPLEMENTAL REPORT OF THE HEAD OF GOVERNANCE AGENDA ITEM 5.3

5.3.5 EMERGENCY MOTION IN THE NAME OF COUNCILLOR ALISON MOORE

Reasons for urgency - it emerged only yesterday that MetPro was not properly licensed, and the extent of the value of their contract - after the deadline for motions. The council has said they will audit the matter, but members ought to discuss the terms of reference of this audit and whether or not it is held in public given the nature of the public concern.

BARNET'S SECURITY ARRANGEMENTS

Council notes the headlines yesterday in the Evening Standard relating to MetPro Rapid Response who have been covertly filming whilst on duty in council premises.

Council notes that it has now emerged that MetroPro was not properly licensed, and is now under investigation by the Security Industry Authority.

Council notes that around £1.2m of Barnet council tax payers' money has been paid to MetPro for security duties in council premises, but there does not appear to be any evidence of a Cabinet or delegated officer decision to employ MetPro.

Council also notes that there does not seem to be any official Council premises Security Policy in place.

Council is concerned that proper contract procedures may not have been followed in the engagement of MetPro, and that without a proper security policy in place the Council is vulnerable to something similar occurring in the future.

Council notes that the Council is investigating these issues, but believes that a full and proper public inquiry should be held in the interests of transparency.

Council therefore asks that an ad-hoc scrutiny committee is set-up to review the council's procurement of the MetPro contract, and the council's premises security arrangements.

For the motion to be debated, Council would have to agree to suspend Council Procedure Rule 31.1 relating to the deadline for submission of motions, and in so doing to agree that it is a matter of urgency.

31.1 Any member may put a motion on the agenda for an ordinary meeting of the Council, except the meeting that deals with the budget and council tax. The member must give written notice to the Democratic Services Manager at least six clear working days before the meeting. Any motion delivered after 4pm will be recorded as received on the next working day. The motion must be signed by the member and delivered by hand, post, fax or e-mail.

The relevant provisions for suspending of standing orders are set out in Council Procedure Rule 14.1.

14.1 The Council at any of its meetings may suspend any standing order provided that:

14.1.1 either due notice has been given, or Council agrees that it is a case of urgency, and 14.1.2 the motion to suspend a standing order is moved, seconded and carried without discussion by a majority of the members of the Council present and voting.

5.3.6 REPORT FROM CABINET - LOCAL DEVELOPMENT FRAMEWORK

Prior to consideration of the Cabinet report on the Local Development Framework, Council is asked to approve the recommendation of Special Committee (Constitution Review) of 9th February 2011 to amend Part 3 of the Constitution (with regards to 3.8, Responsibility for Executive Functions) to include the addition of the following Statutory Framework Policies – For Council Decision, and Plans and Strategies for Cabinet Decision:

Statutory Framework Policies - For Council Decision

- Submission and adoption of Development Plan Documents comprising the Local Development Framework
- Agreement to establish Joint Committees to be local planning authorities, and of agreeing to confer additional functions on such Committees
- Agreement to prepare with two or more Authorities one or more joint Development Plan Documents.

Plans and Strategies For Cabinet Decision

 Draft Development Plan Documents and adoption Supplementary Planning Documents comprising the Local Development Framework

RECOMMEND:

- (1) That Council approve the above additions to the Responsibility for Functions in the Constitution.
- (2) That the Head of Governance be instructed to make the appropriate changes to the Council's Constitution.

5.3.7 COMMENTS FROM BUSINESS MANAGEMENT OVERVIEW AND SCRUTINY SUB-COMMITTEE – 11 APRIL 2011

Business Management OSSC considered a call-in on the Local Development Framework, North London Waste Plan last night. They were advised that, as the decision made by Cabinet on 29 March 2011 was to refer the NLWP to Council for approval (the LDF is a policy framework document), that they were only able to make comments to Council (O&S Procedure Rule 16(r) refers).

Accordingly, they made comments as follows:

1. The Sub-Committee expressed concern that insufficient consultation has been carried out with Barnet residents living in N10 who will be affected by any decision on the Pinkham Way site.

2. The Sub-Committee request that the LBB's response to any planning application in regard to the Pinkham Way site that is submitted to the Haringey planning department should be referred to the LBB P&E for information & comment. The Sub-Committee further request that, as part of this process, the LBB Planning department carry out wide and extensive consultation, making local Barnet residents aware of the application so that they can submit their comments to the Haringey planning department. The LBB Planning department should liaise with the Haringey planning department to use best efforts to ensure that such comments from Barnet residents are taken into consideration when formulating its response.
