9. BACKGROUND INFORMATION

9.1 Councillor Jazmin Naghar has requested that a Member's Item be considered on the following matter:

191 West Heath Road, NW3 - Extension of guard railings.

The house has been owned by the same family since 1954 and I understand that car accidents have always been a continual problem with more frequent incidents having occurred recently. It seems that cars drive along West Heath Road and as the hill descends drivers gain speed, loose control at the junction and crash against the railings. Unfortunately some cars miss the railings and crash against the wall of the house. All possible points of impacts would be covered by an installation of a further six sections of guard rail to the North. The guard rail will most certainly cushion the impact and limit both injury to pedestrians and drivers, whilst reducing damage to the cars themselves.

The recent accidents are as follows,

24th September 2009, stolen car being pursued by police 3rd November 2009, allegedly unmanned vehicle which rolled down the hill! 11th January 2010, car which afterwards appeared to be abandoned drove into exactly the same spot as 24/9/09.
