5. MEMBER'S ITEM – FLOODING OF FOOTPATH: STANLEY ROAD – MARKET PLACE N2 (Report of the Acting Democratic Services Manager – Agenda Item 5A)

Cllr McNeil circulated a plan and photographs of the area in question.

In response to the Member's queries, the representative of the Interim Director of Environment & Operations:

 stated that the flooding appeared to have been the result of demolition works on the site in question, that there was no flooding when the site was visited on 12th November during a period of moderate rainfall, and that arrangements would be made for the site would be visited again in wet weather,

- outlined the Council's powers to prevent the flooding of footways by water from adjoining premises, and
- described arrangements that were currently in preparation to take enforcement action in such cases.

- 2. That Cllr McNeil be given monthly updates on the position regarding the Stanley Road Market Place footpath.

6. MEMBERS' ITEM – WAYSIDE, NW11(Report of the Acting Democratic Services Manager – Agenda Item 5B)

The representative of the Interim Director of Environment & Operations submitted a proposal (accompanied by a tabled plan) for parking restrictions to address the car parking problems in Wayside highlighted by Cllr Monroe Palmer in his item. At the request of the Chairman, these had been developed in consultation with Cllr Palmer, and (as modified slightly from those shown on the plan) comprised double yellow lines at junctions and along both sides of Wayside placed to allow passing spaces (of 2 cars in length) between the areas where parking would be permitted. The remaining space available for parking would be set out to accommodate a fixed number of cars.
