- (2) The Interim Director of Environment, Planning and Regeneration requests that Donoghue provides in writing the days that they will clean the road with their mechanical sweeper across the forthcoming three month period; and once Donoghue provides this information, officers visit at random and inspect if the cleaning is being carried out.
