9. BACKGROUND INFORMATION

9.1 At the last meeting of the Sub-Committee on 14 September 2011, Councillor Geof Cooke submitted a Member's Item for consideration regarding the decision not to proceed with the planned bus stop on the 382 route towards Finchley Central in

Summers Lane N12 near Sunny Way in view of the strong expression of support for the proposal from local residents"

- 9.2 The Sub-Committee agreed that the Cabinet Member be asked to reconsider the decision not to proceed with the planned bus stop, that the Cabinet Member be asked to consider instructing the Interim Director of Environment, Planning and Regeneration to resurrect the scheme in its original form or explore the option of a hail and ride scheme and that a report on the outcome be brought to the next meeting of the Sub-Committee.
- 9.3 Officers have contacted London Buses, Transport for London seeking their views as to the possibility of introducing a Hail and Ride Service in Summers Lane. London Buses has advised that their current policy is that they are trying to phase out Hail and Ride stretches, replacing them with Fixed Stops which are Disability Discrimination Act (DDA) compliant. Therefore no new Hail and Ride locations would be considered.
- 9.4 Accordingly, the possibility of resurrecting the original Bus Stop scheme in Summers Lane has been broached with the Cabinet Member for Environment who has indicated that his position has not changed and that the scheme should not proceed for the reasons originally stated.
