- Cluster 9 - EDGWARE ROAD J/W COLINDALE AVENUE
- Cluster 10 - EDGWARE ROAD HIGH STREET J/W STATION ROAD

Issue	Details
There is a need for a pelican pedestrian crossing on Aerodrome Road to benefit residents of Beaufort Park. Can the Council please install one?	That a pelican crossing is needed in order for pedestrians to cross the road safely. It was also noted that the area will see a population increase which supports the notion of a pelican crossing.

- (2) That the Sub-Committee request that Ward Members be consulted during the process.

Issue	Details
Street Cleaning Why do Barnet Council charge high rate for special collection for large items in comparison to other London Boroughs?	Residents were concerned of the cost for collection of larger items. Due to this cost residents considered that it encourages fly tipping.

Following discussion and consideration of this issue the sub-Committee:

RESOLVED

- (1) That the Sub-Committee formally referred the matter to the Cabinet Member for Environment whilst noting that the removal of the free skip service has encouraged fly tipping.
- (2) The Sub-Committee therefore request for this to be reviewed and considered.
