1. MINUTES OF THE LAST MEETING (Agenda Item 1)

6. BARNET MULTI-AGENCY SAFEGUARDING ADULTS BOARD ANNUAL REPORT 2010-2011 (Agenda Item 6)

The Committee receiving the report of the Director of Adult Social Care and Health, Committee and noted:

- That Councillors could best advise residents when receiving enquires about elderly relatives being cared for at home to refer to the council's Enablement Teams as first point of contact. It was noted that access points and signposting were well publicised.
- The council had expected and budgeted for an increase in referrals as service provision was a statutory duty
- That the council's translation services were available where appropriate and publicised appropriately

Additionally, in response to a request from Members of the Committee, officers undertook to investigate the future of Barnet Mind and to update an update to the Committee.

7. ANNUAL COMPLAINTS REPORT 2010-2011 (Agenda Item 7)

The Assistant Director, Transformation and Resources, Adult Social Care and Health presented the report and outlined that around 14000 customers had been supported by the service in 2010/11 of which around 6500 had been supported at first point of contact and that around 7500 had received a care package.

Committee noted and welcomed the low number of complaints as a proportion of the number of people supported. The Cabinet Member for Adults thanked the Committee for its appreciation.

Responding to Committee observations that no complaints had been received from Chinese residents, the Cabinet Member for Adults explained that the Council's Adult Social Care and Health Equalities Network will be exploring the ethnic profile of complainants at their next meeting.

8. UNDERSTANDING AND ADDRESSING THE RISE IN THE NUMBER OF REPEAT CHILD PROTECTION PLAN CASES (Agenda Item 8)

The Committee received the report outlining the Councils performance against the indicator *Children Subject to a Child Protection Plan for a second or subsequent time*. Referring to paragraphs 9.6 and 9.8 of the report, the Assistant Director, Children's Social Care explained that at March 2011 the percentage of children becoming the subject of a child protection plan for a second or subsequent time was 18%. The percentages between April and August 2011 ranged between 9% and 13%. This is much improved performance that that at December 2010 when performance was at 20.9%. Committee noted that fluctuations in performance may not be statistically significant due to the small cohort of children involved.

RESOLVED that-

(1) That the report on understanding and addressing the rise in the number of repeat child protection plan cases be noted.

9. IMPLICATIONS OF THE SEN GREEN PAPER (Agenda Item 9)

The Principal Educational Psychologist introduced the report, outlining the key recommendations of the green paper, their implications for Barnet and the next steps required. The Cabinet Member for Education, Children & Families welcomed the direction of the Green Paper around early identification, proposals for streamlined assessment processes, the belief that provision needs to be shaped around the needs of the child and support for increased independence for parents.

The Committee discussed a range of issues including:

- future capacity of special needs schools
- potential reputational risk around IT systems and communications

The Committee noted that all special schools in the Borough were judged as Outstanding by Ofsted and that a report on future capacity would be presented to Cabinet. It was also noted that officers regularly reviewed best practice in IT systems and communications at other authorities to mitigate any future reputational risk.
