AGENDA ITEM 3.1

Breast Screening at Finchley Memorial Hospital

Retain 1st and 2nd paragraphs and amend the rest to read:

Council notes that due to the concerted efforts of many people from across the political spectrum NHS England have been persuaded to underwrite the costs involved in returning the Mobile Breast Screening Unit to the Finchley Memorial Hospital (FMH) site from 1st November 2013.

Council also notes that at the Health Overview & Scrutiny Committee Meeting this was described as a temporary move while they sought other sites.

Council believes that the only sustainable long-term solution is for a static unit to be based at FMH, and that at the recent Health & Well-Being Board Dr Clare Stephens, a member of the Clinical Commissioning Group Board, stated that a static unit was the best clinical solution.

Council believes we must learn from Mike Freer MP's four year failure to deliver on his pledge, by leading a new campaign that is genuinely cross party and is not seen by health professionals as mere political posturing.

Council therefore calls on Cabinet to organise an all-party delegation of elected representatives to attend a meeting with all relevant organisations to work towards a static Breast Screening Unit at FMH.

Council also supports the aim of the petition by Sarah Sackman at http://petitions.barnet.gov.uk/breastscreening/ and encourages all members to sign it.

Substantive Business Item to read:

Council is appalled by the fact that the Mobile Breast Screening Unit was removed from its customary site at Finchley Memorial Hospital without any prior notice, discussion or consultation with stakeholders.

Council is adamant that such a situation cannot possibly be permitted to be repeated and welcomes the "Lessons Learned Report" requested by the Health and Wellbeing Board and the urgent implementation of any actions recommended as a result.

Council notes that due to the concerted efforts of many people from across the political spectrum NHS England have been persuaded to underwrite the costs involved in returning the Mobile Breast Screening Unit to the Finchley Memorial Hospital (FMH) site from 1st November 2013.

Council also notes that at the Health Overview & Scrutiny Committee Meeting this was described as a temporary move while they sought other sites.

Council believes that the only sustainable long-term solution is for a static unit to be based at FMH, and that at the recent Health & Well-Being Board Dr Clare Stephens, a member of the Clinical Commissioning Group Board, stated that a static unit was the best clinical solution.

Re-cycling Bin Fiasco

Add between paragraphs 2 and 3;

Council believes that for recycling to be successful it needs total Community buy in and that Councillor Dean Cohen has managed to bring a popular and efficient service into public disrepute. Council also notes the reports of long delays on the phone in dealing with customer complaints and considers this unacceptable.

<u>Substantive Business</u> Item to read:

Council notes that the new re-cycling service has started in utter chaos, with no contract signed in time to handle re-cycled waste, 11,000 new re-cycling bins not delivered in time for the official start of the new re-cycling service by the private contractor, complaints about the number of bins people are left with and rubbish piled high outside homes.

Council notes in particular, that even though the Cabinet Member is reportedly "apoplectic" at the failure of SSI Schaeffer to deliver the new bins on time, the council is said to be only "considering" imposing a financial penalty for non-compliance under the contract – despite the disruption this has caused to local residents.

Council believes that for recycling to be successful it needs total Community buy in and that Councillor Dean Cohen has managed to bring a popular and efficient service into public disrepute. Council also notes the reports of long delays on the phone in dealing with customer complaints and considers this unacceptable .

Council believes that the whole saga has been a complete fiasco, and a lesson in how not to do things – including in not holding private contractors to account.

Council calls on the Cabinet Member to get a grip, and impose the financial sanctions the council is allowed to under the contract, and immediately review the number of bins needed in each property so those who wish to share a bin or wish to have a smaller bin can.

October 14th was the single biggest day of change for waste collection that any local authority in the UK has ever undertaken."

Replace paragraph 4 with "Council believes officers should be congratulated on what has gone well, but where there were mistakes Council calls on the Cabinet Member to continue his strong leadership and press ahead to impose the financial sanctions the council is allowed to under the delivery contract with SSI Schaeffer, while in timely fashion reviewing the number of bins needed in each property so those who wish to share a bin or switch between bags and bins can do so."

North London Waste Authority

Paragraph 1: replace "In light of" with "Council notes"; delete all after "chaos and confusion," and replace with "Council believes the situation raises several issues which will require examination:

Replace last paragraph (after the numbered list) with "However, Council believes it may be too soon to properly determine the outcome of such questions due to the ongoing nature of the situation. Council requests the Administration to revisit these questions at an appropriate juncture, at which time the council's involvement with the NLWA can be effectively reviewed."

Substantive Business Item to read:

Council notes the cancellation of the procurement project by the North London Waste Authority, which has reportedly cost the Council Tax payers of the 7 North London Boroughs £21 million, and the resulting chaos and confusion. Council believes the situation raises several issues which will require examination:

- 1) The future of the NLWA and whether it is in Barnet's best interests to remain a member or for Barnet to become a Waste Disposal Authority.
- 2) The role of the Chairman and Officers of the NLWA in driving forward the failed procurement and the advice given by the NLWA's advisors.
- 3) The future use and ownership of the Pinkham Way site in the light of the failed procurement and the continuing need for a Barnet Council depot.
- 4) The future of London Waste Ltd as a Local Authority owned company.
- 5) The robustness of the finances of the NLWA, in the light of the change of policy.
- 6) The need for waste facilities in Barnet including the proposed facility in the Brent Cross / Cricklewood development and the future of the Summers Lane site.

However, Council believes it may be too soon to properly determine the outcome of such questions due to the ongoing nature of the situation. Council requests the Administration to revisit these questions at an appropriate juncture, at which time the council's involvement with the NLWA can be effectively reviewed.

Add the following:

Council regrets that teachers felt they had no option but to strike against current government education policy.

- Introducing competition between teachers for pay progression will create a divisive system which will damage children's education.
- Introducing competition between schools over pay will further increase division and will leave those schools serving the most deprived communities unable to recruit the teachers they want because they cannot offer the same pay as neighbouring schools.
- Further cuts to teachers' pensions will have a negative impact on our ability to recruit the best candidates into teaching.
- Because most teachers will not be able to do the job to the best of their ability in their late 60s or early 70s and our children's education will suffer.
- Because 'teaching on the cheap' benefits no-one, least of all parents who care about their children's education

Delete 4th paragraph

Add the following:

Council notes an NUT commissioned ComRes opinion poll of 2,003 adults between 13 and 15 April clearly indicated that the British public values professional teaching qualifications. An overwhelming 86% believe that any school receiving public funding should only employ qualified teachers to teach pupils.

Delete all after "teachers" in 5th paragraph and add "and that non-qualified teaching staff degrade the entire teaching profession."

Delete second sentence in 5th paragraph.

Add the following:

Council supports the NUT in its fight against ill thought-out and untested changes to the curriculum, teachers' pay and conditions and the employment of unqualified staff.

Delete all after "support" in final paragraph.

Substantive Business Item to read:

Council expresses its concern at the unions' threat of a national teachers' strike before the end of the autumn term.

Council regrets that teachers felt they had no option but to strike against current government education policy.

Council notes the largest teaching union, the NUT, has listed the following reasons why government policy led to this decision:

Council asks Cabinet to work with local businesses and traders on any proposals, and report back by the end of the financial year on possible proposals.

Council notes that the Secretary of State gives Local Authorities the power to introduce a local levy of 8.5% of the rate on large retail outlets in their area with a rateable annual value not less that £500,000 and requires that the revenue from this levy be retained by the Local Authority in order to be used to improve local communities in their areas by promoting local economic activity, local services and facilities, social and community wellbeing and environmental protection

Council notes that if this power was acquired it would present the opportunity to raise further revenue for the benefit of Barnet's local communities, should the administration wish to use it.
