


Unit 6, Central Depot, Forward Drive Harrow Middlesex HA3 8NT

Central depot is a 10-minute walk away from the Civic Centre. The training room is situated in Unit 6, a single-storey building within the Central Depot complex. If you get lost you can check in at the reception desk on the ground floor of unit 1.

By train

Harrow and Wealdstone British Rail station (Euston – Watford – Northampton – Birmingham) is about a mile away from Forward Drive. Come out the station, proceed to the traffic lights and go right down Masons Avenue. The turn off for Forward Drive is just past Bakkavor Pizzas on the right.

Harrow on the Hill tube station is about a 30 minutes walk away. This is on the metropolitan line (Baker Street, Amersham, Watford, Uxbridge etc) and on the Chiltern line (Marylebone – Aylesbury).

By bus



Take the H10 bus to Harrow Leisure centre, and Forward Drive is less than 5 minutes away.

From Harrow on the Hill, take any of the 340 140 258 or 182 to Harrow & Wealdstone Station and proceed by foot down Masons Avenue for 10 minutes to reach Forward Drive

By car

Parking at Forward Drive is limited and you may be clamped or blocked in by buses etc if you use the wrong space. Proceed down Masons Avenue and turn down Forward Drive to the side of Bakkavor Pizzas. Follow the road around, staying in the left hand lane (the right hand lane leads to the Civic Amenity Site). Proceed through the barrier and park in the designated visitor areas only.

Alternative parking can be found at the Harrow Leisure Centre, which is free. There is also some parking available in nearby residential roads (some with parking restrictions) or a multi-storey car park within Wealdstone, a 10-minute walk from the offices.
