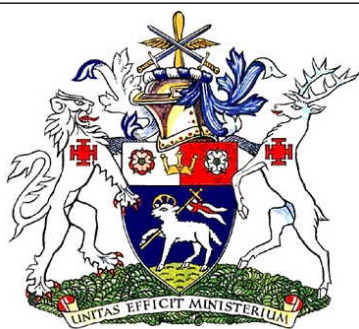

### Summary

This item provides Members of the Finchley and Golders Green Area Committee with information relating a petition that has met the requisite number of signatures in order to be considered by the Committee.

### Recommendations

#### 1. WHY THIS REPORT IS NEEDED

- 1.1 The Head of Governance was notified of a petition that has over 25 signatures which relate to the Finchley and Golders Green constituency. Details of the petition is as follows:

Title of petition	Lead petitioner	Detail/text of petition	No. of signatures
Petition to: urgently address the neglect of Lodge Lane, North Finchley N12 and the cheap resurfacing of the road	Daniela Boyce	Lodge Lane is one of the oldest residential roads in the area, a thoroughfare from the tube station at Woodside Park to the High Road N12, with a primary school, small businesses and a car park. The recent resurfacing has been done to a very low standard and caused many problems - smokes of dust and loose chippings coming into our homes and work places and school, with residents and children slipping and falling, as well as residents breathing in the heavy dust generated. The pavement is uneven due to lorries, dustcarts and cars driving up on it to get past when this historic narrow lane should be 1 way. The houses are too close to the roads to allow the traffic to pass safely and residents are in constant fear of passing cars. The correct expense and care must be taken to preserve it as one of the oldest roads in the area and to eliminate the daily fly tipping and mess in the car park which leads to rubbish flying down the whole road and into our front gardens.	263
