Barnet Adult Social Care Consultation

Barnet Council is currently consulting on proposals for the future delivery of adult social care in the borough. We are asking for your views on two things:

- 1) a new way of **delivering** adult social care in Barnet; and
- 2) a new way of **organising** our adult social care services, of which there are 3 options:
 - Option A - keep the adult social care service within the council
 - Option B - create a shared service with one or more local NHS organisations
 - Option C - establishing a public service mutual

This consultation is live from 16 May 2016 to 8 August 2016 and will play an important part in shaping plans for securing the future of adult social care.

1	<p>Subject: Burnt Oak Substation Address : 35 Watling Street, HA8 0LA (access to site is at the end of Market Lane by the row of garages)</p> <p>Submitted by: Derek Ragunan TFL</p> <p>The accessibility to our Electrical Substation at the bottom of Market Lane has always been a problem for our engineers in preventing us from gaining access to carry out works , access is never clear , jobs have taken longer than necessary and have to be rebooked for alternative visits . Access needs to be clear for Vehicles, Plant and Skips to the Substation.</p> <p>The Electrical Substation consists of heavy duty plant provides power to the tracks for the trains on the Northern Line. As you can imagine breakdown of the line will cause chaos, loss of revenue and compensation claim. It is of vital importance we have 24 hour accessibility at all times for emergencies, i.e. fire and ambulance services, water ingress, breakdowns, maintenance and construction works . Additional to this staff felt frighten if they had to attend site at night due to the lack of security</p> <p>Previous meeting at site at 10.00a.m Thursday 12th March 2015 with a Barnet Council Officer where we discussed double Yellow Lines and the introduction of Cameras as a means of controlling the parking issues on Market Lane. We have builders vans / lorries, abandoned and dumped cars, commuters and school teachers all parking in our road as it is the first one outside of the Edgware controlled parking area.</p> <p>New developments are planned for 246 Hale Lane which is the house at the end of the road and 80 The Grove which will convert 2 existing houses into 14 flats - the applications actually states that there is free parking in the Grove as the developers are not planning to provide an adequate number of parking spaces within the developments.</p> <p>The only solution is to get the council to include The Grove in the controlled parking area. The introduction of permits are intended to provide improved parking opportunities for staff working at schools situated within Controlled Parking Zones (CPZs) in the borough, and to assist those schools in recruiting and retaining teaching staff. The permits will cost £190 per annum, and the number of permits issued to a school will not exceed a number equal to 40% of the total number of staff employed on a full time basis.</p> <p>However, as The Grove is not currently within a CPZ it will not be affected by implementation of the Schools permit, and it likely that teachers will use areas closer to the school for parking rather than The Grove in the future.</p> <p>There have been two Personal Injury Accidents on The Grove, in the most recent three years data available (running to the end of December 2015). Data on injury accidents occurring since then will not yet have been provided to us. Damage only accidents are not generally reported to the police, and injury accidents are used in assessments as there is greater consistency of reporting between locations for these.</p>

We have been asking for this for two years now and have yet to have a definitive response from the council.</p>	<p>Response from: Highways Email: Highways.correspondence@barnet.gov.uk</p> <p>The Council are carrying out work to improve the accessibility of bus stops to make it easier for wheelchair users in particular to make use of the ramps provided for boarding. This means that the kerb needs to be high enough for the ramp to be deployed, and we normally seek to raise the kerb where it is too low.</p> <p>At this location the bus stop is sited between two dropped kerbs that give access to adjacent driveways, so it is not possible to raise the kerb height. An alternative location nearby has therefore been identified where the kerb can be raised to a suitable height.</p> <p>A consultation letter has been sent to residents about the location above.</p> <p>We are also considering another relocation in Hammers Lane in conjunction with Bus Stop Accessibility works to address a problem where vehicles overtaking stationary buses pass the wrong side of a traffic island. NSL are currently commissioned to carry out occasional litter removal within the Council's car parks, however due to recognition of the need for a more concentrated planned cleansing regime in respect to car parks it is planned that this function will soon be moved to Street Scene and car parks will be incorporated into their routine cleansing operation. The details of this change are currently being finalised and in the interim NSL have been instructed to carry out more frequent visits to this car park.</p>

The area underneath the dustbins and wheelie bins is filthy.</p> <p>The first two images show what was dumped by Crystalline Dry Cleaners.</p> <p>The last image is just an example of the kind of mess that I find outside my flat on Goodwyn Avenue.</p>	<p>The area on Goodwyn Avenue adjacent to the alleyway is cleaned daily by a town keeper from Mill Hill. 13	<p>Subject: Colin Crescent and Colindeep Lane – Traffic signs Submitted by: Andrew Dismore</p> <p>I am concerned about the junction between Colin Crescent and Colindeep Lane. Colindeep Lane is a dual carriage way from the junction with the A41 up to a few metres before the Colin Crescent, with vehicles approaching the junction at high speed. Vehicles turning right from Colin Crescent also can't see oncoming traffic due to bend in the road. A vehicle activated sign has been put up but that does not seem to have slowed down the traffic. Can this be investigated to see what measures could be implemented so that life threatening accidents, such as one recently that required the attendance of the London Air Ambulance can be prevented in the future.</p>	<p>Response from: Highways Email: Highways.correspondence@barnet.gov.uk</p> <p>The junction of Colindeep Lane and Colin Crescent is not included in the work programme of Local Implementation Plan (LIP) funded accident reduction schemes for this financial year. New scheme locations are concentrated on locations with higher numbers of recorded injury accidents especially to the most vulnerable road users such as pedestrians and cyclists.</p> <p>Although the junction is a difficult arrangement, and despite the serious injury accident last June, the record of injury accidents related to the junction is low, possibly because drivers are</p>

		<p>especially cautious here.</p> <p>The difficult junction arrangement is not something for which there are obvious solutions. The traffic flow and visibility requirements for a mini-roundabout are unlikely to permit this as a solution</p> <p>There are also proposals as part of s106 arrangements to investigate pedestrian improvements related the North London Grammar School in the general area, and the options here also appear to be limited within the budget available. However in combination with work to look at the junction and the approach there may be mutual benefits to both issues.</p> <p>There will be further discussion at Hendon Area Committee is there is a petition and a Members 'Item on the agenda for the 6th July meeting.</p>

The storm was such that in some areas runoff breached the kerbstone and flowed across the footway into front garden areas / internally into properties.</p> <p>The response from the Environment Agency dated 21 June 2016 is:</p> <p><i>“On 8 June 2016 the South East experienced a series of very intense, very localised rainfall events. A rain gauge in Harrow recorded 47.2mm of rain in just 2 hours, with the bulk of this falling in one hour alone. A nearby rain gauge however only received 23.4mm in a similar time period.
