Waiting until January is unacceptable?</p> <p>Submitted by: Cait O’Riordan</p>	<p>Since the July 2016 meeting regarding the positioning of the crossing there has been substantial work undertaken to review the original proposal to ascertain if the zebra can be relocated to the north of the junction. This work has entailed amongst other things:</p> <ul style="list-style-type: none">a. A topographical survey along a substantial length of the road to ascertain the impact of the existing crest on the two crossing pointsb. Preparation of drawings of the original and revised location together with long sectionsc. The submission of these drawings to the police for reviewd. A site meeting with the police, design engineers and LBB / Re officerse. Discussions between the relevant parties and waiting for reports / observations from eachf. Detailed discussions with the road safety audit team to determine their views on the alternative locationg. Compilation of the review report <p>The review is on-going and the outcome will be reported to the Chipping Barnet January 2017 Area Committee.</p>
