1	Cllr Brian Gordon	The detailed legal requirements for consultation in Planning matters are quite different from those in licencing . In the latter, an unobtrusive notice affixed at the premises and announcement in the local press are considered sufficient consultation with the public. Would you agree that this law is unsatisfactory in practice and that to alleviate the position somewhat licencing officers should be requested to inform Councillors as speedily as possible of any licencing application received within their Ward?	Cllr Richard Cornelius (Leader of the Council)	Keeping members informed of matters which affect their wards as a matter of course is good practice in a whole range of areas. I am sympathetic to the councillor's request.
2	Cllr Barry Rawlings	Given the prediction of increased inflation resulting from the fall in the value of the pound as a result of the vote for Brexit will the Council be altering the MTFS?	Cllr Richard Cornelius (Leader of the Council)	The MTFS has always had to adapt to different economic circumstances. This is not precluded.
3	Cllr Brian Gordon	Would the Chairman join me in commending the work of the Shomrim N W organisation for its excellent security work within the Borough, in full co-operation with the police, as exemplified by a recent scroll induction procession through the streets of Edgware which Shomrim stewarded sensitively and professionally, with no incidents?	Cllr Richard Cornelius (Leader of the Council)	Yes.

Cllr Dean Cohen (Chairman of Environment Committee)	In a survey of roads where footway resurfacing has taken place residents were pleased, with some 91% of people agreeing the work was an improvement. The use of tarmac/asphalt based surfaces was a committee decision that Labour members did not oppose.
5	Cllr Brian Gordon	Would the Chairman join me in welcoming the Prime Minister's recent statement encouraging the re-introduction of grammar schools? If so does he believe that such schools, as in the past, could have a very positive place within this Borough?	Cllr Reuben Thompstone (Chairman of Children, Education, Libraries and Safeguarding Committee)	Yes and yes.
6	Cllr Geof Cooke	Road signs in High Road N12 by Fredericks Place welcome motorists to somewhere called 'Finchley North'. Is the administration trying to rename North Finchley or is it the result of outsourcing to people who do not know the borough?	Cllr Richard Cornelius (Leader of the Council)	I am grateful the councillor has noticed this. The place is North Finchley and a replacement sign is being installed.
7	Cllr Brian Gordon	There have been well-publicised reports of a significant national increase in children calling Childline and other care agencies with urgent emotional, and potentially suicidal, issues. Do we have any statistics on this worrying development, in relation to Barnet?	Cllr Reuben Thompstone (Chairman of Children, Education, Libraries and Safeguarding Committee)	Local data shows that there are approximately 23 presentations per month at Barnet General Hospital for the most serious instances of suicide attempt or serious cutting/self harm. And there has been no notable change during the past two years. However, research indicates about a quarter of young people in the UK experience suicidal thoughts. This suggests that we need to do more locally to enable young people to disclose their feelings and to put in place more community and prevention focused solutions. This is something that we are exploring through the remodelling of CAMHS and we will be piloting the THRIVE model in schools.

Cllr Richard Cornelius (Leader of the Council)	The response at Policy and Resources was to amend Copthall plans so as not to preclude a diving pool. However, some evidence as to usage and cost per person is required, before going into funding and planning problems.
9	Cllr Brian Salinger	Will the Leader please provide members with a list of all planning enforcement cases that officers have handled in the last 2 years advising which they consider to have reached satisfactory outcomes and which are still outstanding. Will the leader ensure that the list shows the dates on which the first complaint about each of the developments was logged?	Cllr Richard Cornelius (Leader of the Council)	The volume of cases means that this list will have to be supplied separately to the councillor and published online.
10	Cllr Paul Edwards	In 2014/15 the Council introduced a charge to residents in receipt of Council Tax benefit of 8.5%. Could the Leader advise how many people received a summons for non-payment of this 8.5%, how many of these had court charges added to this debt, what this charge was, and how many cases ended up with bailiff's being used?	Cllr Richard Cornelius (Leader of the Council)	In 2014/15, 1703 summonses were issued to recipients of Council Tax Support (CTS) (those now incurring 8.5%). Court costs of £72 were added to all these accounts, with a further £25 added when a liability order is granted by the magistrates' court. It should be noted that some court costs may have been subsequently waived where the customer has engaged with the Revenues team. None of these had been passed to the bailiff for enforcement. 				<p>been established. In 2015/16, 513 claims were received, of those 109 were successful and payments totalling nearly £100,000 were made. Claims can be made via the Welfare Reform Taskforce, who carefully assess each case. Some claims have been refused because they did not demonstrate any exceptional circumstances or hardship, had inessential expenses, failed to engage with the Taskforce, or failed to provide the information needed. Most were declined because the council tax could actually be afforded.</p> <p>The Welfare Reform Task Force in place since 2013 offers joined up support to people affected by a range of Welfare Reforms including the introduction of a local Council Tax Scheme. This includes supporting people to access a range of discretionary funds where appropriate including discretionary Council Tax Relief, Discretionary Housing Payments (DHP) and Crisis Fund.</p> <p>The Welfare Reform Taskforce has generated positive outcomes for residents and the council such as assisting claimants to find work, or move to more affordable housing. Applications for Discretionary Housing Payments (DHP) are also assessed by this team. DHPs assist residents with temporary shortfalls in housing benefit, while they seek work and engage further – such improving budgeting and other skills, or finding cheaper accommodation to move to.</p>

Cllr Richard Cornelius (Leader of the Council)	<p>As per the information provided in the report to the Community Leadership Committee on 7th September 2016:</p> <p><u>Hate Crime following EU referendum</u> Following the EU referendum on 23rd June 2016 an increase in reported Race and Religious Hate crime was observed nationally and in London. Barnet has also experienced an increase in rate of reported Race and Religious Hate Crimes in the two week period following the referendum. By the third week after the referendum the rate of reports in Barnet fell back to the pre-referendum levels.</p> <p><u>How big was the increase?</u> The average weekly number of Race and Religious Hate Crimes in Barnet is 10 per week^[1]. During the week following the referendum there were 26 reports, and 19 in the week after that. There were 10 reports in week 3, which is back in line with the average level. This means that during the two weeks following the referendum there were in total 25 more Race and Religious Hate Crimes reported than would normally be expected (i.e. around 2 additional offences per day for a two week period).</p> <p><u>Any patterns?</u> Barnet Police have not identified any specific trends or patterns associated with the increase that would indicate any one particular group is being specifically targeted or that one group of offenders have come to the fore.</p>

				<p><u>Race and Religious Hate Crime – Long term levels and comparisons to London</u></p> <p>During the last 12 months the level of Racist and Hate Crimes reported in Barnet has risen, however the increase is in line with the overall London increase. The level of Race and Religious Hate Crime in Barnet remains considerably below the London average:</p> <ul style="list-style-type: none"> • In the 12 months to May 2016 there were 557 Racist and Religious Hate Crimes in Barnet. • This was an increase of 68 (13.9%) offences from the previous year. • This increase is in line with the London wide increase over the same period (13%). • Per head of population the rate of Racist and Religious Hate Crimes in Barnet is 13% lower than the London average. <p><u>Levels of Anti-Semitic and Islamophobic crime in Barnet:</u></p> <ul style="list-style-type: none"> • In the 12 months to May 2016 there were 121 reported Anti-Semitic Offences in Barnet, compared to 120 in the previous year. • In the 12 months to May 2016 there were 34 reported Islamophobic Offences in comparison to 21 in the previous year.

The reduced spaces for library activity are differentiated between Core, Core Plus and Partnership Libraries, reflecting the current patterns of usage. Events are currently timetabled to take numbers into account and this will continue in staffed opening hours.</p> <p>In the event that a library space becomes overcrowded in the future, during staffed hours, the library staff would need to address this. Should this occur during unstaffed hours, the CCTV operative would alert the contracted security company.</p>
19	Cllr Brian Salinger	Earlier this year the Council announced a significant sum of money to be shared by schools to ease the problems of 'unified pay'. Will the Leader please provide members with a statement showing how much was allocated to each school?	Cllr Richard Cornelius (Leader of the Council)	After extensive consultation unified reward is now being implemented for all directly employed council staff and community schools. Unified reward provides a pay and reward system which is fairer, more flexible and rewards performance. A Collective Agreement was achieved with the Trade Unions on the 31st May 2016 and the changes became effective for corporate staff from the 1st October 2016 and for community schools from the 1st April 2017. Overall the impact of unified reward is cost neutral. However in the first year the impact of pay protection (for those negatively impacted by unified reward)
