1	Councillor John Hart	Could the Chairman of CELS please tell me how the take-up of the European Bacculaureate in Barnet is affecting subjects connected with the arts and with foreign languages	Cllr Richard Cornelius (Leader of the Council)	<p>The English Bacculaureate (EBacc) is a performance measure for schools in England. It allows people to see how many pupils get a grade C or above in the core academic subjects at key stage 4 in any government-funded school.</p> <p>The subjects are:</p> <ul style="list-style-type: none"> • English • Mathematics • History or Geography • the sciences; and • a language <p>The government first introduced the EBacc measure in 2010. In June 2015, it announced its intention that all pupils who start year 7 in September 2015 should take the EBacc subjects when they reach their GCSEs in 2020.</p> <p>In Barnet GCSE entries for languages as a proportion of the KS4 cohort increased significantly in 2014 and have remained relatively stable since then. The proportion of GCSE students entered for the arts rose slightly in 2014 and 2015 but then fell back in 2016. Attainment levels have varied between 87% and 83% achieving at least a C grade in a language and between 76% and 80% achieving this in arts subjects.</p>

A crash of such severity, that it is possible that the young motor cyclist involved, did not survive. The car that went into the young man, was abandoned on pavement, and the (3?) from the car, ran off. Wreckage strewn from outside number 85 Ashurst Road up to number 92. The young motor cyclists body was thrown along Buxted Road. towards the end of 90 Ashurst Road's garden. The emergency services worked for at least two hours on the poor motor cyclist. The police forensic team</p>	Cllr Richard Cornelius (Leader of the Council)	<p>The raised table at the junction of Ashurst Road and Buxted Road was removed in 2004 as part of a localised resurfacing scheme. Between that date and June 2016 there have been a total of 2 recorded incidents both of which were recorded as resulting in “slight” injuries.</p> <p>Officers were informed of the recent tragic fatal incident at this junction. As a matter of priority a site meeting with the police took place to review the circumstances of the incident and agree on any urgent improvements. It was agreed that all road markings in the vicinity should be refreshed and this work has now been completed</p> <p>This incident was subsequently raised as an urgent item at the Area Committee meeting on 30th November where members requested to be informed of the process to review sites that have involved fatalities. This information will be provided to members at a future committee in order to consider this location for future improvement works.</p>

The enforcement service within Re, working with Council Commissioners and Communications staff have undertaken a comprehensive review of Planning Enforcement services, processes and communications to ensure it meets the expectations of members and residents</p> <p>This review has identified a number of actions that are either already being delivered, or will be rolled out between December 2016 and March 2017. These changes will improve quality assurance / performance monitoring, member information and the customer experience.</p> <p>A Members briefing is being arranged to share details of the plan and obtain specific feedback.</p>

Cllr Richard Cornelius (Leader of the Council)	<p>The London Borough of Barnet Trading Standards Department are working closely with the police in relation to preventing the sales of knives to persons under the age of 18. A training pack has been produced and has been provided to a number of traders. Furthermore regular test purchases are taking place to ensure premises are not selling to under 18s. In terms of knife crime incidents the police are the lead agency to respond to this. The police data shows the following which puts the figures in context.</p> <p>As at the reporting period for 1st December 2016 knife crime offences compared to the same period last year (December 2015) has shown a decrease of 10% from 356 offences for the 12 months leading up to December 2015 to 320 offences for the 12 months leading up to December 2016. Approx. 61 of the 320 offences in the last 12 months relate to a knife injury where the victim is under 25 years of age. We have seen an increase of 39% when comparing 12 month to</p>

				<p>December 2015 (44 offences) to 12 months to December 2016 (61 offences), an increase of 17 offences over a 12 month period. The police also work closely with the schools to raise awareness.</p> <p>The council's response to serious youth violence has been addressed in question 92 from Cllr Mitra.</p> <p>In addition to this the council lead on the management of young offenders through the Youth Offending Team. The June 2016 performance report for the youth offending team shows a continued reduction of offences (-55 offences) by young people known to the youth offending team from 159 offences between October and March 2014/15 to 104 offences between October to march 2015-2016. For the same period performance shows a 9.8 % increase in the % of young offenders engaging with employment, education and training and complying with their order. As at May 2016 the Council's youth Offending Team were working with 75 young people who were on statutory orders.</p>

We are also working with Onside on the jointly funded development of Youth Zone, a start of the art facility for young people.</p>

The activities and events that currently take place upstairs in the former Children's Centre rooms will also continue to be provided in the new look library in the proposed community meeting space. 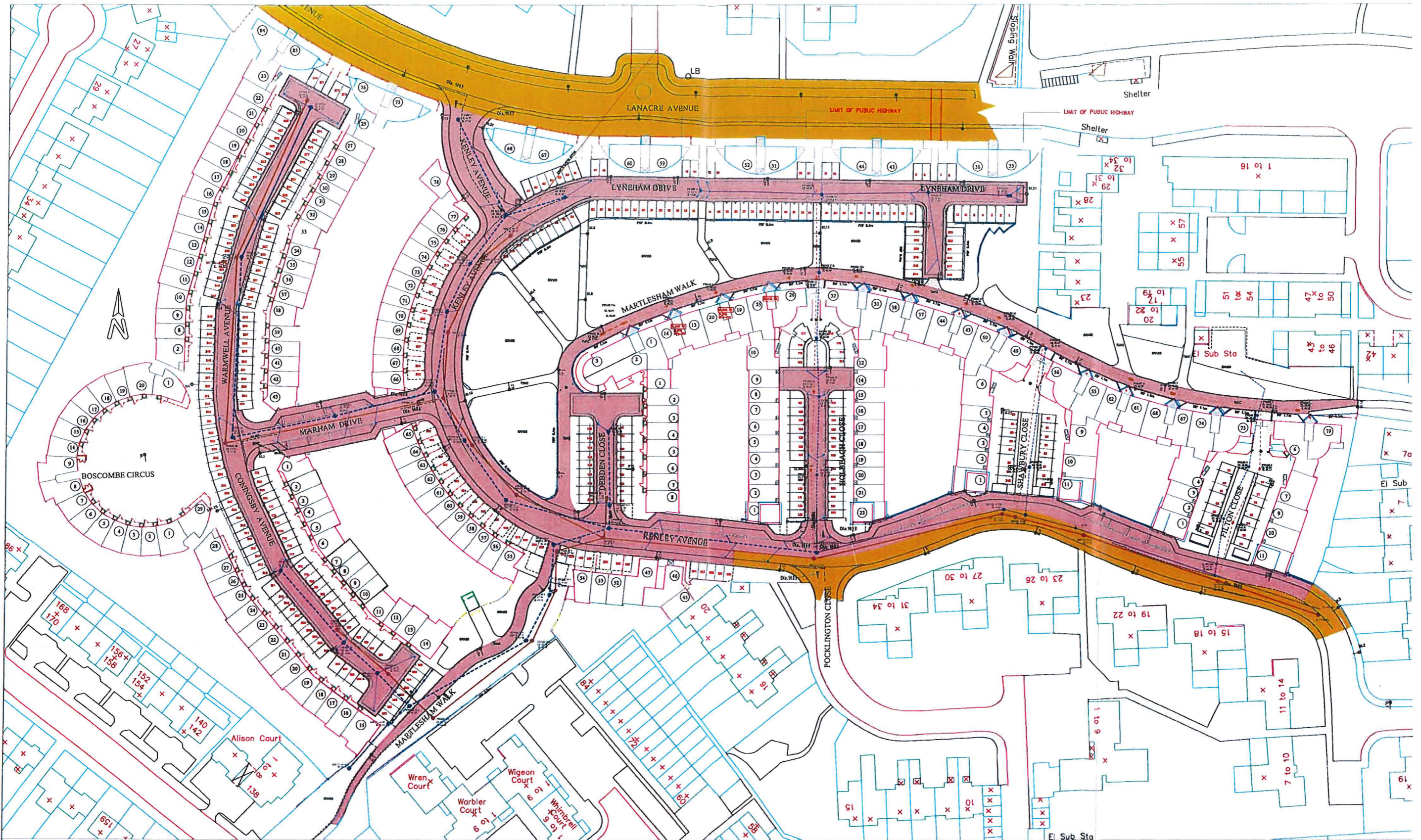
