				<p>The application for a certificate of lawfulness to change the use of the site from a residential institution to a boarding school is complex as such an application has not been tested by case law. Furthermore the decision hinges on the percentage of full time boarders. Therefore legal consideration has been vital to make recommendations.</p> <p>A report for the certificate of lawfulness has been drafted and reviewed by HB Law and will be issued imminently.</p> <p>Members are frustrated at the slow speed of enforcement processes. However, the law is not always helpful in assuring a sensible practical solution.</p>

Cllr Dan Thomas (Chairman of Assets, Regeneration and Growth Committee)	<p>The Planning department have a S106 team who are responsible for monitoring all aspects of the S106 agreement, this team monitor any financial contributions received in lieu of Affordable Housing.</p> <p>In addition the Affordable Housing Liaison Coordinator (in the regeneration team) monitors all affordable housing completions.</p> <p>Regular contact is made with each Registered Provider delivering that year to ensure they are on track with anticipated target completions (as per S106 or other agreements) this includes visits to the scheme to monitor progress.</p> <p>Completion Certificates and full postal address are collected from the Registered Provider as soon as the units complete and this is monitored against the target. Completions are recorded monthly via KPI's and also to the Planning team.</p>

All activities of the Working Group, and the evidence it considers as part of the Review, will be published for public scrutiny and considered by the Performance and Contract Management Committee in due course, as was the case with the CSG contract review. As part of the Review, there will be public consultation, as well as a public evidence gathering meeting that residents can attend to express their views.

12	Councillor Alan Schneiderman	Which roads that were the subject of 'surface dressing' or 'micro asphalt' schemes still require remedial work? When did the original work in those roads take place and when will the remedial work be carried out?	Cllr Dean Cohen (Chairman of Environment Committee)	<p>In Year 1 of the NRP programme (April '15 – Mar '16) 42 Microasphalt roads and 126 surface dressing sites were completed. 13 of the Surface dressing sites were considered to have a substandard final surface as specified under the contract and subsequently defect notice were issued to the Contractor. A further 26 Surface Dressing sites also require some remedial works. As with all works of this nature there is a "maintenance period" where the responsibility for all remedial works rest with the contractor, in these instances this period is 2 years from when the works were signed off. Senior officers from both Regional Enterprise and London Borough of Barnet are in discussions with Contractor's Chief Operating Officer to ensure rectification of these historic issues.</p> <p>In Year 2 of the NPR programme (April '16 – Mar '17) Microasphalt was used on 23 roads.</p> <p>There are 4 locations that require remedial works to be undertaken which are programmed for to be rectified in June this year. Two remedial patches on Britannia Road and Sheaveshill Avenue, 1 ridge area of Abbots Gardens and a low area also on Abbots Gardens.</p>

13	Councillor Brian Gordon	The National Audit Office recently reported that in order to continue the standards of education expected of State schools within budgets available, there would need to be a reduction of some 30 billion pounds from schools' administrative expenses nationally by 2020? How is such a scenario envisaged in Barnet?	Cllr Reuben Thompstone (Chairman of Children, Education, Libraries and Safeguarding Committee)	<p>According to the National Audit Office, the Department for Education estimates that mainstream schools will have to find savings of £3 billion (8%) by 2019-20 to counteract cumulative cost pressures, such as pay rises and higher employer contributions to national insurance and the teachers' pension scheme. It expects that schools will need to make efficiency savings through better procurement (estimated savings of £1.3 billion) and by using their staff more efficiently (the balance of £1.7 billion).</p> <p>The Department's overall schools budget is protected in real terms but does not provide for funding per pupil to increase in line with inflation. In the 2015 Spending Review, the government increased the schools budget by 7.7% from £39.6 billion in 2015-16 to £42.6 billion in 2019-20. While this increase protects the total budget from forecast inflation, the Department estimates that the number of pupils will rise over the same period, by 3.9% (174,000) in primary schools and by 10.3% (284,000) in secondary schools. Therefore, funding per pupil will, on average, rise only from £5,447 in 2015-16 to £5,519 in 2019-20, a real-terms reduction once inflation is taken into account.</p> <p>Schools in Barnet face similar cost pressures to schools in other areas and it is therefore anticipated that schools will need to make, or continue to make, efficiency savings. Furthermore Barnet schools will be adversely affected by the introduction of the National Funding Formula for schools, which is expected to result in an average loss of funding per pupil of 1%, phased over 2018-19 and 2019-20.</p> <p>Schools have direct access to the current benchmarking tools</p>

In addition the sample size was only based on small transects of streets and therefore the assessing of this indicator did not provide a good operation view of the borough and any hotspots for litter and detritus.</p> <p>We believe that the best indicator for street cleansing is the views and satisfaction of our residents who travel around the borough every day. As such we have kept the indicators based on our resident's perception survey as one of our key indicators.</p> <p>Our cleansing team will continue to monitor the borough, using supervisory checks, feedback from residents, business and</p>

New statutory assessments, leading to the production of Education, Health and Care Plans (EHCPs) for individual pupils must now be completed within 20 weeks (previously 26 weeks).</p> <p>A review of the SEND and Inclusion service was carried out by Cambridge Education and this identified insufficient progress with the timely completion of new assessments. In the first quarter of 2016/17 the percentage of new assessments completed within 20 weeks was below 25%. Following an improvement programme, the rate of completions of new assessments within 20 weeks (excluding allowed exceptions) has risen each month since June:</p> <ul style="list-style-type: none"> • July 32% • August 63% • September 78% • October 88% • November 94% • December 100%
