| 2 | 9 | Mary O'Connor | In item 9, appendix E of appendix A of "Draft Corporate Plan 2018/19 Addendum" is "commencing the improvement works to Victoria Park". Victoria Park is charity 4053515. The Charity Commission have a publication "Councillor's Guide: to a Council's role as charity trustee" where it states that "responsibility for decision-making and oversight rests with the councillors". | 4 | 9 | Mary O'Connor | <p>In item 9, "Draft Corporate Plan 2018/19 Addendum" why is the target for "Percentage of residents who are satisfied with quality of pavements" only 37%?</p> <p>Pedestrian activity is environmentally friendly, healthy and the cheapest form of travel that well over 90% of the population can participate in. The present design favours vehicles at every cross-over before pedestrians. Can this committee investigate options to raise residents' satisfaction of pavements by designing pavements to be more pedestrian friendly?</p> | <p>The Council recognises the importance of walking as a significant mode of transport for the borough. For this reason we have established dedicated footway improvement service who have been making substantial improvements to Barnet's footway asset over the last six months. The 37% target is an incremental step towards Barnet achieving a London average percentage in 2019/2020.</p> |
