1. PARKING VOUCHERS AND BLUE BADGE MISUSE (Montagu Road)

2. 20MPH SPEED LIMIT (High Street, Mill Hill, NW7)

Mr Mike Fisher, a representative for Richard Logue, Chair of Mill Hill Residents Association, raised a query about the time scales and scope of the implementation of a 20mph scheme through the School Travel Plan.

In relation to the timescales, Lisa Wright, Traffic and Development Manager for Highways informed the Forum that a consultation procedure would follow involving residents and schools.

Furthermore, the Forum was informed that in relation to timescales, a feasibility study of the Scheme would be undertaken in the current financial year and that the implementation of the Scheme would be added to the Highway Works programme for 2016/17 and be part of the report to the Environment Committee meeting in the new year.

3. STREET SCENE/ CONTAINERS (Mill Hill Broadway etc)

The Forum noted the written response provided by Street Scene in relation to this matter and which also noted that the Enforcement and Investigation Officer will continue to monitor the Broadway after collection day to ensure all are complying with their duty of care in storing and disposing of waste correctly. 4. FLOODING (Silkstream)

Mr and Ms Maja-Roebuck raised a query in relation to the outcome of the meeting arranged between the EA and LB Brent to discuss the storm event and measures to mitigate flooding from the Silk Stream and smaller tributaries.

The Forum also received a query on whether any grants were used towards the two flood investigation studies which are currently being progressed.

The Chairman requested that an appropriate Officer from the Highways Team contact the residents directly within 20 working days to provide an additional response.

Residents informed about the risks of fast-moving traffic. The Forum noted the dangers of vehicles accelerating over 30mph along Bunn's Lane and Page Street. Mr Johnathan Klaff noted the particular danger faced by cyclists in relation to vehicles posing serious danger to cyclists at the junction of Bunn's Lane and Page Street and at the junction of Pursley Road and Page Street and along Pursley Road and Devonshire Road. Mr Klaff advised that he had 75 near misses in one day; 55 along this long stretch of road of Pursley Road to Devonshire Road, with 35 on Devonshire Road..
