The Moxon Street Car park was made into ‘short stay’ car park offering a free one-hour stay, short and medium paid stays and preventing business permit holders from using this car park.</b></p> <p><b>This made the car park nearer to the Town centre more focused towards shoppers and improved the turnover of spaces.</b></p> <p><b>This is accordance with Barnet Parking Policy which seeks to balance conflicting demands and priorities on parking across the borough and to make the best possible use of</b></p>

		<p>our parking assets for the benefit of all residents.</p> <p>An assessment of any spare spaces in the Moxon Street and Fitzjohn Avenue Car Parks has not been undertaken. When will electric car charging points be installed either in Moxon Street, Fitzjohn Avnue or Stapyleton Road Car Parks.</p>	<p>The London Borough of Barnet has recently installed eight electric vehicle charge points (EVCPs) in the Borough to meet the growing demand of electrical vehicle owners and residents. Two in Finchley Road (adjacent to M &amp; S Store), two in East Finchley High Road, two in Lodge Lane car park and two in Bunns Lane car park.</p> <p>The Council is currently also considering the installation of electric vehicle charging points as part of its Long Term Transport Strategy and is aware of a growing demand from residents for such infrastructure. As part of the implementation of the Libraries Strategy work will be taking place at Chipping Barnet Library which will prevent it being used as a meeting venue. The work is expected to start in October. The works and their impact were highlighted to the Chairman of Residents Forum and the Chairman of Chipping Barnet of Area Committee who in turn asked officers to consult with the membership of the Residents Forum and Area Committee on holding meetings for the remainder of the 2016/17 municipal year at Hendon Town Hall.</p> <p>In accordance with Meeting Procedure Rule 4.2, a majority of the committee agreed for meetings to being held at Hendon Town Hall. The selection process for the successful community organisation is currently on-going.</p> <p>Today (26 October) there was a public engagement session to introduce the proposed changes to the current East Barnet Library site. I recently</p>	<p>In 2010 when responsibility for the administration of Freedom Pass renewals passed to the Council 4,768 Disabled Person’s Freedom Passes were issued to Barnet residents by the Authority, which were due to be renewed in 2015. When these 2010 passes came up for renewal, in order to guard against passes expiring without a renewals process being in place, an agreement was reached between</p>

	<p>filled out a consultation document regarding this pass.</p> <p>Is the Council going to revoke it again or are people who already have their pass going to be able to keep it?</p>	<p>the Authority and London Councils that passes due for renewal in 2015 would be automatically renewed and a retrospective check of eligibility would be performed. This work involved retrospectively checking eligibility for the 4,768 customers whose passes were automatically renewed.</p> <p>The Council recognises that the retrospective checking process resulted in 230 Disabled Person's Freedom Passes being withdrawn from residents in Barnet without appropriate guidance being provided. This situation understandably caused distress to a number of Freedom pass holders. As an immediate measure, deactivated passes were reactivated and temporarily returned to 194 residents whilst a full review was instigated to examine the Barnet's Disabled Person's Freedom Pass process and eligibility criteria. Once this review is complete the 194 residents who have had their passes temporarily reinstated will have their eligibility assessed again under the new criteria to ascertain if they are still eligible for their Disabled Person's Freedom Pass. 	<p><b>Ward: Brunswick Park</b></p> <p>“What efforts is the Council taking to reduce pollution and dust on Oakleigh Road South if the Abbots Depot opens?”</p>	<p><b>Depot will be significantly better than previous users Winters Skips who had older vehicles mainly of the Euro 3 or 4 standard.</b></p> <p><b>Dust and mud levels will reduce as refuse collection vehicles have refuse contained in an enclosure after the bin has been emptied, whereas Winter Skips covers on skips were not perfect and allowed some debris to leak on the road.</b></p> <p><b>When Abbots road area was used by Winters there were mainly unpaved muddy and dusty internal roads which will now be paved to reduce mud and dust entering Oakleigh Road South.</b></p> <p><b>As the Street Cleaning vehicles are likely to be based at Abbots Depot this is likely to see an increase in the cleaning of Oakleigh Road South which will reduce dust levels from the other Waste management companies.</b></p> <p><b>Therefore in summary there will be significantly less dust and emissions produced at source from Abbots Depot compared with when Winters were using the site and better cleaning of debris in Oakleigh Road South. The committee agreed to consider the north end of the road when works were complete on the three Tesco housing sites and as part of the temporary enabling works when the large development on the former gas works started. Work has started on that site and there are still problems with speeding traffic and unsuitable vehicles on the section from Park Road to East Barnet Road. We were promised an outside physical exercise trail last year and other improvements to the rec eg possible toddlers play area in addition to the reprovisioned older childrens play area and possibly a skate board park. We know how long the Council processes take and want to start planning now for the future of the Recreation Ground remaining after the other developments are completed</p> <p>NBCA is asking the council to arrange a meeting with the relevant officers, NBCA and the local community to discuss the options and for arrangements to carry out the work next year so it is finished at the same time as the leisure centre and first houses. Money is not a problem as the various new developments in New Barnet are raising circa £12million in S106, CIL contributions and New Homes bonus</p>	<p><b>The Council is fully cognisant of the commencement of development on the Former Gas Works Site this year. Now that the new Leisure Centre designs have reached an appropriate stage, with detailed plans, it is possible to consider the open space areas between these two developments in a fully integrated and aligned manner. The provision of CIL funding from the new development is indeed recognised as a suitable source of capital funds.</b></p> <p><b>A master planning exercise to ensure that the park functions well and provides facilities for all residents of the area has already been commissioned. The sharing of initial draft proposals are timetabled for early December this year which will allow for consideration by the Council in early 2017.
