AGENDA ITEM 4

General points

The following procedure is based on Regulations made by the Secretary of State under the Licensing Act 2003 ("the Hearings Regulations") which may be viewed or downloaded from the website of the Department for Culture, Media and Sport by following links from <u>www.culture.gov.uk</u>

The procedure is intended as a general framework to ensure natural justice and a fair hearing. The conduct of individual hearings may vary slightly according to circumstances and the discretion of the Chairman. In all cases, however, this general framework will be followed.

The procedure allows each party a maximum period of 5 minutes in which to present their case (Regulations 16 & 24). At the end of the time allowed, the Chairman will terminate the presentation and the hearing will proceed in the form of a discussion led by the authority to explore points of dispute. The discussion will not be timed.

The procedure is subject to periodic review and amendment to reflect best practice and relevant legislative changes. An updated version of this procedure is published as soon as possible following any such amendments.

Governance Officer	 To seek nominations for Chairman Elect Chairman Hand over to the Chairman
Chairman	 Introduces him/herself and Members of the Committee, and outlines their roles. Introduces Licensing, Legal and Governance Officer. Explains that Legal and Governance Officers will be present during the Committee's deliberations to advise only, and that the Licensing Officer will be excluded from deliberations. Asks parties present to introduce themselves. Outlines procedure to be followed. Asks all parties to confirm their understanding of the procedure. Clarifies any aspect(s) of the procedure where any parties are uncertain or asks Legal or Governance Officer as appropriate to clarify.
Governance Officer	Informs Committee of absent parties.
	 Details persons whom a party is seeking permission to represent them at hearing. Panel confer regarding permission. Chairman announces decision regarding permission.

Licensing Officer presents the report to the Committee

- Is a statement of the facts including details of the application and operating schedule, relevant policy details, detail representations made, a chronology of events and highlights the points on which the Authority requires clarification.
- Applicant
 Presents opening submissions and clarifies points raised by Authority in notice of hearing. Time allowed 5 mins.
- **Other parties** Presents opening submissions either in person or by spokes person Time allowed 5 mins per interested party.

Note regarding use of video evidence

Video evidence must be in DVD format and will form part of the relevant party's five minutes opening submission. Any party wishing to use video evidence must submit a copy to the Authority along with sufficient, identical extra copies to serve on all the opposing parties – i.e. if the applicant is submitting it, there must be enough copies for all parties making representations and if a party making representations is submitting it there must be a copy for the applicant. The recording must be edited down to the highlights, containing only relevant matter which relates to the written representation previously submitted. In addition, a description of how, when and where the video was recorded and what it contains must be submitted. These must be supplied to the Authority at least five working days before the hearing.

Members question Licensing Officer on Policy

Discussion

Chairman leads a discussion concentrating on points of dispute:

Chairman asks Applicant what he disputes in other parties' submissions, and asks other parties to comment.

Chairman proceeds through all objectors dealing with all matters of contention.

When Chairman feels all matters have been thoroughly discussed and all parties have been given a fair and equal opportunity to comment and make representations, she/he closes discussion.

Determination

There are two procedures depending on whether or not determination is to be made at the end of the Hearing or within five working days of the Hearing. This later announcement of determination is permitted in terms of the Legislation for certain types of applications.

<u>Chairman</u> informs all present that the Committee will deliberate, that Legal and Governance Officer will remain to advise but will not be part of decision-making process, and that all others must leave (under Regulation 14).

- Parties, apart from Legal and Governance Officer, leave the room.
- The Committee deliberates, with advice as required from Legal and Governance Officer, and reaches a conclusion. The Legal officer may assist, as required, in formulating the wording of the determination.
- Parties return.
- Chairman reads out determination, and advises it will be sent in ⁶

writing to all parties.

- Opportunity for determination to be clarified by any interested party who is unclear.
- Chairman gives advice about appealing against the determination.
- Chairman thanks all for attending and closes the meeting.

...Within five working days of the hearing

- Chairman explains requirement to determine the Hearing within five workings days, and advises that the Committee will proceed to deliberate and announce the determination within that time.
- During deliberations, Legal and Governance Officers remain to advise on law and procedure as required. The Legal Officer may assist, as required, in formulating the wording of the determination. The Licensing Officer plays no part in the determination and withdraws for this part of the proceedings.
- Chairman advises all parties that they will receive written notification of the determination within five working days of the Hearing date, together with general information on how to appeal against the determination.
- Chairman thanks all parties for attending and invites the applicant, objector(s), other party(ies) and the Licensing Officer to leave.

Information on Appealing against the decision

You may at any time before the expiration of a period of 21 days from notification appeal to Willesden Magistrates' Court, 448 High Road London England NW10 2DZ (Telephone 020 8955 0555, DX 110850 Willesden 2) by way of Complaint for an Order. The Court may either dismiss the appeal, substitute for the decision appealed against any other decision which could have been made by the Licensing Authority or remit the case to the Licensing Authority to dispose of it in accordance with the directions of the court, and can make such order as to costs as it thinks fit.

1. The Applicants

The application was submitted by Licenses-R-Us on behalf of Mr Masoud Yasini Ardekani, Wallace Bar, 1023 Finchley Road, London, NW11 7ES

2. Application

The application before the subcommittee was submitted under Section 17 of the Licensing Act 2003 for a New Premises Licence. The application seeks to allow the following:

- The **Provision of Live Music** indoors only from 10:00hrs until 23:00hrs Monday to Saturday and from 12:00hrs until 22:30hrs on Sundays
- The Provision of Recorded Music indoors only from 10:00hrs until 23:00hrs Monday to Saturday and from 12:00hrs until 22:30hrs on Sundays.
- **The Supply of alcohol** for consumption both on and off the premises from 10:00hrs until 23:00hrs Monday to Thursday, from 10:00hrs until 01:00hrs (the following morning) Fridays and Saturdays and from 12:00hrs until 23:00hrs on Sundays.
- To allow the following non-standard timings/seasonal variations to the above requested activity hours:
 - An extra hour to the permitted standard timings on; Day preceding Bank Holiday & Bank Holidays
 - Christmas Eve and Boxing Day to end at 01:00hrs the following day
 - On New Year's eve from the end of authorised hours on New Year's Eve to the start of authorised hours the following day
- To allow the **premises to remain open to the public** from 10:00hrs until 23:30hrs Monday to Thursday, from 10:00hrs until 01:30hrs (the following morning) on Fridays and Saturdays and from 12:00hrs until 23:30hrs on Sundays.
- To allow the following non-standard timings/seasonal variations to the hours during which the premises can remain open to the public:
 - An extra hour to the permitted standard timings on; Day preceding Bank Holiday & Bank Holidays
 - Christmas Eve and Boxing Day to end at 01:30hrs the following day
 - On New Year's eve from the end of authorised hours on New Year's Eve to the start of Authorised Hours the following day

A full copy of the application can be seen attached to this report in **Annex 1**.

3. Representations

Responsible Authorities

The Licensing Team have received valid representations from the following responsible authorities:

- Noise Nuisance Representation relates to concerns this authority has with the prevention of public nuisance
- Police Representation highlights concerns relating to the prevention of crime and disorder and the prevention of public nuisance
- Licensing Authority (acting as Responsible Authority) Representation relates to concerns surrounding the prevention of crime and disorder and the prevention of public nuisance.

Other representations

The Licensing Team have received a total of 28 valid representations from members of the public. All the representations can be seen attached to this report in **Annex 2**.

27 of these representation relate to the negative affect that the application could have on the licensing objectives should a licence be granted. Concerns relating to Public Nuisance, Crime and Disorder and Public Safety have been raised within these 27 representations.

1 representation has been received in support of the application.

4. Attaching conditions

The operating schedule, which is part of the application, includes certain additional steps that the applicant will take to protect the licensing objectives. These will become enforceable conditions, should the licence be granted. Additional conditions may be attached to the licence if the committee thinks it appropriate.

The Committee must have regard to all of the representations made and the evidence it hears, and is asked to note that it may not attach conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.

In relation to conditions, the statutory guidance at chapter 10.8 states that "The licensing authority may not impose any conditions unless its discretion has been engaged following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives.

Full Copies of the Councils Statement of Licensing Policy, the Statutory Guidance to the Act and the Council's Guide to Good Practice at Licensed Premises will be available at the Licensing Sub Committee hearing or in advance if required.

A map centrally locating the premises and a plan shall be made available at the hearing.



As the responsible authority for noise and nuisance, I have been notified of the application for a new premises licence for the above.

I am satisfied that allowing this premises to operate in accordance with the application submitted would undermine the licencing objective of the prevention of public nuisance.

Our records show the noise team at Barnet Council has been receiving continuous noise complaints of loud amplified music from this premises since 2008 up until April 2017. In 2009 and 2013 Noise Abatement Notices were served under section 80 of the Environmental Protection Act 1990 as officers from this served witnessed loud amplified music that amounted to a Statutory Noise Nuisance.

In total on 4 occasions a Statutory Noise Nuisance has been witnessed from this premises, however there has been over 20 complaints made to the noise team. On all of the occasions we witnessed a Statutory Noise Nuisance the music could clearly be heard outside of the premises and on two occasions it could be heard inside of residential properties. This clearly shows the location of this premise is not suitable for the application submitted due to it being in close proximity to many residential properties; in particular it is not suitable for live or recorded music of any kind.

I would respectful request the licencing sub-committee reject this application.

The Licensing Authority do however still have concerns that Mr Masoud has been very much involved with the management of the premises for some time and certainly during the period in which Mr Pouressmaell was the premises licence holder.

It is also noted that the licensing team have received several complaints from residents relating to the Wallace during the period following the revocation of the previous licence. The latest of which was received on 24th June 2017 and related to the evening of the 23rd June 2017. On this evening it was stated that the doors of the premises were left wide open whilst loud music was being playing until 23:00hrs causing a nuisance to the complainant. In addition to this the complainant stated that there r was additional nuisance caused by the patrons of the premises until past midnight.

Dear sir,

I am writing to raise my concerns regarding the Wallace Bar, 1023 Finchley Road, NW11 7ES, and the recent licensing application they have made.

Over the past year and a half I have complained to the council's noise complaints line on a few occasions (May and June 2016 being the most memorable) regarding this premises continuing to play recorded music considerably passed their licensed hours. This significantly disrupts my sleep and enjoyment of my home. I have also complained as the bar has had people leave the rear of the bar, onto Porstdown Mews, well into the early hours of the morning, and the customers have often congregated outside the rear of the property, talking loudly at 2am and later, smoking marijuana. Again, not unusual living in London, but allowing people to enter and exit through their fire exit and congregate outside is a clear breach of license conditions. I am also aware that I am not the only person in the neighbourhood to have raised concerns about this business.

I had noted a slight improvement in the new year, however recently the issues have started again.

I do understand that living next door to a business I expect some disturbances, but this is unacceptable, particulatly as yet again I feel that the business is operating outside its licence. From my understanding of their licence they can operate for the sale/supply of alcohol Fri - Sat: 10:00-01:00, Mon-Thu: 10:00-23:00, and Sun: 12:00-23:00, and they are licensed to play recorded music until 23:00 Mon-Sat, and 22:30 on Sun. The majority of my complaints and concerns relate to the inability of the business to cease playing recorded music at the time designated. The recent incidents are as follows:

1st April: loud drunk and noisy customers congregating at the back of the premises 10.30 - 11pm (on Portsdown Mews) using the back doors of the bar as a way in and out. Not just regular conversations, but extremely loud and noisy.

Week of 10th April (exact date unknown): music playing with a loud bass until 1:30am. Unfortunately for me, I have an adjoining wall with the bar. I noted that the music could not be heard well from outside on Portsdown Mews, but carries very well through the wall. Again, I expect some level of noise living in London, but as the bar is only permitted to play recorded music util 11pm I feel that this is unacceptable.

21st April - loud music playing until 1am.

Fortunately for me I have not been around much in May. However, tonight the bar is again playing loud music that is preventing me from sleeping. My frustration was such that I logged on to double check their licence terms and I discovered the application for a new licence and extend the operating hours, and hours through which the business can play music.

I note that there was a licence review held on 9th November, and noted many of the complaints from local residents. For example, the fact that doors and windows were open throughout the night (which was agin the case this evening), complaints regarding the playing if recorded music well past 11pm, and complaints around the business operating outside the licensed hours, which is still happening. I am aware that the police have also had cause to visit the premises regarding breaches to the current license.

Furthermore, I am concerned about the level of rubbish outside the back of the property, their bins are constantly overflowing on to the street, and never seem to be emptied. This is a minor nuisance, but compounded by the noise and other disruption that this business has.

I do note that the new license application has been made by a different individual. I note from a search on the Companies House website that he is the current director of the Wallace bar company, and has been for over a year. I therefore doubt that the change in licensee will reduce the large amount of anti-social behaviour, and the businesses current inability to operate within the terms of their current licence.

I strongly oppose this application. I hope that you will take this submission into account whilst reviewing the application. I would also ask you to review the current licence and take steps to ensure that the business operates within the terms of the licence.
