9. BACKGROUND INFORMATION

9.1 Councillor Pauline Coakley Webb requested that a Member's Item be considered on the following matter:

"To request that the Area Environment Committee instructs officers to report back on the feasability timescale and costs of implementing a 20mph speed limit on all residential roads in Friern Village N11 including Ribblesdale Avenue, Regal Drive and Balmoral Avenue and that the existing double-yellow lines on the roundabout at the junction of Colney Hatch Lane with Ribblesdale Avenue be extended by at least 20 metres into Ribblesdale Ave

There are very many people who use the east end of The Village to walk to and from New Southgate Station both morning and evening, and although there are still two humps in Regal Drive a 20 mph speed limit is necessary to emphasise the residential nature of these very narrow roads and to improve safety.

The existing double-yellow lines on the roundabout at the junction of Colney Hatch Lane with Ribblesdale Avenue need to be be extended by at least 20 metres into Ribblesdale Ave in order to stop cars and vans parking opposite the traffic island, as this makes the road far too narrow at this busy point and impedes sight lines. The extension is also needed to prevent any parking on this very narrow stretch."
