- 5.1 As set out in Annex 1 and the report at Appendix 1, specifically the reference in Recommendation 1 to the Childcare Act 2006 which sets out the Council has a statutory duty to secure sufficient childcare for working families and secure prescribed early years provision free of charge for all 3 and 4 year olds and a proportion of 2 year olds for 15 hours a week. Also in Recommendation 3 for the integration of health professionals into Children's Centres which can be provided for under s75 of the National Health Service Act 2006
- 6. USE OF RESOURCES IMPLICATIONS (Finance, Procurement, Performance & Value for Money, Staffing, IT, Property, Sustainability)
- 6.1 The Council's Medium Term Financial Strategy (MTFS) has the following savings linked to further reconfiguration of early years services:
 - 2014/15 £500k
 - 2015/16 £700k

- 6.3 The approximate Spend for overall Early Years Provision and related support is £32 million. The overall total would be funded from a combination of schools and Council budgets
- 6.4 This review will assist the Council in meeting future savings by considering early intervention methods with a focus on outcomes that deliver return on investment, such as the Brighton Health Led model, as referred to in Appendix 1. As set out in Appendix 1, recent evidence has identified that if families' needs are met early, then it will improve outcomes for them and reduce the number of costly financial interventions required to be made by the state at a later date.
