ADULTS' PERSONAL SOCIAL SERVICES: MAIN NHS TRANSFER, BETTER CARE FUND PREPARATION, SPECIFIC REVENUE GRANTS AND CAPITAL GRANT ALLOCATIONS FOR 2014/15

SUMMARY

1. This letter clarifies local authority allocations for both components of the £1.1 billion transfer of NHS funding to support social care and benefit health in 2014/15. The two components are the main NHS transfer (£900 million) and preparing for the Better Care Fund (£200 million). The allocations are consistent with previously published figures.
2. This letter also summarises the conditions attached to each of these components.
3. This letter lastly confirms the final adults' Personal Social Services (PSS) specific revenue and capital grant funding for 2014/15. The capital grant funding and Local Reform and Community Voices specific revenue grant are unchanged from the provisional figures published in LASSL(DH)(2013)1. The Care Bill Implementation specific revenue grant has not been published in previous LASSLs.
4. Please see **Annex A** for an outline of local authority allocations for the main NHS transfer and for preparing for the Better Care Fund, **Annex B** for the specific revenue grant allocations, and **Annex C** for the capital grant allocations.

ACTION

5. This letter is provided for information only, and confirms final details of local authority allocations for 2014/15. Aside from the inclusion of the Care Bill Implementation specific revenue grant, there have been no changes from the allocations set out in the LASSL(DH)(2013)1, in the spending power calculations for 2014/15, and on the NHS England website.

BETTER CARE FUND PREPARATION AND MAIN NHS TRANSFER

6. Allocations have previously been published for the £200 million for preparing for the Better Care Fund¹ and for the £1.1 billion total², but not for the £900 million main NHS transfer within that total. At **Annex A** this letter sets out allocations for both components and the total. All allocations are consistent with the previously published allocations referenced in footnotes 1 and 2. No changes have been made.
7. The payments for both the main NHS transfer and for preparing for the Better Care Fund are to be made via an agreement under Section 256 of the 2006 NHS Act. NHS England will enter into an agreement with each local authority. However, before each agreement is made, certain conditions must be satisfied. These conditions are summarised below.

Use of the funding – main NHS transfer (£900 million 2014/15)

8. The funding must be used to support adult social care services in each local authority, which also has a health benefit. However, beyond this broad condition, the Department wants to provide flexibility for local areas to determine how this investment in social care services is best used.
9. NHS England must therefore make it a condition of the transfer that the local authority agrees with its local health partners how the funding is best used within social care, and the outcomes expected from this investment. Health and Wellbeing Boards will be the natural place for discussions between NHS England, clinical commissioning groups and local authorities on how the funding should be spent, as part of their wider discussions on the use of their total health and care resources.
10. In line with their responsibilities under the Health and Social Care Act, NHS England must make it a condition of the transfer that local authorities and clinical commissioning groups have regard to the Joint Strategic Needs Assessment for their local population, and existing commissioning plans for both health and social care, in how the funding is used.
11. NHS England must also make it a condition of the transfer that local authorities demonstrate how the funding transfer will make a positive difference to social care services, and outcomes for service users, compared to service plans in the absence of the funding transfer.
12. NHS England may use the funding transfer to support existing services or transformation programmes, where such services or programmes are of benefit to the wider health and care system, provide good outcomes for service users, and would be reduced due to budget pressures in local authorities without this investment. NHS England may also use the funding transfer to support new services or transformation programmes, again where joint benefit with the health system and positive outcomes for service users have been identified.

13. The *Caring for our future* White Paper also set out that the transfer of funding can be used to cover any small revenue costs to local authorities of the White Paper commitments in 2014/15. NHS England should have regard to this when reaching agreements with local authorities.

Use of the funding – preparing for the Better Care Fund (£200 million 2014/15)

14. The funding must be used to prepare for the implementation of pooled budgets in April 2015 and to make early progress against the national conditions and the performance measures set out in the locally agreed plan.
15. NHS England must therefore make it a condition of the transfer that the local authority has agreed a completed Better Care Fund plan with its partner CCG, and that this plan has been signed off by their Health and Wellbeing Board.
16. NHS England must not place any other conditions on the funding transfers without the written agreement of the Department.

Methodology used to allocate funding

17. Both components are allocated using the total adult social care relative needs formulae.

SPECIFIC REVENUE FUNDING

Local Reform and Community Voices grant

18. In 2014/15, DH will make £43.365 million available through the Local Reform and Community Voices grant. This grant is comprised of five funding streams:
 - additional funding for Deprivation of Liberty Safeguards (DOLS) in Hospitals;
 - additional local Healthwatch funding;
 - funding for the transfer of Independent Complaints Advocacy Service (ICAS) to local authorities;
 - funding for the transfer of Independent Mental Health Advocacy (IMHA) to local authorities; and
 - funding for the veterans Guaranteed Income Payments (GIPs) social care charges exemption.
19. Local authority allocations are at **Annex B** and a breakdown of the national grant total by funding stream is included at **Annex D**.
20. The Government has consulted on how funding of each of these streams should be allocated to local authorities. The purpose of the funding streams, and the allocation methodologies used, are explained in LASSL(DH)(2013)1 which is available from:

Care Bill Implementation grant

21. The purpose of this grant is to provide councils with a contribution to the costs of creating the capacity needed to lead and manage implementation of the Care Bill.
22. Each English local authority will receive a single payment of £125,000 shown at **Annex B**, in 2014/15 for use in 2014/15 only. This funding is not ring-fenced but is accompanied with a Memorandum of Understanding, which will shortly be published on the GOV.UK website alongside the grant determination:

CAPITAL FUNDING

Community Capacity grant

23. DH allocates the Community Capacity grant to local authorities, providing capital funding to support development in three key areas: personalisation, reform and efficiency.
24. Capital grant funding has been held constant in real terms for 2013/14 and 2014/15. This means that local authorities will receive DH capital grant funding of £131.666 million for 2014/15.
25. The distribution uses total adults social care relative needs formulae. Confirmed local authority allocations for 2014/15 are set out at **Annex C**.

FURTHER INFORMATION

26. The Isles of Scilly no longer receive their main revenue support grant through the same process as other authorities. Full details of this are available in the CLG guidance. Where Department of Health (DH) specific grants are allocated using the relative needs formulae (RNFs), this will continue to apply to all authorities including the Isles of Scilly.
