# **Recommendations**

1. That the Licensing committee consider and note the following report on the volumes of work into the licensing department in relation to applications for 2013-2014.

#### 1. WHY THIS REPORT IS NEEDED

The Licensing Act 2003 makes the Council the Licensing Authority for licensing the sale of alcohol, the provision of regulated entertainment and late night refreshment in pubs, off-licences, clubs and restaurants in the Borough. There are approximately 1,000 licensed premises within the London Borough of Barnet.

The Gambling Act 2005 makes the Council the licensing authority for gambling premises in the Borough. The Council has a number of important regulatory functions in relation to gambling. These include licensing premises, regulating gaming and gaming machines in clubs, granting permits to what the Guidance refers to as 'family entertainment centres' for the use of certain lower stake gaming machines, regulating gaming and gaming and gaming machines on alcohol licensed premises, granting permits for prize gaming, and registering small society lotteries.

There are currently 72 gambling premise licences in the borough. There are approximately 34 permits and 55 Small Society Lottery registrations

#### 2. REASONS FOR RECOMMENDATIONS

Attached at Appendix 1 is information on the volumes of work undertaken in relation to applications by the Licensing Authority in 2013-2014.

A comparison of the work flow for the past three years shows that the volume of work again remains fairly static. In some applications there has been a decrease in applications and others an increase.

There has been a slight increase in the number of minor variations which may be that more businesses are recognising this as a useful application process in relation to small changes to their premises.

For the first time in a number of years there has been a decrease in the number of Temporary Event Notices (TENs) applied for. The Licensing Department are unsure of why this has decreased this year. It may be that many of the premises who were applying for TENs have now applied for or varied the premises licence. However we plan to look into this further to ensure that the right information is out there for businesses in relation to when they need a TEN.

The data indicates that there has been a large increase in the number of sub committees meetings. Part of this is due to an increase in the number of postponed or withdrawn applications that are then heard on another day. Sub Committee meetings can only be postponed in the public interest. A number of meetings have been adjourned in the public interest, this year the main reason is applicant availability issues. It has been deemed that postponement in these cases is in the public interest. A number of hearings were withdrawn as agreement was reached between the applicant and the representee prior to the hearing

The other reason for an increase in hearings is the increase in the number of reviews held. These reviews were all brought by the metropolitan police and included a number of summary and expedited reviews which means a short turn around time between application and first summary hearing (48 hours).

In 2013-2014 no sub-committee decisions were appealed, which indicates that there in good decision making undertaken by the committee

# 5.2 Resources (Finance & Value for Money, Procurement, Staffing, IT, Property, Sustainability)

Administration and enforcement of the relevant Acts are carried out by the Licensing team, together with support from Legal Services and from Governance Services, when arranging and co-ordinating arrangements for hearings where there are objections. The costs associated with this work are met within existing budgets.

#### 5.3 Legal and Constitutional References

The Licensing Act 2003 placed the responsibility for making local licensing policies and considering applications for licenses on local authorities acting as licensing authorities. The Gambling Act 2005 performed a similar role in respect of gambling premises.

#### 5.4 **Risk Management**

It is prudent to monitor performance to ensure that the Licensing function is delivered efficiently and effectively.

In particular it is important for the Licensing Authority to monitor the number of appeals made against decisions and the outcomes of these appeals. Low levels of appeals and instances of the Courts upholding the Licensing Authorities decisions are good indicators that the Licensing Authority is making made legal and fair decisions within statutory timescales

#### 5.5 **Equalities and Diversity**

The Council has a legal obligation to have due regard to the need to eliminate unlawful discrimination and to promote equality of opportunity and good relations between persons of different groups. When considering applications and representations, only issues provided for in the relevant legislation and associated Guidance, in addition to the licensing authority's policy will be taken into account. This will ensure a consistent approach is adopted. Under the terms of the policy, every application will be considered on its own merits, regardless of the race, colour, nationality, ethnic origin, sex, marital status, disability or age of the individuals involved.

The community in Barnet has a richness of diversity with a broad range of cultural activities and entertainments. Applications will be dealt with in accordance with the Act. Guidance will only be issued and conditions will only be imposed that are reasonable, proportionate and strictly necessary for the promotion of the four licensing objectives.
