RESOLVED TO REFUSE the application which was a reversal of the Officer's recommendation for the following reasons:-

The proposed development would, by reason of the proposed parking layout and restricted access to the site represent a poor form of development which would be prejudicial to the rear servicing of adjoining properties fronting the High Street and would consequently be detrimental to highway and pedestrian safety of the locality as well to the prospective occupants of development contrary to policies CS1 and CS5 of the Barnet Core Strategy (2012), policy DM17 of the Barnet Development Management Polices (2012) and policies 7.4 and 7.6 of the London Plan (2015)

The proposed development would, by reason of its siting and design represent an incongruous form of development which would be detrimental to the character and appearance of the locality contrary to policies CS1 and CS5 of the Barnet Core Strategy (2012), policy DM01 of the Barnet Development Management Polices (2012) and policies 7.4 and 7.6 of the London Plan (2015)

Votes were recorded as follows:
