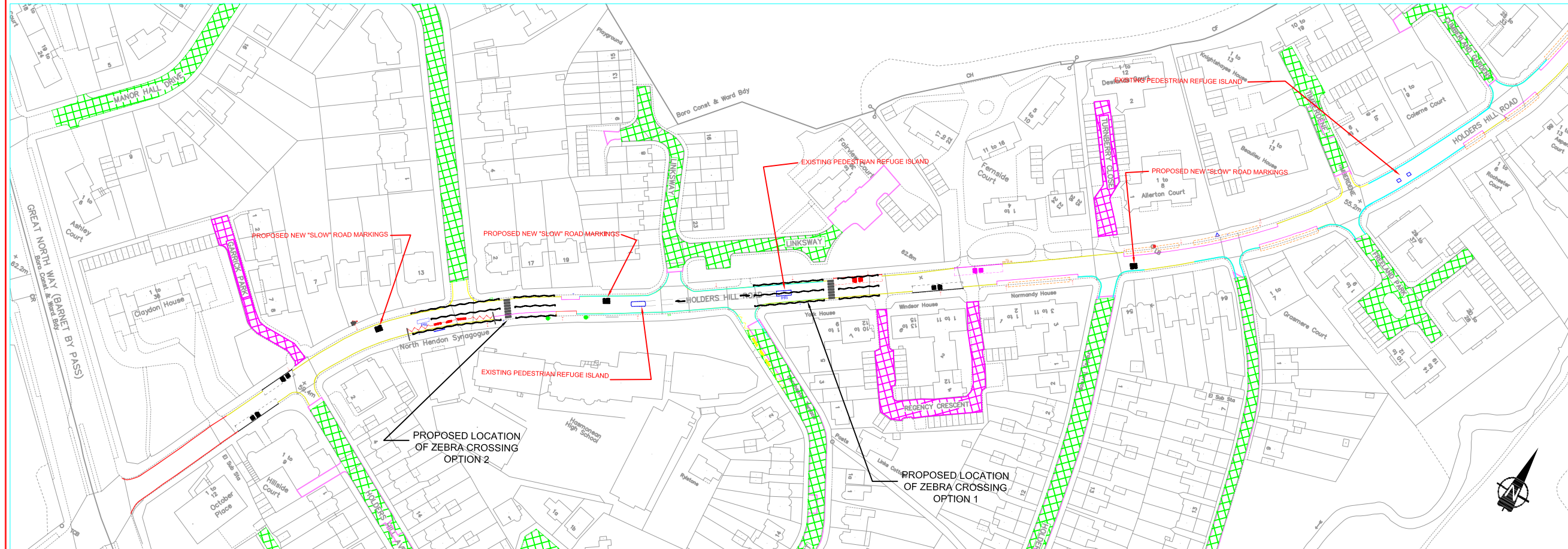
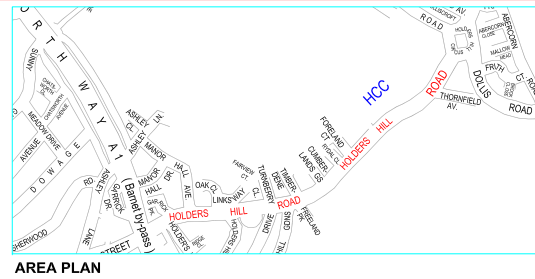
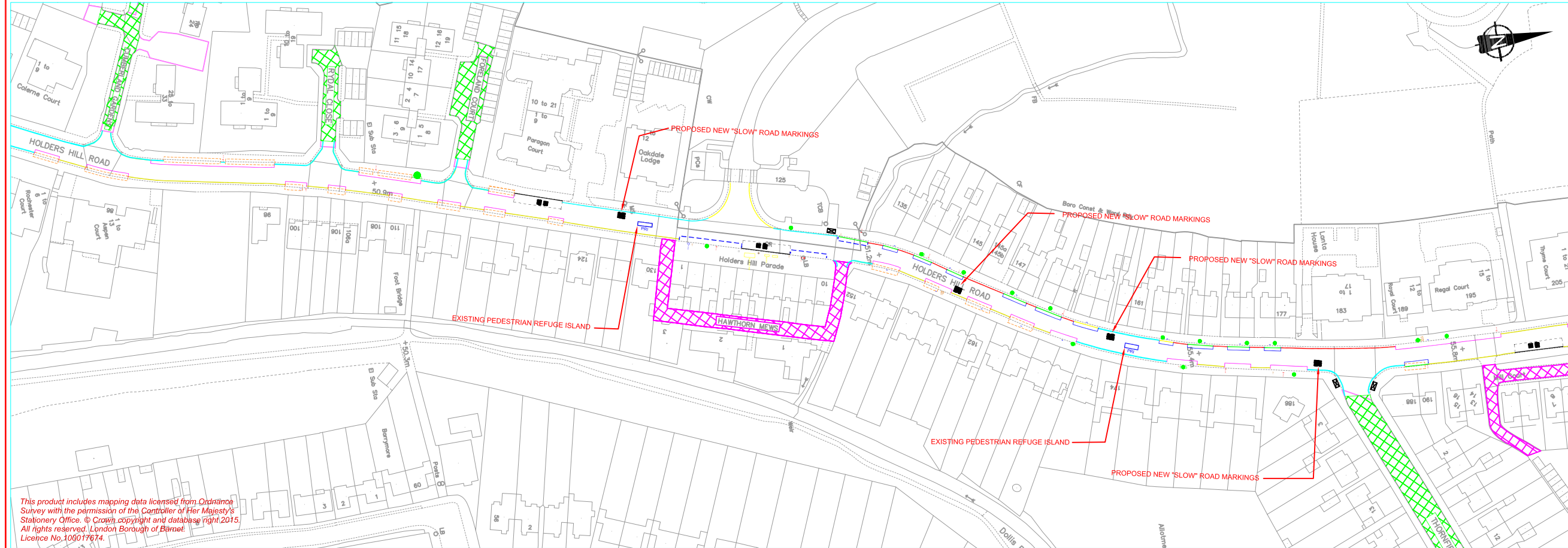

 - Proposed conversion on the existing 1pm to 6pm on event days only limited stay parking bay - (Max stay 1 hour, No return 2 hours) to 8am to 6.30pm and Monday - Friday and 1pm to 6pm on event days waiting restrictions

- Existing 1pm to 6pm on event days only limited stay parking bays (max stay 1 hour, No return 2 hours)

- EXISTING WAITING RESTRICTIONS**
- Existing "No stopping At any time" red route Waiting restrictions
 - Existing 1pm to 6pm on event days only waiting restriction
 - Existing "At any time" waiting restrictions (Double yellow lines)

- OTHER RESTRICTIONS**
- Existing event day permit holders only "Past this point" parking area. 1pm to 6pm on event days (No bay marking on street)
 - Private Roads/Accesses. Excluded from Controlled Parking Zone

- OTHER RESTRICTIONS**
- Existing pedestrian refuge island
 - Tree
 - Existing lamp column
 - Existing sign post
 - Existing telecommunication post
