### 1. The Applicants

The application was submitted by Knight Training on behalf of Hollywood & Co Services Ltd.

### 2. Application

The application before the subcommittee was submitted under Section 34 of the Licensing Act 2003 for an application to vary a Premises Licence. Since the application was made the applicant has reached an agreement with the Police, the application now seeks to allow the following:

- To allow the sale of alcohol for consumption on the premises only from 10:00hrs until 22:00hrs Monday to Thursday, 10:00hrs until 01:30hrs Friday to Saturday and 10:00hrs until 00:00hrs Sunday.
- To allow the provision of live music indoors only from 22:00hrs until 01:30hrs Friday to Saturday and 22:00hrs until 00:00hrs Sunday.
- To allow the playing of recorded music indoors only from 22:00hrs until 01:30hrs Friday to Saturday and 22:00hrs until 00:00hrs Sunday.
- To allow the provision of late night refreshment indoors only from 22:00hrs until 01:30hrs Friday to Saturday and 22:00hrs until 00:00hrs Sunday.
- To allow the premises to remain open to members of the public from 08:00hrs until 22:00hrs Monday to Thursday, 08:00hrs until 02:30hrs Friday to Saturday and 08:00hrs until 00:30hrs Sunday

### 3. Agreements

The applicant has been in discussions with Pc Vicky Wilcock on behalf of Metropolitan Police to the inclusion of various conditions in their application. I can confirm that the applicants agreed to amend their application in order to show the below conditions:

Condition 17 to be replaced not removed. To be replaced with the following;

At all times alcohol is available for purchase the option of snacks and substantial meals will also be available to purchase.

It must actually be appropriate in order to promote the licensing objectives.

In relation to conditions, the statutory guidance at chapter 10.8 states that "The licensing authority may not impose any conditions unless its discretion has been engaged following receipt of relevant representations and it is satisfied as a result of a hearing (unless all parties agree a hearing is not necessary) that it is appropriate to impose conditions to promote one or more of the four licensing objectives.

#### Describe Briefly The Nature Of The Proposed Variation

The premises is a restaurant and coffee bar. It has been open and running for over 12 months now successfully. The owner/director wishes to be able to offer later hours on a Friday, Saturday and Sunday to cater for private bookings such as weddings and Romanian Christening parties. Also to cater for couples and individuals who like to arrive later in the evening to listen to the music and have a glass or wine or a cocktail with or without food. This is why the applicant wishes to have condition 17 "Alcohol will only be supplied before during and after the consumption of a substantial meal" removed. The applicant also states that she is losing out on private hire bookings due to the fact that she has to close earlier than other venues in the local area.

The applicant has an extremely good track record in managing the premises with no incidents over the last 12 months which have required police assistance including times when she has applied for a TEN to cover later weekend hours. She has also taken further steps to ensure the soundproofing of the premises, investing over £7000 on a full soundproofing fit.

They have SIA security staff in place to cover the current hours after 21:00 onwards on a Friday and Saturday and this SIA presence will increase in line with the new hours applied for.

- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

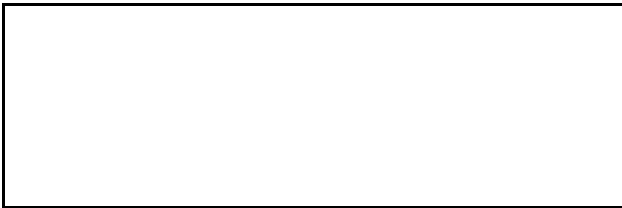

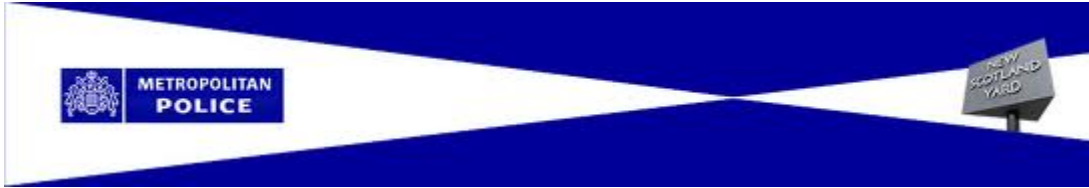

## Annex 1 – Mandatory Conditions

1. No supply of alcohol may be made under the premises licence-
  - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
  - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.  
  
(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—
  - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
    - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
    - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
  - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
  - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
  - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
  - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

ii. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

iii. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(3) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

(4) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—

(a) a holographic mark, or

(b) an ultraviolet feature.

iv. The responsible person must ensure that—

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml;

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.”

4. 1.A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

2. For the purposes of the condition set out in paragraph 1 -

(a)"duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979

(b)"permitted price" is the price found by applying the formula -



$$P = D + (D \times V)$$

Where -

(i) P is the permitted price

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -

(i) The holder of the premises licence

(ii) The designated premises supervisor (if any) in respect of such a licence, or

(iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.

3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

4.(1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

5. Each individual employed in the role of guarding the premises against unauthorised access or occupation, against outbreaks of disorder or against damage must be licensed by the Security Industry Authority.

## **Annex 2 – Conditions consistent with the operating schedule**

6. A CCTV system will be installed that complies with the following specifications:
  - a. Digital recording colour CCTV comprising a multi camera system.
  - b. The head unit (recorder) for storing the images will store such data on a hard drive or a similar quality medium.
  - c. The CCTV system shall be capable of producing immediate copies of recordings on site. Copies of recordings will be capable of being recorded digitally on to CD/DVD/USB or other equivalent medium.
  - d. If the head unit (recorder) is kept on the premises it must be located in a secure cabinet or other secure area, preferably out of the sight and reach of the public. The unit must be further secured by physical means to prevent anyone from merely picking up and removing the unit, e.g. a secure metal boot, or metal case strap, bolted to an immovable object like a wall or floor.
  - e. The quality of the images must be of a sufficiently high standard to allow identification of the subject matter.
  - f. Cameras will cover key areas identified by the operator and Police. These will include external cameras covering any outside area used by customers of the premises, the external entrance and exit doors, approach to the toilets, clear headshots of persons entering the premises, the till and bar areas and other areas not easily monitored by staff.
  - g. Images must be retained for a period of 31 days before overwriting.
  - h. The images will be made available in reasonable time on demand by the Police and authorised officers of the London Borough of Barnet.
  - i. At all times when the premises are open there shall be at least one person who is capable of operating the CCTV system if required to do so by the Police or authorised officers of the London Borough of Barnet. This system will be fully maintained at all times to ensure correct operation
  
7. All staff engaged in the sale of alcohol shall be trained to record refusals of sales of alcohol in a refusals book/register. The book/register will contain:
  - a. Details of the time and date the refusal was made
  - b. The identity of the staff member refusing the sale
  - c. Details of the alcohol the person attempted to purchase

This book/register will be available upon request to police and authorised officers of the London Borough of Barnet.

8. An incident book/register shall be maintained to record:
  - a. All incidents of crime and disorder
  - b. Details of occasions when the police are called to the premises
  - c. Details of ejections of patrons from the premises.

This book/register will be available upon request to police and authorised officer of the London Borough of Barnet.

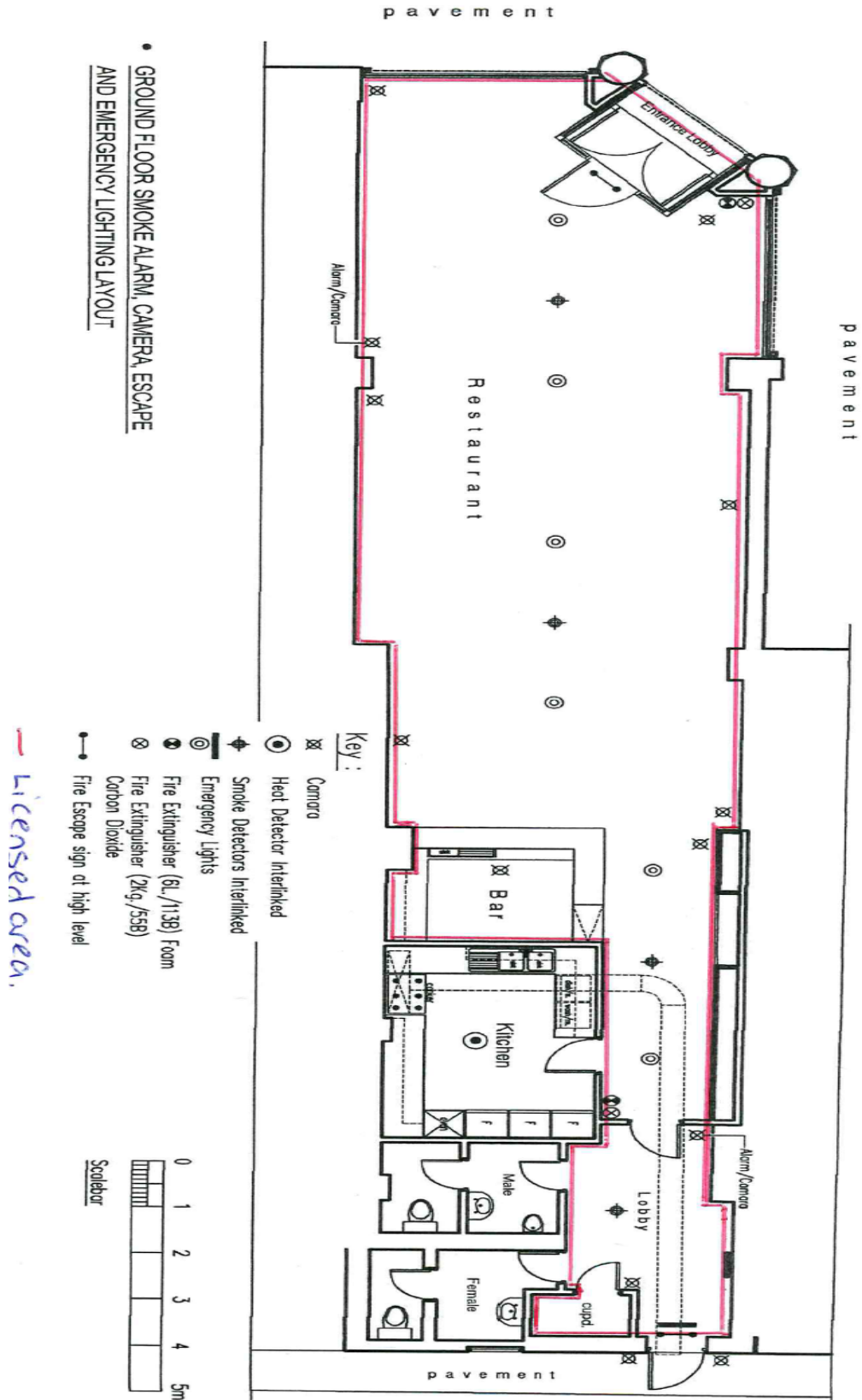
9. Challenge 25 age verification scheme to be operated at the venue and only acceptable forms of identification are (recognised photographic identification cards, such as a driving licence or passport / Holographic marked PASS scheme identification cards). A "No ID, No sale" policy will be operated.
10. Staff will be trained in the challenge 25 policy and training records will be available for inspection if requested by Police and authorised officers of the London Borough of Barnet. Refresher training will be provided at least once every 12 months and induction training provided for any new members of staff
11. No glassware is to be taken outside of the venue.
12. Prominent signage reminding customers to leave quietly the premises will be displayed
13. There will be a wind down period of 30 minutes where live or recorded music will be turned down prior to the terminal closing hour.
14. A minimum of 2 door staff will be employed at the premises on a Friday and Saturday night from 2100 onwards. They will also be employed on any non standard day e.g. Christmas Eve, New years eve.
15. There shall be no vertical drinking on the premises
16. There will be no discharge of glass recycling bins and no waste/recycling collections between 11pm and 7am.

### **Annex 3 – Conditions attached after hearing by the licensing authority**

17. Alcohol will only be supplied before during and after the consumption of a substantial meal.
18. All music be relayed through a noise limiter which shall be set at a maximum decibel level agreed with the Environmental Health Department of the council.

I object in the strongest terms to an extension of hours to 3:30am on Friday to Sundays. These are usually the hours when people sleep for the night and the prospect of alcohol being served till such hours will put what is fundamentally a residential neighbourhood at risk of both unacceptable noise levels and disturbance. More than this, these hours will create a much higher possibility of anti social behaviour since those frequenting the venue will come there as it is the only place in the area to serve alcohol till such late hours.

Nearly all roads nearby are residential and so offering music and alcohol until 3:00am will also increase the possibility of a 'nightclub' environment which again is highly unsuitable to what is a quiet neighbourhood and this too could put the nature of the neighbourhood at risk.

I would like to formally lodge an objection to the application for the variation of the premises licence for The Hollywood Café, which is situated on the Edgware high street at the intersection of Penshurst Gardens and Station Road.

- Edgware is a very suburban area. A short drive from the high street takes you to rural farmland, dominated by horses. It does not have the very late night hustle and bustle associated with central London. What it does have, though is a population of several hundred young families, with young children and teenagers, as well as many elderly people.
- When the Hollywood Café first applied for its operating licence, one of our main concerns was that it would encourage drunk and disorderly behaviour, especially as we live on Penshurst Gardens, which is basically the same road as Hollywood Café. Such behaviour had been seen in previous years, when there was a pub located just near the current Hollywood Café location.
- Barnet Council gave us some reassurance by issuing Hollywood Café a reasonable licence, both in terms of opening hours and the serving of alcohol. In general, while Hollywood Café has not proved to be a nuisance, it is not to be seen as a family restaurant in any way or form. The clientele is predominantly young male Romanians. On a Saturday afternoon, they often congregate on the pavement in front of the doorway to the café, making it quite difficult to navigate that part of the pavement, but as there has never been any aggression arising from this crowd of young men, it is something that we can live with.
- However, it appears that the new application is seeking to re-apply for those conditions which were previously (and reassuringly) rejected by Barnet. One of the most blatant ones is that the applicant has requested an alcohol licence from 10am daily (why would anyone need to consume alcohol at 10am?). This, read together with the request that the condition 17 "Alcohol will only be supplied when consumed before, during and after the consumption of a substantial table meal" be removed, is very concerning. These are the very conditions that have ensured that the Hollywood Café does not endanger the residents of Edgware in any obvious way.
- We all strongly believe that this status quo will change drastically if opening hours are extended to 3:30am, along with the fact that allowing alcohol to be served without food can only lead to drunken and anti-social behaviour.
- The Edgware high street does not seem like a suitable place to have a nightclub. When one applies for a licence to remain open till 3:30am, where alcohol can be served without accompanying food, it is no longer a restaurant with live entertainment. It is a nightclub with a bar. I believe that, even if the noise levels of the music can be contained, the noise associated with drunk patrons leaving the premises at 3:30 in the morning, along with other disruptive and anti-social behaviour that could result after several hours of drinking, could leave Edgware residents feeling quite frightened. Surely this can't be seen as desirable in such a family dominated residential area?

The pub that was 2 doors down (now a polish supermarket) from where Hollywood Cafe now stands caused so much upset to the neighbourhood and any move towards this business type or that of a nightclub would be nothing but negative. Allowing the license for alcohol and late operating hours would go against the prevention of crime and disorder, public safety and prevention of public nuisance, not forgetting the noise pollution. When the pub existed many times we called the police about drunken disorderly people on our road at ridiculous hours in the morning; people shouting, swearing, littering, urinating on our driveways with total and utter disregard. this did not prevent our children from harm as they've witnessed such vile behaviour because they were woken from their beds.

Having Hollywood Cafes' alcohol and loud music late in the night would be ill-advised to Edgware - a quiet family orientated area of London.

Edgware is a quiet family orientated area of London with no demand for a club/bar whatsoever; such a place would bring down the area and cause unnecessary disorder.

The type of people a place like this would attract would be bad for the area, the people it already attracts as it stands causes us discomfort.

Back in early September I reported them for illegal trading - selling clothes with no license from under their awning; an Eastern European woman selling clothes from plastic bags from outside of the premises - and people were buying them - which would've only happened if they'd have advertised. They clearly knew this individual as they always have their awnings rolled up when out of hours and on this occasion one awning was deliberately kept out. We are concerned about several aspects of this matter.

Allowing the license for alcohol and late operating hours would go against the prevention of crime and disorder, public safety and prevention of public nuisance, not forgetting the noise pollution. Having Hollywood Cafes' alcohol and loud music late in the night would be ill-advised to Edgware - a quiet family orientated area of London.

Edgware is a quiet family orientated area of London with no demand for a club/bar whatsoever; such a place would bring down the area and cause unnecessary disorder.

I am writing to object to the current variation application by Hollywood Café to extend weekend opening hours until 3am for music and alcohol with a closing time of 3.30am.

We live in a quiet residential area in Peshurst Gardens and have already seen multiple breaches of the current license conditions. Only last week there were groups of people sharing whisky without food and large groups of smokers and drinkers outside the premises at night means that we are unable to safely enter the entire corner where the café is located as the pavement is usually blocked by hordes of smokers (and occasionally drinkers). The café has been closed a lot but when it is open, the corner becomes a hostile environment to local residents and families with children as large groups of men gather outside drinking and smoking.

A nightclub type operation would be perfectly in place in the High Street or nearer towards the station where there are already restaurants and passing traffic. The end of Peshurst Gardens is almost entirely residential with the only restaurants and cafes closing at 10pm. Even with these opening times, we have seen an increase in beer bottles, noise and traffic along our street, graffiti, litter and alleys being used as toilets associated with the Hollywood Café.

These objections are addressed in the context of the nature of the location (a moderately-quiet heavily residential setting), the type of premises (initially a café, now seeking to become a late night attraction), regulated activities to be provided (music and alcohol – without a meal, which substantially changes the nature and type of venue and business), operational procedures (there is little ability to police any detrimental effect) and the needs of the local community (little evidence of demand in this area for a nightclub, and most residents would object). The opening of such a venue is undoubtedly for those in surrounding areas, and not designed to meet any need of the local community.

The concerns we have, addressed under the relevant heading are:

Prevention of crime and disorder

The opening of a nightclub will attract large numbers from outside the area (being the only venue open at these hours) and this will inevitably cause an increase in numbers of people in drink passing along the road late at night. We have already seen an increase in antisocial behaviour (noise), drunken shouting at night, litter from bottles and cans of alcohol in our driveway, graffiti and cigarette butts and urination. There appears to be no effective measures to discourage drinking in public places in the vicinity of the premises (para 15.4.1 of the Council's policy).

We have no doubt that making a quiet residential street the focus of late night entertainment will be a recipe for disaster and cause much more work for local police who are already over-stretched. A simple review of the CCTV at the venue would reveal how much drinking, smoking and pavement blocking already exists – this can only get worse. We are very concerned that a late night venue will attract the wrong crowds of people into a quiet residential part of Edgware which is unsuited to such activity. A late night venue in an observant Jewish area will also cause tensions as loud noise, drinking and smoking are culturally insensitive where many local shops are closed and many residents wish to enjoy a peaceful weekend. It is of note that anti-Semitic crime and antisocial behaviour is increasing, and this cannot help. The application should be refused as part of an holistic approach to the management of the evening and night-time economy in town and city centres, a per the Councils' written policy (para 3.4).

## Public Safety

Whilst we are unaware of any physical attacks, the corner outside the venue is not a large area, and is already blocked by hordes of smokers and drinkers. There is a strong feeling amongst residents that this area has become a no-go area at night. Increasing opening times will put families returning from Friday night and Saturday night family get-togethers in direct confrontation with partygoers at the nightclub. When trying to sleep, the noise from people coming and going, parking and enjoying themselves late at night would create a further feeling that the risk to our safety has been compromised. There is no CCTV along our street, and there is little police presence (unlike other areas of Edgware). The dark alley of Bakers Row is littered with drinks cans, was home to a recent stabbing and is becoming increasingly more dangerous to use. Creating a nightclub in this location would make matters worse in terms of safety and quiet and peaceful enjoyment of our home environment.

## The prevention of public nuisance

Opening late at night will increase the public nuisance to families living near-by. As stated above, there is already an effective blockade of the corner from hordes of drinker and smokers. There has been an increase in graffiti, litter, urination and noise disturbance. All matters which the council and local police seem ill-equipped to deal with. There is no CCTV or protection along our road (unlike the High Street and around the station). Drinking alcohol outside the venue (without a meal) is already common and passers by are regularly greeted by a hostile group, shouting or intimidating behaviour from users of the venue. This will only get worse with increased hours which will attract much larger numbers of revellers to the area by dint of this being the only potential venue opening so late. The application is in direct contravention of council objectives at para 4.1 of its policy - Positive measures to create a safe and clean town centre environment. Worse still, the area is not even the town centre.

Since the opening of the venue (as considered by para 15.3.1 of the Council's policy) there has been an increase in:

- Noise emanating from the premises included extended areas – there is no smoking area, and tables are outside on the pavement
- Noise, anti-social behaviour and other disturbances caused by persons leaving the premises.
- Urination in public places in the vicinity of the premises – notably the alleyway in Bakers Row and Stream Lane. It is understood there is little/insufficient lavatories provided at the premises.
- Congregation of persons from the premises – the entire corner of Penshurst Gardens and Station Road/Hale Lane is often blocked with people smoking
- Noise from vehicles driven by, delivering or collecting customers – there is little parking on or near the corner
- Litter – there has been a noticeable increase in litter, beer cans, bottles and cigarettes cleared from our front drive.

## The protection of children from harm

As parents of young and older children, we can see that our children are already exposed to smoking, drinking and disorderly behaviour at the corner of our road, meaning that there is essentially a 'blockade' effect for the residents. This is a common and well used route to and from residents houses especially over the Jewish Sabbath (Friday night and Saturday) when families will be exposed to increasing anti-social behaviour and hostile use of the outside of the premises. The use of such a venue as a nightclub is both culturally and religiously insensitive and also potentially a damaging environment to raise children for those who have chosen a quiet residential street in which to live. The character of the area will be negatively effected in this area of Edgware in a way that is potentially harmful to young and older children. The Council should pay heed to the direct negative impact of activities taking place at the licensed premises on both adults and children living in, working in or visiting the area concerned (para 3.3).

Finally, the requirement that alcohol be consumed with a meal, sitting down and before certain times clearly envisaged curtailing some of the problems that will arise by removing these restrictions. We feel that the acceptance of some terms, the partial opening and then re-application for a license under extended

37

terms is a cynical attempt to play the system. The application has been given very little publicity and the extension has been applied for by stealth in the knowledge that almost every resident would be appalled at how damaging the grant of the application would be for their quiet enjoyment of their local community. This is not an application sought for the good or demand of anyone in the local community.

I live this nightly and it is a nightclub and not a restaurant or bar as it says it is, because throughout the day, it is empty and when not, there is never more than 10 people maximum in there. But at night it is packed.

The issue at hand which I am informing you about is, for the last year in which this nightclub has been running, it has been playing loud music through to early hours. Frequently until 3am. This time last year or early January, I made a recording on my phone that had music from downstairs playing a 3 minutes past 4AM. It finally stopped at 5 minutes past 4AM on that occasion.

These days the volume is not as load as it was when it first opened a year back, but it its still unacceptable at 1am or 2am on weekends. The residents here or at least myself, under no circumstance willingly agreed to loud music through the night.

I have a metal Dimplex heater which stands in the centre of my room above this Nightclub. Frequently because of the volume it rings with the vibrations of the music beats through the floor below me.

I will not ever agree to having a club playing loud music well past midnight underneath me. People stand outside shouting and laughing and with me being directly above, it is seriously annoying. There seams to be no respect for the fact that the is club is directly under residential property, and therefore inform people to keep the noise down outside as well as within late at night.

I understand people need to party and thats not what I'm against or the venue. The music being so loud and going on past midnight well through to and past 3AM not just on the odd ocasion. As I said this has been going on since January.

You have to be up early for work so you ned to sleep, but you can't get off to sleep until half way through the night. Why should I have only a few hours sleep? I didn't ever agree to loud music below going on Thursday through to Sunday.

There is no way I can put up with this any longer. I have to have earplugs and headphones on

I am a Peshurst Gardens resident living relatively near Station Road and I am writing to object strongly to the latest application by the Hollywood Café to extend opening hours (Friday to Sunday) until 3am for live music and alcohol with a closing time of 3.30am.

This latest application causes me and my family much alarm and concern. It might be understandable if the Café was located in a bustling commercial hub but this unit stands a few metres from residential homes for the young and old on the corner of a quiet, leafy suburban street where residents go about their lives in a dignified and law-abiding manner. It is also a corner relied upon for access to the shops, station, restaurants and general amenities.

The Licensing Act created 4 licensing objectives which are the foundation of the licensing regime:

- the prevention of crime and disorder
- public safety
- the prevention of public nuisance
- the prevention of children from harm

All of these will be called into question should this extension be approved.

1. The prevention of crime and disorder.

The current licence seeks to curb disorderly behaviour by permitting alcohol to be served only with food. Yet the current application requests that alcohol be consumed on its own. Clearly, this is likely to attract those wishing to drink excessively, resulting in unsavoury behaviour which could extend beyond the Café onto side streets and beyond. This could lead to acts of criminal damage and/or violence and/or abuse of local residents. The Café might in time gain a 'reputation' attracting more unpalatable types to the neighbourhood.

2. Public Safety

With the possibility of drunken behaviour until so late at night this would put the public at risk of harm and disturbance. It might lead to theft, burglary, and verbal and physical abuse. Certainly, it would deter locals from leaving their homes at night for fear of being harmed and it would increase the feeling of insecurity for locals in their own homes, young and old alike.

3. The prevention of public nuisance.

There might well be an increase in noise levels with shouting, laughing, screaming and swearing during the night disturbing sleep for children, families and the old alike. For children to be in earshot of drunken

swearing is for me, completely unacceptable. In addition, those who have drunk excessively are likely to pee, leave litter, beer cans, half - consumed take- aways in gardens for us and our children to observe in the morning walking to the shops or school on Monday morning. This already happens, and is very likely to be exacerbated by the proposed extension.

4. The prevention of children from harm

As above – the likelihood of hearing and observing drunken behaviour, the possibility of being subjected to verbal and physical abuse by drunkards, learning from the wrong type of behaviour, and seeing the litter left behind would put our children at risk of harm.

With customers able to stay at the Cafe until closing time of 3.30am there is the possibility of people hanging around until at least 4am and beyond with groups walking up Peshurst Gardens and neighbouring roads to take the bus or just loitering.

The corner of Peshurst Gardens is simply not a suitable location for what is ostensibly a night club and I urge you to think carefully and consider this application with our children and local residents in mind.

I am very much concerned and raise my objections regarding the application by **Hollywood, 246 Station Road, London, HA8 7AU** for extension of opening hours and live music with sale of alcohol without any accompanying food to the latest **Variation application (dated 15/11/2017)** for the following reasons:

The opening of a bar/pub with late night opening without food will bring about a larger number of people into the area late at night and will lead to disturbance due to availability of alcohol and music and the way it will adversely affect the quality of life of local residents.

The venue, Hollywood is situated at the corner and entry street of Penshurst Gardens. This street has been a respected and reputable street ever since I have known about it and been a resident of it for some 33 years. People are attracted to move into and reside in this street with foremost opportunity they get due to the quiet cul-de-sac and living without fear of drunkards passing. There is a footbridge at the end of Penshurst Gardens and a lot of people living off Penshurst Gardens use the bridge as a short cut. We are worried about late night noise and disturbance caused by late night drinkers who pass our street. There has been incidents where drunk people have bumped on to our cars parked in the forecourt as well as beer cans and bottles dropped into the front garden/patio.

There are a number of elderly people living in Penshurst Gardens and as are other residents, are also worried and fear for their quality of life with prospect of sudden noise pollution/erratic behaviour from drunk passers by late at night.

Immediately the outside of the venue, already there is sign of pollution from smokers and drinkers and this is going to increase with extended hours and make passers-by feel uncomfortable to walk, by way of insecurity and hazardous smoke pollution, and often forced to walk in the road, to skirt the blockage in the narrow pavement. All in all extending the opening hours with sale of alcohol without food, would create a non-safe area and traffic hazard.

In addition, I personally have noticed that on many an occasion the cars are parked near immediate entry of Penshurst Gardens on double yellow lines and I have found it both nuisance and safety hazard driving into or even exiting from Penshurst gardens at about 12 midnight and this can be even more nuisance and safety hazard for resident drivers coming home late at night.

I pass by this venue at least four times a day and I have observed that most of the customers at Café Hollywood, 246 Station Road, are consuming alcohol/drinks without any accompanying food and this I believe is in contradiction to the current licencing agreement. I also have to avoid walking past the café due to smoke pollution and worried to walk this area late at night.

Dear Mr/Ms Pattenden,

As Chairman of the Berkeley Court R.A., I am writing on behalf of its 40+ residents to object to the extension of the license for the Hollywood Cafe which would allow it to provide alcohol and live music until 11 p.m. Monday - Thursday and until 3 a.m. Friday - Sunday.

Berkeley Court is situated in Hale lane, on the same side as the cafe, and only about 150 yards away. The majority of its residents are elderly and a number of them are from families that were forced to flee from Poland because of the virulent anti-Semitism which they suffered during and after the Second World War. There are also several younger families of ultra-Orthodox Jews with small children living there.

The residents are concerned because the cafe advertises itself to the Polish community in the area and further afield and based on their experiences with the clientele since it opened, they feel that permitting this extension would increase the stress which they have suffered from the remarks and behaviour when passing it (many of them understand Polish) and the noise which it is engendering until late at night.

We have already suffered more than once from finding individuals (presumably too inebriated to get home) sleeping in one of the doorways to the block, which is sheltered from the elements, and predict that this would be likely to increase if the cafe was allowed to stay open until Public Transport ended its normal time-table.

The music and other noise can be clearly heard, particularly during the summer months when our windows are open, and this interferes with the sleep of some of the very old and very young already, a problem which would certainly get worse if the application was allowed.

I would be happy to speak at the hearing if allowed to do so.

I am writing with regard to the application which has been made by Hollywood Café for a variation to their existing licence.

I **strongly object** to the application to vary their licence which would allow them to sell alcohol until 3am, play live music until 3am and keep the premises open until 3.30am.

Anyone who knows the area will be aware that Edgwarebury Lane / Heronsgate / Penshurst Gardens / Brook Avenue / St Margarets Road / The Drive / The Rise are all quiet residential roads.

For the same reasons that so many local residents objected to the original licensing, Hollywood Café has chosen to locate itself right in the middle of a quiet residential area, where it is ill-suited to operate the kind of establishment that Hollywood Café seeks to become.

Although the Hollywood Café has not been filled to capacity since it opened, it already causes a disproportionate detrimental effect on the surrounding area.

One of the concerns raised at the original licencing application meeting was that their outside tables and chairs extended well past the narrow strip which has the potential to fall under the freehold of the premises (although I asked for clarification on this, no evidence was ever presented to me that the landlord has any claim to use their outside strip) and thus blocks the pavement.

What has become even more of a problem is the regular cluster of smokers outside the front door of the establishment. They regularly block pedestrian access to the pavement.

This results in three significant problems:

- (1) Pedestrians are forced onto the edge of the pavement or even the road, which even though it is a relatively small roundabout, poses considerable danger
- (2) Anyone walking past is subject to a cloud of toxic smoke
- (3) As the café is predominantly patronised by men, it has proven to become an intimidating corner to navigate. Why should my young daughters be subjected to groups of men glaring at them?

We have also suffered from noise generated by patrons coming out of the establishment, as they walk along the road and all the inevitable litter which they leave along the road.

If this variation to the licence is granted, many of the local residents including myself are greatly concerned that the situation will significantly deteriorate.

It has been clear that the owners of Hollywood Café had always intended to turn their establishment into a late night destination. If this licence is granted, then as it will be open far later than any other local venue, it will inevitably attract even more people from outside the area, who will cause significant disruption to the quiet residential environment.

Although they may call themselves a 'Café', it is clear that they had always intended to be a bar / pub and now are clear that they want it to be more of a nightclub.

Whilst I do not object to someone setting up a bar, it should not be done in such close proximity to a quiet residential neighbourhood.

The management of the establishment have not shown any ability to control the actions or behaviour of their patrons who smoke and drink outside the building, so there can be no confidence that they would be able to control an even larger crowd of people who are more likely to be drunk and disruptive at 3.30am.

I am aware that objections need to be made in relation to your four criteria and have listed them below.

I will finish this email with two important points:

- (1) I do not know what level of monitoring the licencing team carry out after a licence has been granted, but the existing licence clearly states the condition that alcohol may only be served with a substantial table meal.

**Anyone who has walked past the venue has witnessed that this condition of the current licence has not been adhered to. I have never seen a 'substantial' meal served to anyone, only what looks like finger foods or small snacks. There are regularly drinkers sitting at tables with no food whatsoever. There are also people drinking whilst standing up in groups.**

If the management of Hollywood Café have no qualms about keeping to the conditions of their existing licence, then how can there be any justification for allowing them to extent their licenced hours and operating mode?

- (2) I do not believe that the Hollywood Café provided the proper level of notice about their new application: it was posted on an A4 sheet of paper with a small text size only suitable for close-up reading. The notice was posted on the door. This door is either covered with a security grille (see attached photo) or there are smokers standing in front of it.

There is a requirement for establishments to consult with neighbours and businesses, but putting a notice with small writing up on a door behind a security shutter cannot really be considered to be fair consultation. I only became aware of this application after a neighbour notified me about it.

**I would be grateful if you could please confirm receipt of this objection.**

### **Prevention of Crime and Disorder**

Any bar or club open until 3.30am will inevitably draw in larger numbers of visitors from a very wide area. This is because they are proposing a later closing time than any comparable venue in the area. Not only will visitors be attracted to the venue, but it will inevitably result in a large number of people hanging around the area. Unfortunately, music, alcohol and late night partying will usually attract the attention of less than savoury characters. Between the drunken visitors and those on the periphery, there will inevitably be severe disruption to the surrounding roads.

There is a reason why most Councils are very careful about where licenced premises can be located – they are usually concentrated away from residential areas and in places where the Police can closely monitor the activity outside the establishments.

We have witnessed visitors from the Hollywood Café urinate in the street, either round the corner on Penshurst Gardens or on the junction of Penshurst Gardens and Stream Lane. This is no doubt due to the totally inadequate provision of toilet facilities within Hollywood Café. Should they turn it into even more of a drinking establishment, there can be little doubt that public urination will only become more commonplace.

The premises has already attracted people who seemingly have purchased their own alcohol elsewhere, but drink outside, in the immediate proximity to the venue. This is a clear indication that any extension to the licence will only continue to have greater detrimental effects to the environment, outside of the direct control of the café management.

### **Public Safety**

There are regularly groups of smokers who congregate directly outside the front door of the Café. This creates a toxic and hazardous environment for anyone who walks past: as the Café is just down the road to the underground station, this directly affects a large number of residents returning home from work.

Secondly, the presence of groups outside the venue takes over the pavement and forces pedestrians onto the very edge of the pavement or even on the road. This creates significant potential for danger.

There is already a feeling amongst local residents that the corner of Hale Lane and Penshurst Gardens is an area to be avoided.

### **Prevention of Public Nuisance**

There is **already** a public nuisance, caused by the visitors to the café smoking and drinking outside. Any extension to their licensing hours will only result in even greater nuisance. Why should local residents have to ensure an even greater level of noise and disturbance from visitors leaving the establishment?

Even with the current closing hours, the noise, litter, congestion and disruption has become a problem.

With opening hours extended until 3.30am the venue will attract yet a different class of visitor, which will inevitably result in even greater disruption... How many people who go out drinking until 3.30am really care about the disruption they will cause after they leave the venue?

At the time of the original licensing, the Council were unwilling to address the issue of café tables spilling out over the pavement. Now the problem is far worse...

### **Protection of Children from Harm**

There is already a problem with children being harmed: there is smoking, drinking and leering of young females as they walk past.

I don't need to be able to translate the language they are speaking to know that they have used vulgar and hostile language whilst leering at my young daughters.

As long-time Edgware residents, this is unacceptable. It is completely insensitive to the local residents and not the environment we chose to bring up our children.

I have no issue with people partying and getting drunk until 3.30am, but this is just the wrong location for that to be happening. It needs to be away from residential areas and someone where the Police have the resources to regularly monitor the activity.

I am writing to object to the above application to extend the opening hours and alcohol licence to allow alcohol to be served without food and for extended times. The combination of the change in my view alters the use of the premises from a cafe to a bar/pub and nightclub. I object on the following grounds:

1/ Prevention of crime and disorder

The premises are on the edge of a residential area and is looking to lure a large number of people into this area. We are concerned that given the requirement to smoke outside there will be an increase of late night noise, violence will occur in this unregulated gathering space and broken glass and other litter will increase in the general area.

2/ Public safety

The cafe currently uses the outside space both for tables and as a smoking area, passing by this area is increasingly uncomfortable, increasing the number of people and increasing alcohol consumption increases the likelihood of confrontation and violence - I am especially worried for the safety of my daughter who needs to pass this area regularly. Extending the opening hours and increasing alcohol sales will make this already uncomfortable situation worse

3/ Prevention of Public Nuisance

We have noticed an increasing number of groups of people leaving the cafe in noisy groups at the weekend, extending the opening hours will make this noise nuisance occur in the early hours with the increased amount of alcohol making the groups more rowdy. Additionally the external space being used for smoking would mean that both the doors to the premises would open regularly allowing inside music to be heard and large groups outside the premises would create a significant amount of noise and litter. The extension of opening hours would conflict with the councils policy of providing a safe area

4/ Protection of children from harm

As stated above we have noticed large groups hanging around outside the restaurant smoking, this is creating an environment where children are scared of passing the corner of Penshurst Gardens and Station road. Children have both been forced to walk in the road or cross to the other side of the street as the public thoroughfare is blocked and they are scared of the individuals.

I strongly oppose this application for the following reasons:

There has been a considerable impact on public safety and a general nuisance

1. Since original license was approved Broken bottles, used condoms and rubbish are left on the pavement in and around the establishment - especially on the road on which I live. Granting this application will inevitably draw more of the same.
2. Groups of drunken, noisy youths congregate on the corner of Penshurst Gardens and St Margarets Rd continuing to drink once they have left the premises. At this time it is considered a risk to walk past them, especially females and children.
3. Groups of drunken, noisy youths frequently wake up my 7 year old child around closing time. Approving this ammendment will make it even more unfair to him and the other children in the neighbourhood.
3. I have observed fights outside my house that by people who frequent Hollywood. To grant this license will further risk the safety of the public and specifically local residents.
4. There has been a high increase in speeding traffic on St Margarets Road. This is mainly due to patrons searching for a place to park. (They are frequently in a 'loud' car)

In summary this establishment corners onto the family oriented residetial area of Edgware, especially St Margarets Road, Brook Avenue and Penshurst Gardens. It is simply unfair to impose such a nuisance and risk to safety by granting this license.

I refer to your email to Councillors Hart and Gordon dated 15/11/17 regarding the full variation of a premises license in respect of the above property.

There are 6 proposed variations including extended hours to sell alcohol, provide live music, play recorded music, late night refreshments, extended opening hours to the public and the removal of condition 17 restricting the supply of alcohol to only be supplied if consumed with "a substantial table meal".

I'm not sure if representation should be made in respect of each item but in general the application to extend the activities mentioned above until 03.00/03.30 hours cannot be conducive to the character of the surrounding area which is predominately residential. With alcohol being available until 03.00am (an extension of 5 hours on the current licence) there is every chance that it will attract customers from a wider catchment area with the result that local residents will experience disturbances as a result of increased vehicle movement (and parking will be an issue), people congregating on the pavement particularly those who wish to smoke and drink at the same time and from the decibel levels of live and/or recorded music as the door to the premises opens and closes.

Of course, it is not possible to quantify the amount of intoxication that could occur due to the extended alcohol hours but there are bound to be disturbances as a consequence.

There are a number of establishments in the Edgware Road that host such activities but they are not located in close proximity to residential dwellings.

I would urge the Licensing sub-committee to reject the application on the grounds that it would effectively create a night club with drinking hours that are far too long and hence make unwelcome disturbances to the immediate environs inevitable.

Anyway, that is not the reason for my email.

In my opinion, and according to the guidelines the council should follow in section 2.1 of the Barnet guidelines that I am sure you are more than familiar with, before granting a license the following points should be considered:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

When there used to be a pub a couple of metres away there was a high degree of public disorder and social unrest that resulted from excessive alcohol consumption without a meal. I am not sure why you or anybody else would believe that this would have any other result, and could be worse as the pub was not open until 3am. I fully support entrepreneurs making a living and providing a service to the community that will benefit everyone however having a nightclub in a residential area where the majority of residents are families with young families can have no positive outcome for anyone, including the council that will ultimately pick up the cost of policing it.

I am writing to you to raise my objection to the granting of a license for extended opening hours and the sale of alcohol without food to Hollywood, 246 Sation Road, London, HA8 7AU.

Allowing Hollywood cafe to extend their week end (Friday to Sunday) opening hours to 3am for music and alcohol will draw a large number of people to the area late at night. This will lead to congestion and parking problems in the area and the associated increase in noise. Undoubtably the people most affected will be the residents of Penshurst Gardens.

I have had people (after a night out) dropping litter on my front drive - generally drink cans and food litter. If the extended hours license is granted I fear it will increase the incidence of litter like beer cans and bottles.

Several years ago there used to be a pub called The Edge of Town on Station Road. I always felt uneasy and sometimes intimidating going past it on my way home from Edgware station late at night. There were often fights outside the pub as a result of late night drinking. After the pub closed down it has been much safer to walk home late at night from Edgware station. Allowing the consumption of alcohol until 3am on the corner of Penshurst Gardens I fear will lead to safety issues and increased risk of confrontation and possible violence. This will affect not only the residents of Penshurst Gardens but all the local community.

We write to express our objection to the above application.

When the original application (LAPRE 1/16/53288) was heard by the licensing sub-committee there were a considerable number of objections and whilst the sub-committee granted the application they did not agree to the extended hours put forward by the applicant. The extended hours of 3am for music, alcohol and refreshment and 3.30am for opening hours for members of the public now being put forward by the applicant in this application even go beyond those previously put forward by the applicant and which were rejected by the licensing sub-committee.

Moreover, the applicant is requesting the removal of Condition 17 namely "Alcohol only supplied when consumed before during and after the consumption of a substantial table meal".

Under the Council's current Statement of Licensing Policy it has a duty to prevent crime and disorder in the borough and will do all it can under the Environmental Protection Act 1990 to prevent nuisance, including noise. Although the premises are situated in Station Road, they are on the corner of Penshurst Gardens, an entirely residential road and very close to a considerable number of other residential roads in the surrounding area. In our view if the proposed variation were allowed noise, nuisance and disturbance would inevitably arise and the possibility of crime could not be excluded. The premises would in effect become a nightclub in a residential area and if customers are at liberty to drink alcohol until 3am in the morning we do not see how the council could be satisfied under the operating schedule of the statement of Licensing Policy that nuisance such as disturbance caused by customers arriving and leaving the premises, congregation of persons, noise and anti-social behaviour could be prevented by the effective management and operation of the licensed activities.

At the original application which took place only a year or so ago the Licensing sub-committee gave due consideration to the application and came to their decision after reading all the written submissions and hearing all the verbal objections at the hearing of the application. We are of the opinion that the sub-committee's decision was fair to both the applicant and the objectors and we do not think it is reasonable now for the applicant to be granted the extended hours it is requesting and we therefore confirm we are against the application.

Dear Mr Pattenden,

As an Edgware Ward councillor and someone who was intrinsically involved in taking forward objections from local residents against the original New Premises Application for the Hollywood, 246 Station Road, Edgware HA8 7 AU, I write to object - in the strongest possible terms - to this latest application under section 34 of the Licensing Act 2003 for a variation of a premises licence for the said premises.

My objections to each of the variations is as follows:-

**To change the sale of alcohol on the premises to 10:00hrs until 22:00hrs Monday to Thursday and to 10:00hrs until 03:00hrs Friday to Sunday.**

The existing restrictions on the timing of the sale of alcohol - whilst rather later than originally requested by affected local residents - have, to an extent, mitigated against the contrary effects of the availability of alcohol for public consumption - and the consequent threat of antisocial behaviour - at a premises situated at the entrance to a quiet, family orientated residential area. The surrounding residential roads are largely populated by families with young children as well as by a number of rather elderly vulnerable residents. Many of these local residents are also followers of particular faiths whose observance and enjoyment of their individual Sabbaths would be adversely affected by any extension of hours.

Unfortunately local residents and the Ward councillors well remember the history of antisocial and criminal behaviour from a former drinking establishment - which was actually a little further away from this corner - which became so unacceptable that it was actually closed down.

The consumption of alcohol late at night and the type of patron this availability attracts would inevitably lead to an increase in both drunkenness and rowdiness - all of it spilling onto the quiet neighbouring residential roads as patrons leave in the early hours of the morning. Even if some of the above behaviours could be avoided by the continuation of the other restrictions which the Applicant is seeking to have removed, there



would still be the problem of slamming car doors, loud chatter and laughter and general noise both from patrons arriving and leaving the premises.

**To change the provision of live music indoors only to 22:00hrs until 03:00hrs Friday to Sunday.**

**To change the provision of recorded music indoors only to 22:00hrs until 03:00hrs Friday to Sunday.**

There is always the difficulty of ensuring that the provision of live music indoors does not adversely impact on neighbouring properties – by its very nature the sound vibrates and travels. 12.30 am is just about manageable – any extension of that is not.

The same applies to recorded music which is generally very loud and throbbing and not of a background nature.

**To change the provision of late night refreshment indoors only to 23:00hrs until 03:00hrs Friday to Sunday.**

Objections to this proposal are very similar to those expressed with regard to the sale of alcohol – focussing on noise and disruption on arrival, inebriation, rowdiness and unacceptable behaviour on departure.

**To change the hours open to members of the public to 08:00hrs until 22:00hrs Monday to Thursday and to 08:00hrs until 03:30hrs Friday to Sunday.**

To have groups or even pairs of people leaving these premises at times up to and including 3.30 am with all the noise, disruption and rowdy and unacceptable behaviour that this would involve and the consequent deleterious effect on the quality of life of neighbouring residents is totally unacceptable. As mentioned previously the effect that this would have on residents' ability to observe and enjoy their own particular Sabbaths is particularly unpalatable.

**To remove condition 17 “ Alcohol will only supplied when consumed before, during and after the consumption of a substantial table meal”**

I believe that the imposition of condition 17 - which this variation seeks to remove – is one of the main reasons why local residents have not been subjected to the type of antisocial and criminal behaviour which led to the closing down of the previously mentioned drinking establishment a few doors further down Station Road. To remove this condition would allow the Hollywood to be turned into a Night Club/Late Night Drinking Establishment in what would be an entirely inappropriate location. Such

an establishment could attract a very undesirable element to a quiet, peaceful, family orientated residential area with the consequent threat to public safety, risk of crime and disorder and propensity to public nuisance.

In conclusion, as a Ward councillor, following the disallowance of the Alcohol Free Zone in this area, I already receive regular complaints from local residents about street drinking and what is perceived to be anti social behaviour. Added to this I am receiving frequent complaints of urination, smashed alcohol bottles, littering and dumped beer cans- many of the above taking place on private property. To allow **any** of the requested variations to the conditions of this Licence – which were imposed only after very careful consideration of all of the relevant factors by the Licensing Committee – could only exacerbate an already extremely difficult situation.

For all of the above reasons and for all of the reasons put forward by our absolutely devastated local residents, I urge the Licensing Committee – in the strongest terms possible – to reject the request for this Full Variation of a Premises Licence for the Hollywood 246 Station Road Edgware Middx HA8 7AU in its entirety.

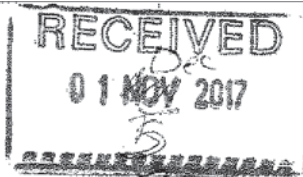
