Submitted by: Kadri Sayed Naved</p> <p>I am a resident on Park Road, Hendon and writing about my concern regarding vehicles (cars, vans and lorries) exceeding the speed limit once they have passed the Pedestrian Crossing. Traffic calming measures such as speed humps on the section of Park Road from the junction of Dartmouth Road to Bertram Road.</p>	<p>The Hendon Area Committee on 4 December 2017 approved a scheme to introduce a 20mph zone in Park Road and surrounding roads. 3.	<p>Petition: Proposed CPZ Scout Way, NW7 Submitted by: C De Lord on behalf of residents Signatures: 120</p> <p>The traders and residents of this complex strongly object to the implementation of this scheme. This service road was designed to provide access for the combine commercial and residential use as part of the planning requirement for the estate.</p> <p>As business rate and council tax payers we are disappointed that this proposed scheme should be introduced when we are experiencing difficult times and struggling to make ends meet. Customers will go elsewhere such as the Broadwalk Centre in Edgware and Borehamwood where there is free parking.</p> <p>Here are some other examples that would be affected:</p> <ol style="list-style-type: none"> <li>Business – delivers, loading and unloading goods throughout the day.</li> <li>Parking for staff and customers.</li> <li>Children’s Nursery – twice a day dropping and collecting children.</li> <li>Residents senior citizens, relatives, friends and visitors.</li> <li>Tradesmen working on individual properties with no off street parking.</li> </ol>	<p>To be dealt with in line with the Council’s constitution:</p> <p>The Lead Petitioner will be given three minutes to present the petition to the Forum.
