| 1. | Residents Parking at Montrose, Dudley and Clarendon Courts   |          |
|    | Since the change from meters to telephone parking, the three pavement sections of these blocks of flats are not used during the restricted time period, thus incurring lost revenue for the council. I have monitored these three sections daily and it is clear shoppers are not parking here any more. There is adequate parking opposite for users of Topps Tiles, Kwik Fit and the businesses leading to North Circular. |          |
|    | I have completed a survey of all fifty-five flats and nine have expressed an interest in Residents' Parking Permits. It seems that Residents Parking in front of the blocks would be sufficient to resolve the issue, possibly Dudley and Clarendon Courts.  |          |
|    | One of the biggest problems residents face is parked cars in the private driveway behind Montrose and Clarendon Court, where the garage is located. For those who have a garage, it is intensely annoying and very inconvenient to find a car or van blocking you in or out. This happens on a regular basis in spite of large "No Parking" signs on the relevant garage door.   |          |

|    | 2. There are 55 flats in Dudley, Montrose and Clarendon Courts and effectively no parking area at all for the residents, except for a driveway in front of Dudley for a few cars. So, unless like me you are paying for a garage, there is nowhere for residents to park other than by meter or in surrounding side roads, which is difficult for residents with small children. |          |
|    | 3. The biggest battle is with visitors who think they have every right to park at the back of the flats in front of the garages. There is one couple, who attended last night from Dudley Court, who need their car every day. The car needs to be accessible at all times and was once blocked in for two weeks by a car whose owner had gone on holiday.                       |          |

| 5. | In the last three months or so, there have been three more accidents in Squires Lane near the junction with Avondale/Etchingham Park Road, including one in which a car crashed into the crossing, ending up on the pavement across the road some distance away, destroying a telephone pole which came crashing down into the front garden of a resident's house. It was nothing short of miraculous that no one was badly hurt. This blackspot is next to a primary school and nursery. There have been countless accidents in this area, including a fatal one outside my own house. | 7. | The sign regarding East Finchley Neighbourhood Centre (EFNC) located on the High Road, East Finchley, near Martin School has still not been removed; please advise when this will be dealt with as its several months since I brought this to your attention. I assume the same sign located on East End Road at top end of Church Lane has also not been removed.   |          |

| 8. | Damaged brick wall bordering the Garden of Hope on East End Road - despite months of exchanges of emails and being referred to Transport for London (TfL), whose responsibility it is to rectify the damage, the latest email dated 19 December 2012 from the Borough Engagement Manager (North) TfL advised "The brick section will be rebuilt by Friday 21 December as previously advised. However, the TfL contractor undertaking the works has encountered a problem sourcing the matching coping stones, the blue grey colour is apparently a "special order". Therefore, the fitting of the coping stones will not be undertaken until the end of the second week in January when all aspects of the work will then be completed." |          |
|    | Please note that the brick section was not rebuilt by 21 December and as it is approaching the end of the second week in January, I have today checked the brick wall and not only is it still in its original damaged state, without any brickwork done either to the bricks or the coping stones, but additional bricks in the wall have deteriorated.   |          |

| 9.  | A carpet shop has recently re-opened at 85 East End Road and after approximately 18 months of major excavation and renovations, the pavement outside this shop requires attention to ensure the pavement stones are level and there is also a section of the pavement which has been badly concreted leaving an uneven surface, all of which contributes to a lack of health and safety especially for disabled and visually impaired people, whom I know live in the nearby area and would use this pavement. | 10. | Usage of The Vale by PB Donoghue skips and other lorries - The noise and vibration from the skips and lorries is significant, causing vibration <i>inside</i> the house. The articulated lorries are very large, heavily laden and long adding to the level of noise and vibration. Sometimes the skips and lorries park on The Vale with the engine running presumably waiting for a call to say they can access the yard. The problem starts early in the morning six days a week. More importantly, it is still vacant and unsold while thousands of homeless families in Barnet wait in vain for accommodation. |          |
