3	Parking problems in Richmond Gardens NW4Residents have request that the Council introduce a CPZ in Richmond Gardens for 1 hour during weekdays.	Council Officers have been made aware of parking congestion in the Richmond Gardens/Endersleigh Gardens area, and of the problems encountered by residents and the council's Refuse Team who either wish to park or who are unable to gain safe and adequate access through the area.
	Ms Levy	Following the parking issues being highlighted at the last Hendon Area Resident Forum, a Council Officer met with a local resident and a West Hendon Ward Councillor in Richmond Gardens to observe and discuss the problems being experienced, and as a result it is understood that the majority of vehicles parking in the roads in this area may not belong to residents, but to local employees, students and commuters.
		At the meeting it was agreed that Officers would consider the possibility of introducing measures to initially address the immediate safety and access concerns, and as such following investigation Officers intend to propose certain lengths of waiting restrictions in Richmond Gardens, Endersleigh Gardens and Colindeep Gardens although it is acknowledged that the introduction of waiting restrictions would restrict available kerbside space in these roads further. The proposals are still subject to the councils internal consultation processes, including consultation with Ward Councillors, however, should approval be granted to proceed with the proposals there would be a statutory public consultation which would be carried out, which assuming a satisfactory outcome to the internal consultation, Officers would anticipate being carried out in September this year.
		At this time the council do not have any plans to investigate the possible introduction of a CPZ in Richmond Gardens or its surrounding area and it should be noted that investigations into CPZs are generally carried out on an area wide basis rather than on an individual road basis and are generally only considered in areas where there is significant known local support of such

		Although the petition indicates some support in Richmond Gardens, it is considered unfeasible to investigate whether a CPZ could be introduced in this road in isolation, with no or little regard for neighbouring roads, whose current opinions are unknown although they may have similar issues, or would be impacted from any action taken in Richmond Gardens.

		I visited the location as indicated in my original reply – Our past monitoring resulted in the removal of a number of Street litter bins from the general location due to the encouragement of Fly-tipping and the lack of use for public litter, this resulted in an ineffective absorption of resources. Their removal greatly reduced this problem. The location receives a 6weekly Cleanse, Town Centre Support and regular street litter bins, with additional attention by our Hotspot crew. We are of the opinion that additional bins will not address the anti-social behaviour and at this stage we will continue to monitor this issue and action where required.
