In Barnet all children who want to have a place are made an offer of one.</p> <p>To ensure parents are aware of the availability of free places all eligible parents are written to and outreach and brokerage staff have face to face discussions with parents in children's centres, community venues and shopping centres. Partners such as health and schools also promote the free places. There is a marketing campaign in place including posters and leaflets in places families attend such as libraries, health centres, schools and public transport, as well as online publicity. Validated datasets are expected to be released by the DfE between December 2015 and January 2016 and an update to all Councillors will be provided when these are available.</p> <p>The unvalidated results indicate that the proportion of pupils in Barnet schools who attained 5 A*-C grades including English and Maths this year is 68.8%. This is 1.3 percentage points above the 2014 validated data and is expected to increase once validated data is available. It is already above the national average for state funded schools in 2014 (56.8% - validated data).
