## SUPPLEMENTAL REPORT OF THE DEMOCRATIC SERVICES MANAGER

## 7. Representation of the Council on Outside Bodies

Barnet Care Attendant Scheme Management Committee has changed its name and drawn up a revised governing document, as a result of which Council representation is no longer required. Therefore, the vacancies relating to this organisation on Appendix A to my report no longer require to be filled.

Recommend: That the Council notes that Council representation on Barnet Care Attendant Scheme Management Committee is no longer required.
8. Appointment of Standing Committees and a Chairman and Vice Chairman for each Standing Committee

## Introduction

Council on 26 October, 2004, when approving the establishment of a Licensing Committee, agreed to reduce the number of Appeals Committees to one, with effect from the 2005 Annual Meeting.

The Council also on 12 April, 2005, agreed, with effect from the Annual Meeting to
(i) restructure the Overview and Scrutiny Committees into six Overview and Scrutiny Committees; and
(ii) introduce a new Audit Committee

Political Balance : Background
The Council must allocate seats on committees and other prescribed bodies so as to give effect to the political balance rules under the Local Government and Housing Act 1989.

The political proportionality rules also apply to those outside bodies dealing with local government matters to which the council appoints three or more representatives. They therefore apply to the Welsh Harp Joint Consultative Committee. The calculation indicates that the allocation must be two Conservative and two Labour. However, the Welsh Harp Joint Consultative Committee is not included in the calculation relating to achieving political balance.

The Council appoints or nominates members to a variety of special statutory bodies, or informal or consultative bodies that are not council committees or sub-committees. The political balance rules do not apply to these bodies.

The consultative bodies established for consultation with staff are also not regarded as council committees subject to the political balance rules. Each has a special composition.

The Regulations provide an exception from the political balance requirements where a committee is established to discharge functions in part of an authority's area, and
(a) consists entirely of members elected for wards which comprise the area, and
(b) either the area or its population does not exceed two-fifths of the total for the authority.

This allows the six area planning and environment sub-committees to be constituted on a ward member basis and still comply with the law.

The political group with the majority of seats on the council is entitled to a majority of seats on all the relevant Committees.

## Achieving Political Balance

The political balance calculations are based on the following political split. :
Conservatives :33
Labour : 24
Liberal Democrat : 6

However, in determining political balance for 2005/06, the issues set out in the introduction to this item must be borne in mjnd.

With that in mind, the Special Committee (Constitution Review), met on 11 May to consider the issues. Details of the members' attending the meeting and a synopsis of the their considerations are set out in Appendix 1.

The Special Committee (Constitution Review) agreed to recommend the Council to adopt the model set out in Appendix B to achieve political balance. The Committee noted that the Labour Group had indicated that their support of this model was conditional upon a member of that Group chairing the Appeals Committee to reflect their majority on that Committee.

Recommendations have still to be made as to the Overview and Scrutiny Committee that will comprise ten members.

As far as the appointment of substitutes are concerned, the Council on 20 April, 2004, agreed to the appointment of two substitutes for each political group for certain committees and Overview and Scrutiny Committees. It, is therefore recommended that this principle also applies to the new Audit Committee.

Appendix C also identifies all of the other Council Committees and Panels and their compositions.

Appendix $D$ identifies the bodies to which the political balance calculations do not apply.

The Group Secretaries have been advised of the situation.
Recommend:
(1) That on the basis that the Council is made up of 63 members comprising three political groups (Conservative 33 members, Labour 24 members, Liberal Democrat 6 members), the allocation of seats on committees subject to the political balance regulations be as set out in Appendix B.
(2) That the allocation of seats on Committees and other bodies appointed by the Council and on sub - committees and other bodies appointed by council committees should be in accordance with Appendices C and D
(3) That the principle of establishing the appointment of two substitutes for each political group be applied to the Audit Committee.
(4) That each political group be invited to nominate members for seats in accordance with the principles set out in (1), (2) and (3) above and the allocations set out in Appendices C and D, and that the Council and Council committees appoint committees, sub - committees and other relevant bodies in accordance with those principles and allocations, subject to the Council's final decision as to the Overview and Scrutiny Committee that will comprise the 10 - member Committee.

Non-Council Members of Committees and other Bodies - Nominations
Nominations have been sought for Non-Council Members of Committees and other bodies as indicated below:

First Class Education and Children Overview and Scrutiny Committee
The Council on 13 May, 2003, agreed that with effect from 2004/2005 the period of appointments of voluntary school representatives on the then Education and Children Overview and Scrutiny Committee be for a period of two years.

It is proposes the appointments made on 18 May, 2004, continue for the First Class Education and Children Overview and Scrutiny Committee for the period 2005/2006.

Recommend : That the following be appointed to serve as voting voluntary - aided school representatives on the First Class Education and Children Overview and Scrutiny Committee for 2005/2006 : -
(i)Mr Denis Carey, representative of the Roman Catholic Church;
(ii)Ms Cathy Goldin, representative of the Persons who Appoint Foundation Governors to Voluntary Aided Jewish Schools ; and (iii) Ms Gladys Vendy representative of the Church of England.

## Tackling Crime and Housing Overview and Scrutiny Committee

The Constitution provides for two non - voting co-opted tenant representatives to be appointed to this Committee. The Council, on 21 October, 2003, agreed that these appointments should be made by the Barnet Housing Consultative Panel.

Recommend : That the two non - voting co-opted tenant representatives on the Housing Overview and Scrutiny Committee for 2005/2006 be appointed by the Barnet Housing Consultative Panel.

Independent Members of the Standards Committee
The Council at their Annual Meeting on 14 May 2002 appointed four independent people to serve on the Standards Committee, one of whom was appointed as Chairman. Two of the Members subsequently stood down and the Council, on 1 March appointed Mr Stephen Ross to that Committee with immediate effect and Mrs Susan Riddle with effect from 17 May, 2005.

The independent people have all their confirmed their willingness to continue,

## Recommend:

(1) That, Ms Marguerite Argles, JP, Reverend Berndt Koschland, Mrs Susan Riddle and Mr Stephen Ross be appointed to serve as Independent Persons on the Standards Committee for the municipal year 2005/2006.
(2) That Reverend Berndt Koschland be appointed Chairman and Ms Marguerite Argles JP be appointed Vice-Chairman for the municipal year 2005/2006.
9. Calendar of meetings 2005/06

Item 13.4.5 of my report refers to a revised Calendar of meetings for Committees, Sub - Committees, Panels. forums, etc

Since the revised calendar was circulated, one or two anomalies have come to light.

Therefore, the amendments set out in the recommendation are also for the Council's consideration.

Recommend- That the Calendar of meetings, as amended by the following be approved:

- Alter Teaching JNCC from 23 June to 21 June, 2005
- Alter Tackling Crime and Housing Overview and Scrutiny Committee from 9 June to 27 June, 2005
- Alter First Class Education and Children Overview and Scrutiny Committee from 28 June to 30 June, 2005.
- Alter Audit Committee from 31 October to 10 October - to ensure that all legislation relating to the SAS610 report from the Auditors can be complied with.

Item 3 of the Agenda for this meeting relates to Minutes of the meeting held on 12 April.

Minute 200 relates to Questions to Cabinet Members. Set out below is the complete Supplemental Question 31.
"There is so much waste of cardboard and plastics in the bins. If somebody is able to do something to use it, whereby the council would then increase its recycling rate and help the environment, then that's for the good and that's why I put the question. There has to be some time when this council will have to look at what other boroughs do to recycle plastics and cardboard. So what's wrong with Barnet doing just that and reviewing this? Thank you."

Recommend - That subject to the Council's decisions on the proposed membership of Committees and Sub - Committees and on the Overview and Scrutiny Committee that will comprise ten members the amendments to the Constitution as set out in Appendices E and F be approved.
