## 4. Appointment of Standing Committees and a Chairman and Vice Chairman for each Standing Committee

## Political Balance : Background

The Council must allocate seats on committees and other prescribed bodies so as to give effect to the political balance rules under the Local Government and Housing Act 1989.

The political proportionality rules also apply to those outside bodies dealing with local government matters to which the council appoints three or more representatives. They therefore apply to the Welsh Harp Joint Consultative Committee. The calculation indicates that the allocation must be three Conservative and one Labour. However, the Welsh Harp Joint Consultative Committee is not included in the calculation relating to achieving political balance.

The Council appoints or nominates members to a variety of special statutory bodies, or informal or consultative bodies that are not council committees or sub-committees. The political balance rules do not apply to these bodies.

The consultative bodies established for consultation with staff are also not regarded as council committees subject to the political balance rules. Each has a special composition.

The Regulations provide an exception from the political balance requirements where a committee is established to discharge functions in part of an authority's area, and
(a) consists entirely of members elected for wards which comprise the area, and
(b) either the area or its population does not exceed two-fifths of the total for the authority.

This allows the six area planning and environment sub-committees to be constituted on a ward member basis and still comply with the law.

The political group with the majority of seats on the council is entitled to a majority of seats on all the relevant Committees.
(a) Determine the split between the political groups on the Council. This gives:
Conservative $37=58.73 \%$
Labour $\quad 20=31.75 \%$
Liberal Democrat $6=9.52 \%$
(b) Allocate the total number of seats on 'ordinary committees' in the proportions shown in (a).
(c) Allocate seats on each committee to match the totals in (b), endeavouring to ensure that each committee has the rough balance identified in (a).
(d) Allocate seats on other committees and sub-committees as far as possible to make the political balance identified in (a) above, but without the requirement to check the balance on the numbers of seats in total.
'Ordinary committees' has a special statutory meaning. It only includes committees that have delegated powers to discharge the council's statutory functions. It does not include informal bodies that are not committees. The total number of seats on ordinary committees is 80 . Given the distribution of membership between the political groups on the Council it is not possible to achieve the required political balance under the current Constitution. To achieve the required balance it is necessary to increase the number of seats on the all the Overview and Scrutiny Committees, other than Cabinet Overview and Scrutiny Committee, and on Appeals Committee 1 from 6 to 10, and on the General Functions Committee from 6 to 7 . The political proportionality rules do not apply to the Standards Committee or to the appointment of the Cabinet under the Council's Constitution.

Taking the calculations based on the political split described above, the allocation of seats on ordinary committees is set out in Appendix B. The total allocation of seats on ordinary committees is:-

62 Conservative<br>33 Labour<br>10 Liberal Democrat

Appendix C also identifies all of the other Council Committees and Panels and their compositions.

The Group Secretaries have been advised of the situation.

## Recommend:

(1) That on the basis that the Council is made up of 63 members comprising three political groups (Conservative 37 members, Labour 20 members, Liberal Democrat 6 members), the
allocation of seats on committees subject to the political balance regulations be as set out in Appendix B.
(2) That the allocation of seats on Committees and other bodies appointed by the Council and on sub - committees and other bodies appointed by council committees should be in accordance with Appendix C.
(3) That each political group be invited to nominate members for seats in accordance with the principles set out in (1) and (2) above and the allocations set out in Appendices B and C, and that the Council and Council committees appoint committees, sub - committees and other relevant bodies in accordance with those principles and allocations. Nominations are set out in Appendix E.
(4) That the Council's Constitution be amended to incorporate the changes in the numbers of seats on committees set out above.

Non-Council Members of Committees and other Bodies - Nominations
Nominations have been sought for Non-Council Members of Committees and other bodies as indicated below:

First Class Education and Children Overview and Scrutiny Committee
The Council on 13 May, 2003, agreed that with effect from 2004/2005 the period of appointments of voluntary aided school representatives on the then Education and Children Overview and Scrutiny Committee be for a period of two years.

Nominations so far received for 2006/2008 are set out in Appendix D. Council
RECOMMEND : That the following be appointed to serve as voting voluntary - aided school representatives on the Education and Children Overview and Scrutiny Committee for 2006/2008 : -
(i) Mr Denis Carey;
(ii) one representative of the Persons who Appoint Foundation

Governors to Voluntary Aided Jewish Schools
(iii) one representative of the Church of England, to be nominated by the London Diocesan Board.

Tackling Crime and Housing Overview and Scrutiny Committee
The Constitution provides for two non - voting co-opted tenant representatives to be appointed to this Committee. The Council, on 21 October, 2003, agreed that these appointments should be made by the Barnet Housing Consultative Panel.

Recommend : That the two non - voting co-opted tenant representatives on the Housing Overview and Scrutiny Committee for 2006/2007 be appointed by the Barnet Housing Consultative Panel.

Independent Members of the Standards Committee
The Council at their Annual Meeting on 14 May 2002 appointed four independent people to serve on the Standards Committee, one of whom was appointed as Chairman. Two of the Members subsequently stood down and the Council, on 1 March 2005 appointed Mr Stephen Ross to that Committee with immediate effect and Mrs Susan Riddle with effect from 17 May, 2005.

The independent people have all their confirmed their willingness to continue,

## Recommend:

(1) That, Ms Marguerite Argles, JP, Reverend Berndt Koschland, Mrs Susan Riddle and Mr Stephen Ross be appointed to serve as Independent Persons on the Standards Committee for the municipal year 2006/2007.
(2) That Reverend Berndt Koschland be appointed Chairman and Ms Marguerite Argles JP be appointed Vice-Chairman for the municipal year 2006/2007.
5. Representation of the Council on Outside Bodies.

Since the Local Elections on May 4 2006, a review of the Council's representation on outside bodies has taken place. Vacancies have arisen as a result of requirements for the positions to be occupied by current members of the Council.

Appendix D lists in bold the vacancies arising on outside bodies as a result of these requirements. There are also two vacancies as a result of the deletion of two senior officer posts.

The Group Secretaries have been advised of the vacancies.

## RECOMMEND:

1. That the Council make appointments to fill the vacancies reported.

## 6. Chief Officer Appointment Panel for Chief Executive's Annual Appraisal

A Chief Officer Appointment Panel is required to carry out the remaining target-setting element of the Chief Executive's annual appraisal.

The Panel previously constituted comprised the following six members (3 Conservative, 2 Labour and 1 Liberal Democrat) with two substitutes from each Group:

7. Representation of the Council on Threshold Housing Advice (formerly known as Barnet Housing Aid Centre)

The Council are asked to note that Threshold Housing Advice has taken over Barnet Housing Aid Centre, and as the Council's relationship with Threshold is purely on a commercial basis, Council representations on the organisation, which is listed on Appendix $A$, is not required.

The Group Secretaries have been advised of the change.

## Recommend:

The Council note that appointments to Threshold Housing Advice are no longer required.
8. Agenda item 8 : Appointment of Leader of the Opposition - Leader of the largest political group other than the Group of which the Leader of the Council is a Member.

The Labour Group is the second largest political group represented on the Council and have advised me that Councillor Alison Moore is the leader of that Group.

As a consequence, in accordance with the Constitution, Councillor Alison Moore has been appointed Leader of the Opposition.
