#### 1. MINUTES

The minutes of the meeting held on 10 November 2005 were approved.

#### 2. APOLOGIES FOR ABSENCE:

All members were present.

#### 3. DECLARATION OF MEMBERS' PERSONAL AND PREJUDICIAL INTERESTS:

Members declared the following interests set out below:

## 4. URGENT ITEM - BARNET FOOTBALL AND BARNET CRICKET CLUB, BARNET LANE (Report of the Cabinet Member for Resources—Agenda Item 9)

Because The Barnet Club Limited have indicated that they are intending to commence building work on Council property on 9 January 2006, the Chairman agreed pursuant to section 100B (4) (b) of the Local Government Act 1972 that this item be considered as a matter of urgency.

The Committee noted an email exchange between Mr Kleanthous and Mr Graham Beattie, the Council's Director for Environment.

With the agreement of the Chairman, Mr Andrew Markey and Mr Mike Dawson addressed the Committee expressing that consent should not be given for the work proposals by The Barnet Club Limited.

#### 5. MOTION TO EXCLUDE THE PRESS AND PUBLIC: -

#### RESOLVED -

- 1. That subject to the provision of the required additional information, officers process the application by Barnet Club Limited in line with normal Council procedures and report back to this Committee at the earliest possible opportunity.
- 2. That The Barnet Club Limited and Barnet Football Club and their associated companies be advised of the manner in which the Council proposes to deal with this application and that under no circumstances should any works commence in advance of all necessary consents and agreement of terms being in place.
- 3. That subject to 1 and 2 above, compliance with section 123 of the Local Government Act 1972, the obtaining of all necessary consents and agreement of valuations and terms, the Council agree in principle to the disposal of the open space land on a long lease to The Barnet Club Limited, co-terminus with their existing lease.
- 4. That an independent firm of property valuers be appointed to advise on the best consideration arising from the proposals and subject to that, the valuers be instructed to negotiate with The Barnet Club Limited and Barnet Football Club to secure the best consideration for the Council.
- 5. That officers be instructed to take all legal steps necessary to ensure that works are not commenced until all consents and agreements are obtained and that an injunction be prepared ready to go out if the work commences.

6. That legal works for any consents and agreements be carried out by a third party firm of solicitors and that costs be recouped from Barnet Football Club and Barnet Cricket Club.

### 7. REVENUE MONITORING 2005/06 (Report of the Cabinet Member for Resources – Agenda Item 4)

  - a. Net slippage from 2004/05 of £4.973m is added to the current approved 2005/06 budget of £47.456m to give a total budget of £52.429m.
  - b. An increase of £0.150m in the 2005/06 budget for Frith Manor on the basis that the expenditure is fully funded by school contribution.
  - c. An increase of £0.550m in the capitalised redundancies budget and an increase of £0.429m in the Pericles budget for 2005/6.

This will increase the non-housing capital programme by £6.102m to give a total of £53.558m
