1	57 signature petition protesting at the proposal of charging for street trading licenses. The proposal from the London Borough of Barnet to charge an additional fee to trade is unanimously rejected and request that this unwarranted charge is reconsidered. (Regeneration & Enhancement in East Finchley)	On 21 st February 2008 Cabinet approved the implementation of a new street trading policy. The last time street trading was addressed by the Council was in 1988. Since then the incidences of businesses using the public highway as additional commercial space has increased, especially since the introduction of the smoking ban, leading to increased public nuisance such as obstruction and noise. 		The London Local Authorities Act 1990 (as amended) provides a statutory framework whereby the Council can regulate the street scene and manage any problems that may arise. The London Local Authorities Act 1990 states 'it shall be unlawful for any person to engage in street trading unless that person is authorised to do so by a street trading licence or a temporary licence'.	
		 Section 32 of the Act allows for fees to be set for the grant, renewal and variation of a licence. Such charges may be used to cover the costs of: Collection, removal and disposal of refuse Cleansing of streets attributable to street trading Administrative costs Enforcement costs The Council may only recover from licence holders the reasonable costs incurred to deliver the above. The fees that have been set will be reviewed to ensure that the reasonable costs of administering and enforcing the regime are met following initial implementation.

However, as of June 11 2008, the sign is still there.	It is the responsibility of the Police to remove the 'Neighbourhood Watch' sign. 3	Temple Fortune Hill & Asmuns Hill NW11 - Temple Fortune Hill. Willifield Way NW11 -Resurfacing - Speed danger along Willifield Way due to resurfacing works and the removal of speed tables and mini - roundabout at the Willifield Way / Asmuns Hill junction.	The Council removes carriageway features such as humps / tables as part of taking up the old road surface. Traffic movements are currently being monitored together with an appraisal of the views received from residents, local ward councillors and the emergency services. A decision on whether to maintain the current arrangements or introduce measures to influence movement behaviour will be made by the Lead Member for Environment & Transport within the next month. 4	Recommendation of an installation of a sound coordinated crossing equipment for blind pedestrians to cross the road on a T junction at the Ossulton Way / East End Road junction. There is only a partial traffic light on one side of the road. This needs to be changed as there are blind people living in the immediate area.	There is a small device placed underneath the pedestrian crossing push button panel. After pressing the button on the machine, a resident can place their fingers on the cone underneath the push button boxes. When it is safe to cross the road, the cone will start to spin indicating to the pedestrian that it is safe to cross the road.	No update necessary
5	At the Finchley & Golders Green Area Planning Sub Committee meeting on 6th May 2008, the officer presenting the report on 1-3 Sandringham Gardens, N12 ONY (C17302/A/08) was heard to state that the properties were within the "North Finchley Town Centre envelope" and that this was a justification for their demolition and the redevelopment of the site to provide the flatted	The officer did not refer to a "North Centre Town Centre envelope" but referred to the fact that the application site was in close proximity to the North Finchley Town Centre. 6	Request to suspend or modify Temple Fortune CPZ (excluding Asmuns Place) *Hampstead Way From Finchley Road to Asmuns Hill NW11	The Temple Fortune CPZ was introduced only after extensive consultation with the local community which included informal as well as statutory consultations before its introduction in addition to a follow up satisfaction survey in June 2006 after the scheme had been introduced. Heavily influenced by the responses to the follow up survey which included properties both inside and outside of the CPZ boundaries, the Council decided that the principles of the scheme were justified and that it should be made permanent. In making this decision the Council accepted that it is inevitable that the introduction of parking restrictions, either localised or on an area wide basis will not be accepted by all but considered that the benefits of the scheme, evidenced through the responses to the consultations, and the traffic management advantages in the area outweighed any concerns that have been expressed by some members of the community. The Council has an established programme of reviewing its CPZs where the opportunity is given via a questionnaire being delivered to all properties within a CPZ allowing occupants the opportunity to inform the Council of their views relating to their particular CPZ and what changes they might wish made.
