## 1.0 Summary

- 1.1 This report presents progress on the Brent Reservoir / Welsh Harp Management Plan and related issues. The Management Plan is a joint Management Plan between the three main land-holding and land-managing organisations in the vicinity: Brent Council, British Waterways, and the London Borough of Barnet.

## 2.0 Recommendations

- 2.1 Members are asked to note the Report.

## 3.0 Detail

### Welsh Harp Management Plan

- 3.1 The Welsh Harp / Brent Reservoir Management Plan is administered by officers of the land owning and land managing organisations. An annual review is undertaken in approximately July each year, and then reported to Committee for the Committee's recommendations. Since 2001, officers have included in the Management Plan process the additional responsibilities of the Countryside and Rights of Way Act 2000 to produce Management Plans for Sites of Special Scientific Interest (SSSI).
- 3.2 The Management Plan was signed by English Nature (now Natural England) on 15 May 2003. Subsequent amendments have been reported to this Committee. Natural England have indicated that for minor changes to the Management Plan, there is no need to seek their formal consent.

- 3.3 The most recent re-drafting of the Management Plan was completed in early 2006; and that version will serve until the next review in 2007. The current version of the Management Plan is available on the internet at [www.Brent.gov.uk/parks](http://www.Brent.gov.uk/parks) (from there go to the 'Brent Biodiversity Action Plan homepage and then navigate via the Brent Reservoir Action Plan). A map of the zones is also provided on the internet; and a copy of the map is also attached to this report.

#### **Management works**

- 3.4 Marshland conservation: Coppicing of willow and other tree growth in the marshland strip was undertaken, as programmed, on the southern side of the Reservoir (Neasden Recreation Ground) in early 2007.

#### **Dam wall works**

- 3.5 British Waterways have substantially completed their works to the dam wall. However, the reinstatement work at Neasden Recreation Ground, which was used by British Waterways as a work site, has taken longer than anticipated. The remaining work is now programmed to be undertaken from mid-April 2007.

#### **Cross-boundary working and enforcement**

- 3.6 A pollution incident which involved waste tipping and other pollution in the woodland area on British Waterways land on the south side of the Reservoir to the north of the North Circular Road Industrial Estate (zone 4C) was raised at the previous WHJCC meeting. Following joint site meetings with the Environment Agency, British Waterways and Brent Council, the Environment Agency are leading on the investigations. British Waterways are leading on the clear-up of the existing waste; works which will be phased over three years.

#### **Green Flag Award application**

- 3.7 Green Flag: Brent Council Parks Service has submitted an application for the Green Flag Award 2007/08 for the Welsh Harp Open Space.

The Green Flag Award is a national scheme with the aim of improving the standards of green spaces and is maintained by annual external inspection. The Green Flag Award particularly considers whether the green space is welcoming, addresses health and safety, cleanliness and maintenance, sustainability, conservation, and whether there is community involvement in the management of the green space.

Work had begun to improve access throughout the open space. This includes repairing pathways, path edges and cutting back overgrown brambles. The site will have additional directional signage, new seats and bins installed and the interpretative panels at the look-out area will be refurbished.

#### **Biodiversity Action Plan**

- 3.8 Brent Biodiversity Action Plan: Brent Council is currently reviewing the Borough Biodiversity Action Plan with a view to a revised Biodiversity Action Plan for the years 2007-2010.

#### **Heritage Lottery Award**

- 3.9 Maintenance of the Heritage Lottery Fund award project continues.

- 3.10 Kingsbury and Welsh Harp Reservoir Open Day  
The annual Kingsbury and Welsh Harp Reservoir Open Day will be held on Spring Bank Holiday Monday 28 May 2007.

#### **4.0 Financial Implications**

- 4.1 None specific, but some of the priorities identified in the Management Plan will require additional resources if they are to be implemented in the future. For Brent Council Parks Service, the Management Plan is implemented and improvements programmed via the Brent Parks Service Parks Strategy, and Service Plan; both of which derive from the Council's Corporate Strategy. Thus implementation is partially dependent upon revenue and capital budgets for grounds maintenance and for parks management. The Parks Service pursues other sources of finance and opportunities for partnership working that may become available. The Welsh Harp Project Group will discuss the financial implications of projects within the remit of that group.

#### **5.0 Legal Implications**

- 5.1 Under the Countryside and Rights of Way Act 2000 (CROW) and the Wildlife and Countryside Act 1981 (as amended), land owners / managers are required to consult with English Nature for any operation in the list of 'Potentially damaging operations'; and English Nature will issue a consent for the works unless the operation is likely to have a significant impact on any of the notified features of interest on the site. CROW (and section 28G of the Wildlife and Countryside Act 1981) places a duty on all public bodies to take reasonable steps, consistent with the proper exercise of the authority's functions, to further the conservation of the site. CROW also encourages land owners to produce Management Plans for the SSSI, which when approved by English Nature, enable the carrying out of the works specified in the Management Plan. This can reduce the administrative work inherent in obtaining consent for individual items of management work.

#### **6.0 Diversity Implications**

- 6.1 The proposals in this report have been subject to screening and officers believe that there are no diversity implications.

#### **7.0 Staffing/Accommodation Implications**

- 7.1 None specific.

#### **8.0 Environmental Implications**

- 8.1 The Welsh Harp Management Plan co-ordinates current environmental works in the Reservoir area, and highlights works that are a future priority.
