MINUTES OF THE WELSH HARP JOINT CONSULTATIVE COMMITTEE Tuesday, 7th March 2006 at 7.30 pm

PRESENT: Councillor Farrell (Chair, London Borough of Brent), Councillors Motley and O'Sullivan (London Borough of Brent), Councillor Johnson (London Borough of Barnet) and Roy Beddard (Welsh Harp Conservation Group), John Colmans (London Wildlife Trust), Frank Hewlett (Barnet Council for Sport and Recreation), Dorothy Jakes (Birchen Grove Residents' Association), Molly Savage (Local Agenda 21), Judy Shepherd (West Hendon Community Forum) and Brian Turgoose (Welsh Harp Sailing Association).

Apologies for absence were received from Councillor Cummins and Harry Mackie (Welsh Harp Environmental Education Centre).

Also in attendance were Leslie Williams (Brent Parks Service), Roger Jones (Barnet Parks Service), Clive Cohen (London Wildlife Trust) and representatives of Trainingship Broadsword.

1. Election of Chair and Vice-Chair

Nominations were invited for the positions of Chair and Vice-Chair for the municipal year. Following votes, Councillor Farrell was elected Chair and Councillor Johnson was elected Vice-Chair of the Joint Consultative Committee for the municipal year 2007/8.

2. Declarations of Interest

There were none declared.

3. Minutes of Previous Meeting – 3rd May 2007

RESOLVED:-

that the minutes of the previous meeting held on 3rd May 2007 be received and approved as an accurate record subject to the following alterations:

- that the reference on page 3, item 6(c) be changed from British Waterways to The Environment Agency
- that the reference on page 6, paragraph 1 be changed from the Sea cadets to Trainingship Broadsword.

4. Matters Arising

Proposed reuse of the northern arm of the Welsh Harp as a sailing base

Copies of a letter sent to, and reply received from Cllr Offord the Lead Member for the Environment at the London Borough of Barnet were circulated. These reported that Cllr Offord was of the view that the northern arm of the reservoir should not be used for sailing or similar activities. Officers from Barnet explained that further discussions were due with Cllr Offord and with Trainingship Broadsword, who had requested access, and that these would be reported back to the committee.

Enforcing by-laws

A number of members expressed concerns that the by-laws covering the welsh harp open space were consistently being broken with problems such as

BBQs, swimming and littering and that wardens were not present on the site often enough particularly at weekends. It was reported that this was a more significant problem in the areas operated by Barnet Council. Officers responded that wardens patrolled in a limited fashion related to the funding available and also because they hadn't witnessed many problems. Officers explained that there was a phone number publicised at Welsh Harp for problems to be reported but that it wasn't regularly used. The Chair suggested that members ensure that all incidents they witness get reported to ensure that both councils knew the full extent of any problems.

5. **Public Speaking Arrangements**

Two local residents spoke and both expressed concerns about the litter with the area near the north circular road and the river Brent both up and down stream of the reservoir particularly mentioned. One resident also requested that more efforts be made to provide leisure opportunities for young people as she felt the site was underused in this way.

In response to these speakers, officers agreed that there were litter problems and that they were doing there best to tackle them, in conjunction with British Waterways and the Environment Agency but that they are always looking for volunteers to help on major clean-up operations. Officers promised to examine the need for additional litter bins and dog waste bins near the North Circular road.

6. Welsh Harp Management Plan (Brent) - update

Leslie Williams introduced an item regarding the Welsh Harp management plan. He reported that, as was required, the Welsh Harp Management Plan was currently undergoing its regular review, the last having been in February 2006, and that draft copies of the new version were available on the council website. Issues that had been raised for possible inclusion were the possibility of creating more scrapes (ponds) and the requirement to control Japanese knotweed.

It was reported that British Waterways were conducting a survey into the condition of the trees on their land, including their impact on bats and other wildlife and the danger to the public from any diseased trees found. Officers reported that they would be consulted before any actions were undertaken.

Turning to general management issues, Leslie Williams reported that further attempts to clean up problem areas had been undertaken, that since the last meeting contractors had been at work on the amenity grassland in Neasden Recreation Ground area at the foot of the dam wall and that officers had been in touch with the Environment Agency and British Waterways to encourage them to attend WHJCC meetings and the agencies had responded that they would attend or submit reports as often as possible and if any significant issues arose.

It was reported that the Welsh Harp open space had failed to collect a 'Green Flag' award. It was explained that these were new awards presented to the best open spaces in the country. Officers explained that they would be

examining the report to see what would need to be achieved to enable the Welsh Harp to gain an award in future years and would report back to the next meeting.

Finally, it was reported that Brent Council was continuing to review its Biodiversity Action Plan, that the maintenance of the heritage lottery projects was continuing and that the Kingsbury and Welsh Harp Open Day was successfully held on 28th May 2007.

A discussion followed during which members expressed concerns about how the tree works were to be undertaken and asked officers to ensure that trees were only removed if absolutely necessary and, if possible, replaced with the same species. In regards to the issue of fly tipping, it was reported that British Waterways had a three year project to clean up the problem areas. Members expressed concerns about the length of the project and it was discussed whether there was anything the councils or voluntary groups could do to help speed this up.

Other issues discussed included the misconnection of waste pipes from housing and the quality of the water entering the reservoir.

RESOLVED:-

that the report be noted.

7. Welsh Harp Management Plan (Barnet) – update

Roger Jones introduced a verbal update on the Barnet side of the Welsh Harp Management Plan. He reported that they were also reviewing the plan and would be meeting with officers from Brent shortly to discuss joint issues, including tree management, litter and pollution issues.

During discussion questions were asked regarding the area of the reservoir north of Cool Oak Lane bridge in relation to requests to use that area for boating activities for young people by Trainingship Broadsword.

Several members, including those from Trainingship Broadsword, expressed concern that officers were looking to remove part of the site from leisure use. They pointed out that this area had previously been used for sailing and that they had been given assurances before the areas recent temporary closure that they would be allowed to come back but that it now appeared that this promise had been broken. Other members expressed support for the decision highlighting how the areas ecology over recent years had changed.

Officers responded that they would discuss the issue with the relevant London Borough of Barnet officers and report back to the committee at the next meeting.

It was also noted that there was a new youth sailing base due to be completed at the reservoir and that local youth groups would be welcome to make use of it when it was finished in a few years time. During further discussion it was noted that the Metropolitan Housing Corporation, who were working to regenerate an area adjacent to the reservoir, had not been to the committee for a long time to update on their progress. Members requested that an attempt be made to invite them to the next meeting.

Officers further reported on the issue of fly-tipping and agreed to present more information at the next meeting relating to the costs and progress of removing tips. It was finally reported that tests had been run on the water quality on streams entering the reservoir and had encountered no issues.

RESOLVED:-

that the report be noted.

8. Planning Issues

Members of the committee reported that they had been consulted again on the plans for the Brent Cross and Cricklewood redevelopment and that part of the plans were to re-route the River Brent upstream of the Welsh Harp reservoir. Members expressed concerns about silt entering the reservoir during construction. It was reported that the developers had stated that they were aware of the issue and intended to prevent and problems.

Members asked if the detailed proposals from the developers to prevent problems could be presented to the committee at the appropriate time.

9. **Date of Next Meeting**

The next meeting of the Consultative Committee would take place on Tuesday 13th November 2007.

10. Any Other Urgent Business

It was noted that the plaque for Mike Manual had been removed, officers promised to investigate.

Members from Trainingship Broadsword expressed additional concerns regarding their ability to retain members if they weren't able to offer waterbased activities.

1.0 Summary

1.1 This report presents progress on the Brent Reservoir / Welsh Harp Management Plan and related issues. The Management Plan is jointly managed by the three main local land-holding organisations: Brent Council, British Waterways, and the London Borough of Barnet.

2.0 Recommendations

- 2.1 Members are asked to note the Report.
- 2.2 Members are asked to agree the reviewed Management Plan.

3.0 Detail

Welsh Harp Management Plan

- 3.1 The Welsh Harp / Brent Reservoir Management Plan is administered by officers of the land owning and land managing organisations. Annual reviews, undertaken near to July each year, are reported to Committee for their recommendations. Since 2001 this has included the additional responsibilities of the Countryside and Rights of Way Act 2000 in relation to Sites of Special Scientific Interest (SSSI).
- 3.2 The Management Plan was signed by English Nature (now Natural England) on 15 May 2003. Subsequent amendments have been reported to this Committee. Natural England have indicated that there is no need to seek their consent for minor changes to the Management

Plan. The current version of the Management Plan is available on the internet at www.Brent.gov.uk/parks. A map of the zones is also provided on the internet; and is attached to this report.

- 3.3 At the previous meeting of the Welsh Harp Joint Consultative Committee (17 July 2007) a version of the Management Plan was present that updated that agreed by the Committee in early 2006. A copy of the revised version is available on the Brent Council website. Subject to any amendments required since July 2007, the Committee's approval of the revised Management Plan is sought.
- 3.3.1 It should be noted that the Management Plan does not include or propose changes to zone 2 north of Cool Oak Lane concerning the balance between recreation and nature conservation.

Management works

3.4.1 At the previous meeting of the Welsh Harp Joint Consultative Committee (WHJCC) information was requested on the number of litter and dog waste bins, collection frequencies, and the condition of information boards at Neasden Recreation Ground. The following information is provided:

Litter bins: There are 20 litter bins at Neasden Recreation Ground and these bins are emptied on Mondays, Fridays and at the weekends, and more frequently if required.

Dog waste bins: Currently there is one dog waste bin near to the Neasden Recreation Ground car park; two further bins have been lost to theft and/or vandalism. The dog waste bins are emptied twice a week by contractors to Brent Council Parks Service. The missing dog waste bins will be replaced when funding becomes available.

Notice boards: There are three notice boards at Neasden Recreation Ground, all of which are repeatedly covered in graffiti. The graffiti is removed as soon as possible by staff of Brent Council Parks Service. Following vandalism to the front panel of the notice board adjacent to the car park, the front panel was replaced with a new panel in about June 2007, but the new panel had been vandalised by 24 July 2007. The panel of the notice board will be replaced when funding becomes available.

3.4.2 A number of unauthorised raves were held or potentially would have been held at the Welsh Harp since the last meeting of the Welsh Harp Joint Consultative Committee. These were on the weekends of:

6 August 2007: 0130 hours to late afternoon. Wardens from Brent Council Parks Service were called to this incident and in turn contacted the Police.

11-12 August 2007: Brent Council Parks Service had staff on duty and turned away ravers as they arrived. Consequently the rave did not proceed.

25-26 August 2007: This was thwarted by combined pre-planning and actions between Barnet Council, Brent Council and the Police.

Dam wall works

3.5 The reinstatement of the grassland area in Neasden Recreation Ground to the south of the dam wall was completed. Full grass establishment has been achieved by the contractors to British Waterways and the land has been handed back to Brent Council Parks Service.

British Waterways

3.6 British Waterways are working with Brent Council and local residents to carry out some clearance works on the Brent Canal Feeder immediately south of the outfall from the Reservoir. (Brent Environmental Health are also involved with this project and report that the Community Clean-Up Day will be held on Saturday 10 November from 0930 to 1400 hours. The event is taking place at Braemar Avenue near to the access to the Canal Feeder. For more details please contact Donna Austin-Walker tel: 020 8937 5252, e-mail: env.health@brent.gov.uk). This is part of a larger project to achieve a proper maintenance agreement for the whole of the Canal Feeder.

The initial clearance of fly-tipping in the Site of Special Scientific Interest on the southern side of the Reservoir bordering the North Circular Road was carried out last year and the second phase will occur in conjunction with the Canal Feeder works identified above.

British Waterways also report that community groups may be able to obtain grant funding for the creation and management of ponds from The Waterways Trust with grants of £1,000 (to £2,000). Grants for larger biodiversity projects may also be available from a scheme recently announced by the SITA Trust.

Environment Agency

3.7 For the Environment Agency, Welsh Harp issues are led by the Brent and Crane Environment Management Team. They have been invited to provide an update to the Committee.

Green Flag Award application

3.8 Following the unsuccessful application for an award, feedback comments from the Green Flag Award judges were provided (see the Appendix to this report); some of which could be equally applicable to the Welsh Harp area as a whole. The Parks Service will consider the judges recommendations for a possible future Green Flag application for the Welsh Harp Open Space.

Biodiversity Action Plan

3.9 The Executive of Brent Council approved an updated Brent Biodiversity Action Plan in August 2007. The Biodiversity Action Plan serves as the geographic area of the local authority; and as the Corporate Biodiversity Action Plan for the Council. The Corporate BAP also includes the responsibilities of the Council in respect of the Biodiversity Duty. The BAP is available on the Brent Council website.

Heritage Lottery Award

3.10 Maintenance of the Heritage Lottery Fund award project continues.

Events

3.11 Brent Council Sports Service have initiated a Healthy Walks Programme. At the Welsh Harp these meet at the Welsh Harp Environmental Education Centre, Birchen Grove, every Thursday (except on Bank / Public Holidays) from 10am-11am. The walks are 'low to moderate' in pace. The nearest bus routes are numbers 182, 245, 297 and 302. For further details contact Brent Council Sports Service, tel: 020 8937 3707, www. Brent.gov.uk/sports. The current programme runs until March 2008.

4.0 **Financial Implications**

4.1 None specific, but some of the priorities identified in the Management Plan will require additional resources and decisions by, as appropriate. Brent Council, Barnet Council or British Waterways, if they are to be implemented in the future. For Brent Council Parks Service, the Management Plan is implemented and improvements programmed via the Brent Parks Service Parks Strategy, and Service Plan; both of which derive from the Council's Corporate Strategy. Thus implementation is partially dependent upon revenue and capital budgets for grounds maintenance and for parks management. The Parks Service pursues other sources of finance and opportunities for partnership working that may become available.

5.0 **Legal Implications**

Under the Countryside and Rights of Way Act 2000 (CROW) and the 5.1 Wildlife and Countryside Act 1981 (as amended), land owners or occupiers are required to give notice to and consult with Natural England for any operation in an area of land that is of special interest by reason of any of its flora, fauna, or geological or physiographical features; and Natural England will issue a consent for the works unless the operation is likely to have a significant impact on any of the notified features of interest on the site. CROW (and section 28G of the Wildlife and Countryside Act 1981) places a duty on all public bodies to take

reasonable steps, consistent with the proper exercise of the authority's functions, to further the conservation and enhancement of the site.

- It is good practice for land owners or occupiers to produce Management Plans for the SSSI, which when approved by Natural England, enable the carrying out of the works specified in the Management Plan. This can reduce the administrative work inherent in obtaining consent for individual items of management work.
- 5.3 The Natural Environment and Rural Communities Act 2006 requires that from 1 October 2006 all public authorities in England and Wales have a general duty to have regard to the conservation of biodiversity so far as is consistent with the proper exercise of their functions.

6.0 Diversity Implications

6.1 The proposals in this report have been subject to screening and officers believe that there are no diversity implications.

8.1 The Welsh Harp Management Plan co-ordinates environmental works in the Reservoir area.

Summary To report the position on the Local Nature Reserve (LNR)

2. RELEVANT PREVIOUS DECISIONS

- 2.1 Welsh Harp Joint Consultative Committee on 9 December 2003 approved the proposed boundary of the LNR.
- 2.2 Barnet's Hendon Area Environment Sub-Committee on 15 March 2005 agreed the designation of a Local Nature Reserve on the Welsh Harp.
- 2.3 Welsh Harp Joint Consultative Committee of 15 June 2005 agreed draft byelaws.
- 2.4 Barnet's Hendon Area Environment Sub-Committee on 5 September 2006 and Cabinet on 16 October 2006 endorsed the draft byelaws for formal approval by full Council on 7 November 2006.

7. LEGAL ISSUES

7.1 The Local Authority has a statutory duty under the Countryside and Rights of Way Act 2000 to safeguard, protect and enhance sites of special scientific interest. The Local Authority has the power under Section 21 of the National Parks and Access to the Countryside Act 1949 to acquire, declare and manage nature reserves. However, English Nature must be consulted by the Authority in the use of the powers given by section 21. The 1949 Act states that a Local Nature Reserve (LNR) must be managed in such a way to ensure that use of the site does not result in any damage to its natural features.

8. CONSTITUTIONAL POWERS

8.1 The Terms of Reference of the Joint Committee, as set out in its Constitution, include:

"to consider and co-ordinate all the interests of recreation / leisure / maintenance / nature conservation and statutory requirements of the British Waterways Board and the Environment Agency at the Welsh Harp; with the object of protecting the Welsh Harp and surrounding open land as a unique environment for both recreation and wildlife conservation."
