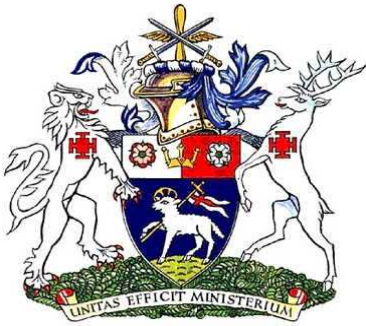

Summary

The report informs the Environment Committee of a Motion which was reported to Full Council on 28 July 2015. In accordance with Council Procedure Rule 23.5, if a Member's Motion is not dealt with by the end of a Full Council meeting, it will be referred to the appropriate committee for consideration and any necessary action.

Recommendation

That the Environment Committee instructions are required in relation to this item.

1. WHY THIS REPORT IS NEEDED

1.1 On Tuesday 28 July Councillor Kath McGuirk submitted an Opposition Motion to Full Council as follows:

1.2 *“Council notes the plans to cut the No 13 bus route in Finchley were scrapped by the Mayor but the decision has been brought into question as it fell in the purdah period during the general election. Council also notes there were around 3,000 responses to the consultation from concerned residents, and TfL cites the 'strength of feeling' as the reason the plan to cut the route was ditched.*

Council further notes however that while the cuts to this bus service appear to have been scrapped the axe still hangs over other bus services in Finchley as the Mayor of London and TfL still say there is excess capacity in local Finchley bus services.

Council believes bus services should not be cut in Finchley and calls on the administration to lobby the Mayor and TfL opposing any further bus cuts.”
