Summary The report informs the Environment Committee of a Motion which was reported to Full Council on 20 October 2015. In accordance with Council Procedure Rule 23.5, if a Member's Motion is not deal with by the end of a Full Council meeting, it will be referred to the appropriate committee for consideration and any necessary action.

1. WHY THIS REPORT IS NEEDED

1.1 On Tuesday 20 October 2015 Councillor Alan Schneiderman submitted an Opposition Motion to Full Council as follows:

1.2 Roads and Pavements

Council notes the rising complaints over the state of the boroughs roads and pavements, and that roads and pavements are the number one issue of concern for residents according to the council's own Residents Perception Survey.

Council also notes the recent practice of 'road surface dressing' in Barnet which leaves tarmac road chippings loose on the road surface resulting in damage to vehicles from flying chippings and damage to homes from tar.

Council further notes that many residents have complained about this new approach to road repairs, and asks the Environment Committee to review the procedure, including any contingency for dealing with a deterioration in roads due to the approaching cold winter weather.

- 1.3 Under Full Council Procedure Rule 23.5 I ask that if my motion is not dealt with by the end of the meeting it is referred directly to the Environment Committee.
- 1.4 Council's Constitution, Full Council Procedure Rule 23.5 states that:

If the Member's Motion is not dealt with by the end of the meeting, it will be referred to the appropriate Council Committee or sub-Committee for consideration and any necessary action. (However, if the proposer has specifically asked in his or her notice for the Motion to be voted on at that Council meeting it will be voted on without discussion).

1.5 The motion was not discussed or voted on at the Full Council meeting. Therefore the Environment Committee are requested to consider the contents of the motion as set out in section 1.2 of this report and give instruction.
