Qn.	Councillor	Question	Answer by	Answer
1	Cllr Brian Gordon	Would the Leader agree that Residents' Forums are principally for ordinary local residents to table issues, express their views and ask questions and not a soapbox for elected politicians?	Cllr Richard Cornelius (Leader of the Council)	Yes.
2	Cllr Barry Rawlings	What justification does the Leader have for not asking officers to consider the risks and opportunities of both Brexit and Remain for the Council and our partners before June 23rd?	Cllr Richard Cornelius (Leader of the Council)	All this work would have been highly hypothetical, as even now it is not clear what our relationship with Europe will look like. There was widespread discussion of the perceived advantages and disadvantages of each option, but it would have been wrong to drag officers into this argument. With the new government in place, now is the time to begin working with our colleagues to advance Barnet's interests.
3	Cllr Brian Gordon	There are a number of procedural issues relating to planning committee meetings that I, several colleagues and officers consider need reviewing. How and when will there be an opportunity to do this in the not-too-distant future?	Cllr Richard Cornelius (Leader of the Council)	In response to feedback from Members on the recent changes to the rules relating to planning committees, the Constitution, Ethics and Probity Committee at the meeting held on 30 June 2016 has already made some amendments to the Planning Committee Procedure Rules. Details of the changes agreed by the Committee are included on the agenda for the Council meeting this evening for consideration and agreement. If Councillor Gordon would like to make suggestions regarding any additional changes, officers can add these to the list of issues to be considered at the next Constitution, Ethics and Probity Committee which is scheduled to take place on 16 November.

4	Cllr Reema Patel	Why did the Barnet Council fail to notify disabled recipients of freedom passes that their passes had been cancelled? Does the leader accept that failure to do so could have put residents at unnecessary risk of apprehension by transport police?	Cllr Richard Cornelius (Leader of the Council)	<p>Officers accept that when some residents received their new Freedom Passes they were not advised that the passes could be deactivated if they did not meet the current eligibility criteria. As such a small minority of residents had their passes deactivated without being provided with appropriate advice.</p> <p>Officers recognise that the process may have caused the residents involved inconvenience and distress. Everyone concerned apologises unreservedly for this. In the interests of fairness, Freedom Passes have temporarily been reissued to the 207 residents affected whilst the council carries out a review of the Freedom Pass process. On conclusion of this process review, residents will be reassessed based on the revised eligibility criteria. All 207 residents that have had their passes temporarily reissued have also been offered the facility to submit a claim for expenses incurred for the period of time when their passes were deactivated.</p>
5	Cllr Brian Gordon	Is the Leader satisfied that the enquiry into the cause of the voting problems that occurred at the London election, particularly in Wards such as mine, was fully and sufficiently investigated with a view to such a problem not being allowed to reoccur in the future? Mr Heath produced a very clear report that set out what went wrong and made a series of recommendations – all of which were accepted by the new Returning Officer. There is now a wider review being conducted into the elections service.

Reducing litter, fly tipping and similar will reduce pressure on services. The Council has recently started a campaign "Keep Barnet Clean" which highlights the problem anti-social enviro crime. The Environmental Enforcement Officers will be able to issue Fixed penalty notices for littering (including cigarette butt), dog fouling etc.

This is because they do not procure their payroll service from CSG. This includes all of the community secondary schools. Therefore the impact by sector is only shown below for Early years and Primary.</p> <p>Negative impact in early years: 4 staff (0.24%) Negative impact in primary: 67 staff (4.07%)</p>
9	Cllr Brian Gordon	The Government's Chief Inspector of Schools has recently issued a directive that many Councils are not acting sufficiently to curb extremism within schools. Would you consider this to be a problem within the Borough of Barnet?	Cllr Reuben Thompstone (Chairman of Children, Education, Libraries and Safeguarding Committee)	<p>No, but we have prioritised schools for end user WRAP3 Prevent Training and delivered training to high priority schools already.</p> <p>We have publicised the online WRAP Training to schools. Schools are able to use BPSI hours on any trained BPSI advisers to deliver WRAP3 Training to their staff. We are putting in place steps to try and train up more BPSI advisers (over the coming 2-3 months) so that we can offer real capacity in the system to provide whole-school face-to-face training for those that want to take up that option in addition to engagement with the e-training.</p> <p>'Zak' – Prevent/E-Safety Training for years 2 to 13 has been publicised to schools after being trialled by two headteachers. 10	Cllr Dr Devra Kay	<p>It appears that at least some postal vote ballot papers for the Referendum were not received from Barnet by voters living abroad. An example I have is of a couple living in Israel, at the same address, making a request for a postal vote at the same time. The husband is registered in Ealing, the wife in Barnet. The husband received his form, the wife did not. Will the Leader admit that Barnet voters have been disenfranchised yet again due to the Council's inability to organise an election and that he should take responsibility for the failures under his leadership of the Council?</p>	Cllr Richard Cornelius (Leader of the Council)	<p>No.</p> <p>If Cllr Kay provides the name of the voter concerned to me or the Assurance Director, the elections team will look into what may have happened. There are a variety of possibilities including those which may not be the fault of the council, such as postal delays. The voting and count process for the EU Referendum in Barnet went very well. The turnout for the Referendum was 72.1% with a postal vote turnout of 85%. 161,208 residents cast their vote from an electorate of 223,467. We sent out 48,148 postal votes and received back 41,229. This equates to a 85.63% turnout which is a record quantity and percentage for Barnet. We also had a record number of overseas electors, 2,500, on the register for the referendum.</p>

Our long-standing zero tolerance approach to any form of hate crime is something we are totally committed to as individuals, as an organisation and as a borough.</p>

Barnet has also seen an increase in reporting. In the 16 days following the referendum there rate of Race and Faith Hate crime reporting rose by approximately an average of 1 additional offence per day compared to the levels over the previous 3 months. 				<p>reported offences between 23rd June to 8th July – an average of 2.75 per day compared to an average of 1.7 per day in the 3 month period prior to the referendum).</p> <p>The police have not identified any specific trends, patterns or community tension issues however this situation is being monitored by the councils Community Safety Team and Equalities Team who are in close liaison with the police.</p> <p>Barnet Police confirm (at time of writing) that there are no specific trends or patterns behind the figures that indicate one particular groups is specifically being additionally targeted or that one group of offenders have come to the fore, however, the police are monitoring the situation closely and continue to deal with all forms of hate crime as a serious matter.</p> <p>Should any community tension issues arise or be identified, the police and council are ready to take any action necessary to address the issues in coordination with the Communities Together Network and Barnet Multi Faith Forum.</p> <p>Community Cohesion Remains High •The Spring 2016 Resident Perception Survey shows that community and cohesion perception measures continue to remain high in Barnet and have remained constant for the last four years.</p>
