1	11	Hendon School	As the students of the Mental Health team at Hendon School, we thank the council for the response to Sehar's motion – to be discussed later this evening. However, we do not feel that it goes far enough. We want to ask the Council if they would write to the CCG by the 24 th May 2017, the day before the next CCG meeting which Hendon School will be attending, to support the idea to commission Mental Health First Aid Training for all Secondary schools in Barnet. The cost for the training of 4 staff in each school, each year on a rolling programme would be the equivalent of £100 per year (costed) and we are able to provide this information. In fact we are also able to provide a proposal, where this could be cost free to the CCG to commission from Year 2, after the relatively small initial payment in Year 1.	The CCG agree to fund this project and will be meeting Hendon school on 6 th June to discuss how Mental Health Training will link in with the Resilient Schools programme (Thrive) and to develop an implementation plan.
2	11	Hendon School	The students have already met with BEH-MHT, who are supportive and written to the CCG, who have yet to respond. Will Barnet Council take the initiative to ask the CCG to commission this and become National leaders in supporting MHFA for all schools in the borough?	See above
