Cllr Richard Cornelius (Leader of the Council)	No. The issue is that the Mayor provides us with fewer police officers per capita than any other borough, despite Barnet making the single largest contribution to the MOPAC budget.
4	Cllr Jack Cohen	In the current calendar year to date how many PCNs have been issued in the section of Granville Road from the junction of The Vale to Nant Road?	Cllr Dean Cohen (Chairman of the Environment Committee)	83 PCNs issued in Granville Road NW2 this calendar year. A review by location description or reference to photos, when not clear, suggests 71 of those were issued in the section described. This included one warning notice.
5	Cllr Peter Zinkin	What is happening at the Golders Green Hippodrome, and who are the new owners?	Cllr Richard Cornelius (Leader of the Council)	The Hippodrome in Golders Green was purchased by a Shia Islamic organisation in July 2017. The council registered a planning application on 15 September requesting that the wording of the current planning permission controlling the use of the building be varied from a use restricted to a "church" to use as a "place of worship". The applicant has also asked to increase opening hours by one hour from 8:00am - 11.30pm to 8:00am - 12.30am on any day of the week. The application is currently being considered by planning officers and no date has been set for when it will be considered by a planning committee. The council has also received a petition in relation to the centre and this petition will be considered by the Environment Committee, as it relates to traffic management.

Delivery of these measures has already started, with work underway to blocks at Grahame Park and on the Whitefield estate.</p> <p>Detail of how to implement the commitment to further best practice measures such as the installation of sprinkler systems and upgrades to alarm systems will be presented to Housing Committee in Spring 2018 after the outcome of the independent review of building regulations and fire safety is known. However London Buses latest published performance report for the route indicates that Excess Waiting Time and Mileage Operated both deteriorated initially in the first one or two 4-week monitoring periods after the change followed by a slight improvement by the third period, although performance still remained worse than the expected level for the route. The latest published report available at the time of writing runs to 23 June 2017 (12 weeks after the introduction of the changes).</p> <p>No customer requests in relation to this matter have been received by the Highways Service, although such enquiries are likely to be made direct to TfL.</p>

That equates to about 1,370 per day, every day, for four years. Mill Hill residents appear to be paying the price for the sheer impossibility of Mayor Khan's broken promises.
38	Cllr Phil Cohen	A restaurant called Ninova at 1 Church Hill Road, East Barnet EN4 have been illegally displaying a large electronic sign which overlooks the War Memorial in East Barnet village. Council enforcement officers have instructed the owners to remove it but they have refused to do so. The remaining 72 claims are currently open pending further consideration/investigation.</p>

Cllr Richard Cornelius (Leader of the Council)	<p>Barnet received a letter from GLA planners in the middle of September objecting to plans for the Stage B, Phase 1 of the scheme. The letter, I am told, was riddled with errors and misunderstandings — even appearing to be ignorant of the GLA's own involvement in the scheme — and no prior notice was given of the GLA's grievances, as is established practice. A great deal of effort was undertaken in politely pointing out these errors to the GLA behind the scenes. By September 26, Barnet was on the cusp of securing a retraction or modification of the letter in light of said errors, at which point Mayor Khan released the letter to the press and issued a press release condemning the plans, thus ensuring this would not happen.</p>

Every month, over 1,000 residents sign up for their own personal online account to access council services such as council tax, parking, housing benefits and libraries. By the end of August, the total number of 'My Account' holders stood at 45,821.

This trend to go online is fantastic news, because an online transaction costs a fraction of those that happen via telephone, email or face to face, and means that staff time is freed up to focus their efforts on the customers that may be unable to use digital services or need specialist help. It's also great for customers who want to access our services quickly and at a time that suits them, using any device.

However the journey is far from over – the council continues to invest in upgrading its online services, with the first improvements having gone live in early October. The upgrade to the online account offers a raft of new features alongside the existing ones, and we will continue to introduce improvements throughout 2018.

remains principally at Hendon Library. The refurbishment of this library has only lead to parts of the collection being moved downstairs in Hendon Library rather than into another library altogether. The service will re-open to enquiries from the 6th November.

The local studies collection will now be in an area separate from other readers, with its own entrance, and with the material closer to hand being on two instead of four floors, and the movement of material between floors will be solely by lift.

The collection is in two sections: the historical collection (old maps, plans, documents, and photographs), and council documents: an extensive but incomplete second collection of the minutes and reports 1964 – 2004 used by the public, an incomplete collection of minutes and reports 1870s – 1964, and a partial collection of electoral registers- the only collection in the borough of this material.

A portion of the collection is in commercial storage from the move from Daws Lane in 2011, but it is hoped that with the recent reorganisation and new racking of the collection and new quarters within Hendon this material (the historical rate books and many miscellaneous plans and maps) will be return to Hendon in the next 18 months.

There are current projects to create electronic finding aids, enabling the searching of the historical collection by postcode, street, as well as subject and object, through indexing the old index cards (places and subject indexes are complete only the people index remains) and the accession registers (nearly complete). This will enable local history groups and individuals to find what material in the collection will be interesting not only in their or their ancestors districts, but also on their street. We are working on a similar type of list of our collection of Barnet
