1	7	Jon Dix	<p>At 1.4 in the report it identifies the problem with the transfer station floor and attributes the blame to Wilmott Dixon. At some point during the construction process a surveyor must have signed off this element of construction in order for Wilmott Dixon to be paid. If the floor was not laid to the correct specification why wasn't this picked up at that stage and does this call into question the quality of project management?</p>	<p>The technical specifications employed by Wilmott Dixon were fully reviewed in advance the works being undertaken. The floor was laid to the correct levels/falls and visually there was no evidence upon inspection of a potential defect.</p> <p>It appears that upon pouring the screed the rebar had moved meaning the steelwork was close to the surface and reducing the integrity of the concrete surface cover. This was exacerbated by some localised deterioration of the screed. As soon as the issue was identified, it was reported and rectified under the contractual 'Defects Liability Period'</p>
2	7	Roger Tichborne	<p>With regards to removal of recycling drop off points. One of the justifications for the removal of this service is that the sites are used for flytipping, which is adding costs to the budget. It seems unlikely that flytippers will desist in their activities, just because the recycling points are removed. The most likely result is an increase in flytipping at secluded spots and areas of natural beauty. This will have a greater impact on residents and will most likely increase costs, as the chaotic nature of the distribution will make it more costly to remove and more impacting on residents. Has any risk assessment or study been conducted to assess the relative costs of clearing up such randomly distributed waste vs the cost of regular planned cleaning of the drop off points? What are the comparative figures.</p>	<p>As kerbside recycling and communal recycling services have improved over the last decade the reliance on bring recycling sites has dramatically reduced with collected tonnages now less than 5.5 tonnes a week. As such, local authorities across London have in recent years rationalised or removed their recycling bring site. Barnet has already reduced from a peak of 80 sites to 17 sites.</p> <p>Communal public waste/recycling bins do attract dumping. The experience of Barnet previously and other authorities was that no increase in recorded large-scale fly tips was experienced as a result of the reduction/removal of this service.</p> <p>The intention in Barnet is to address the level of fly tipping over time across all locations, through communication and enforcement.</p>

Table 1 contains the Street Scene MTFP commitments. Street Scene Service has no MTFP commitments regarding Fixed Penalty Notice income.  There is a £50K commitment within community safety relating to income from environment enforcement.
6	7	Mr Levy	Re 1.27. "Officers will be identifying areas of the borough where there is scope to improve material quality and address low recycling levels". Considering that LBB is still achieving around 37% versus the 2020 target of 50%, is it expected there will be anywhere in the borough where household recycling rates and accuracy are good enough?	Recycling rates from houses (as opposed to flats) are estimated to be between 43% and 45%. The main emphasis for future work will be around dry recycling from flats.

How long was this area out of action and why were councillors given inaccurate information?</p>	<p>The transfer station was available to Wilmot Dixon Friday 6th April and reopened for Monday April 23rd. As far as we are aware no advanced information was sent to all councillors that detailed the estimated time for the works to be completed.</p>

The best way for a business, to avoid paying any level of FPN is to ensure that they have a licenced waste company remove their waste. If at any time a business had mislaid these documents any licenced waste company would re-provide these to a customer swiftly. If a company wishes to take the matter to court they could be subject to an unlimited fine and criminal record.

The aim of issuing FPNs is to secure compliance and hold offenders to account for fly tipping without incurring unnecessary costs to the public purse, the aim of this approach is maximum reduction on littering and fly tipping. At present there are 24 open Cases being prepared for court following non-payment of Fly tipping or Duty of Care. Unpaid FPNs for littering and fly tipping are referred to HB law for court on a monthly basis where the decision to prosecute, or not, is determined.</p> <p>Currently a new contract is being procured in partnership with other London boroughs which will see a percentage of any income retained by the council. Any surplus from this contract would be used to support community safety and street cleansing</p> <p>At present all FPN income goes to NSL to cover the cost of enforcement. Any court based costs come to the council.</p>

Officers are in discussions NLWA to investigate in any additional information is available.</p>

Avoided service delivery costs will enable street cleansing resource reallocation to cleansing other areas</p> <p>There is potential revenue that could be captured from redirecting the illegally deposited commercial recycling into the new council commercial waste collection service, although this has not been taken into account in any costings. Due to the communal nature of these facilities and the limited current usage by residents is envisaged publicity costs will be minimal.</p>

The operation from a hypothetical single depot could only be calculated, knowing where the single depot is.

Why were the rounds not reorganized at that time?	In May 2017 the Environment Committees decide to keep Street Scene as an In House service. Following on from this decision and the move from Mill Hill depot in July 2017 restructuring of street scene services has been ongoing. Change have been made to street cleansing, ground maintenance, commercial service, as well as support service. Services have now bedded down in their new locations and we have a clear forward plan of new households development over the next five year. This is now the right time for the council to maximise the efficiencies across the recycling and waste operation.

Working patterns may need to be adjusted however this has not been fully established.</p> <p>When designing the new recycling and waste service there are numerous opportunities and delivery variations that will be assessed. What modelling has been done of the fall in tonnage likely to result from a three month winter suspension versus six weeks or none, and of the corresponding effect on air pollution from the likely rise in bonfires?	<p>Between December and February (inclusive) of 2016/17 1,857 tonnes of garden waste was collected. Approximately 12% of the annual green waste tonnages. The total collected in 2016/17 was 14,910 tonnes. It is reasonable to assume that similar levels could be witnessed without a 3 month service suspension</p> <p>No assessment of the impact on air quality has been undertaken however Barnet have an in borough refuse and recycling centre located at Summers Lane operated by the North London Waste Authority (NLWA). Residents with transport can take garden waste to this facility throughout the duration of the suspension period as opposed to the uncontrolled burning of this.</p>

The number of bikes will be dependent on usage and demand. Decisions will be made by Highways officers in conjunction with the Cycling Team, who will also evaluate the pilot scheme. The Courtauld Commitment 2025 is a voluntary agreement to make food and drink production and consumption more sustainable. It is predominantly aimed at improving upstream efficiency and practices to reduce the amount of food that needs to be recovered either through recycling or as a fuel. Currently Barnet is not a signatory to this commitment. There are few authority who are a signatory, as it is mainly aimed a business.
